Notes to Financial Statements

Note 1: Description of Plan

The following description of the Fiduciary Real Estate Development, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

General

The Plan is a defined-contribution plan sponsored by Fiduciary Real Estate Development, Inc. (the "Company"). John Hancock Trust Company LLC ("John Hancock") is the custodian and record keeper. The custodian holds the Plan's investment assets and executes investment transactions.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA, and therefore, provides that participants direct their contributions and/or their account balances among the Plan's investment alternatives. All investments are participant-directed.

Eligibility and Participation

Full-time employees of the Company are eligible to participate in the Plan upon completing two months of service. Part-time, temporary and seasonal employees of the Company are eligible to participate in the Plan upon completing 1,000 hours of service or work three years of completeing at least 500 hours. Employees who become eligible are automatically enrolled into the Plan on the first day of the month following the month the participant meets the above requirements, deferring 5% of eligible compensation, unless they affirmatively elect not to participate or elect a different deferral rate.

Contributions

Each year participants may contribute a portion of their compensation, as defined by the Plan, not to exceed the limits of the Internal Revenue Service ("IRS"). Participants, aged 50 and older, may make catch-up contributions. Participants may also contribute distributions from other qualified plans ("rollovers").

In 2024, the Company made a safe harbor match equal to 100% of the first 3% and 50% of deferrals that exceed the first 3% up to 5% of eligible compensation on elective deferrals made by each participant. The Company may also make discretionary matching and profit sharing contributions to the Plan. There were no discretionary matching or profit sharing contributions in 2024.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and earnings (losses) thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

At the discretion of the Plan Administrator, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator. Interest rates on notes receivable outstanding at December 31, 2024 range from 4.25% to 9.50%. The Plan Administrator determines the term of participant notes made for the purpose of acquiring a primary residence, but not to exceed fifteen years. The term of other participant notes must be five years or less. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits and Vesting

Upon death, disability, termination of service, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account. In addition, hardship distributions are permitted if certain criteria are met and in-service distributions are permitted from participant vested balances for participants who have attained age 59 1/2.

Participants are immediately vested in their contributions and Company contributions plus actual earnings (losses) thereon.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates and are subject to change in the near term.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Substantially all expenses incurred by the Plan are paid by the Plan. Certain expenses may be paid by the Company and are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 7, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Money market fund: Valued using \$1.00 as NAV which approximates fair value. The money market funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: The NAV of each of the pooled separate accounts is calculated in a manner consistent with GAAP for investment companies and is determinative of their fair value and represents the price at which the Plan would be able to initiate a transaction. Several of the pooled separate accounts invest in publicly traded mutual funds or actively managed stocks. Some of the pooled separate accounts also invest in fixed income securities or real estate. The fair value of the underlying mutual funds or stock and of the underlying securities, which is based on quoted prices of similar assets, is used to determine the NAV of the pooled separate account which is not publicly traded.

Investments in the pooled separate accounts can be purchased and sold continuously. The Plan has no obligation to buy additional units.

Corporate bonds: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Note 3: Fair Value Measurements (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Tax Status

The Plan has adopted a non-standard prototype document with a notification letter from the IRS which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter, however, the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and accordingly, believes the Plan is exempt from federal and state income taxes.

Note 5: Related Party and Party-in-Interest

Certain Plan investments are managed by Fiduciary Management, Inc. ("FMI"), a related-party of the Company, and therefore, these transactions qualify as related party transactions. Transactions related to notes receivable from participants and administrative expenses qualify as party-in-interest transactions. These transactions are not considered prohibited transactions under ERISA regulations. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Note 6: Information Prepared and Certified by the Custodian

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information certified as complete and accurate by John Hancock, custodian of the Plan. This information includes investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
