Notes to Financial Statements

Note 1: Description of Plan

The following description of the AAA South Jersey 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1984. The Plan is a defined contribution plan and covers all employees of AAA South Jersey, Inc. (the "Company") who are not considered excluded employees as defined in the Plan, and who have 6 months of service, worked a minimum of 500 hours, and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute either pre-tax or Roth 401(k) deferrals up to the maximum allowable amount as mandated under the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in the respective target date fund until changed by the participant.

The Company matches, under its safe harbor match provision, 100% of salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation. For the year ended December 31, 2024, the Company made matching contributions in the amount of \$234,585. Matching Company contributions are invested as directed by the participant.

Additional profit sharing amounts may be contributed at the option of the Company's management and are invested as directed by the participant. The Company did not make a profit sharing contribution for the year ended December 31, 2024.

The Plan allows for rollover contributions from other qualified plans.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or allocated directly to a participant, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan currently offers various mutual funds and a money market fund through pooled separate accounts. The Plan also offers an investment contract account which is guaranteed by the financial strength and claims-paying ability of Minnesota Life Insurance Company, the guaranteed investment contract issuer. If the contract is terminated by the plan sponsor, a market value adjustment, which is determined based on five-year treasury rates may apply. This adjustment may result in a balance which is below the value of that principal and interest otherwise guaranteed.

Vesting

Participants are fully vested immediately in their elective contributions, the employer safe harbor matching contributions, and the actual earnings thereon. Vesting in the Company's additional profit sharing contributions and earnings thereon are as follows:

Notes Receivable from Participants

Participants may borrow a total of the lesser of 50% of their vested account balance (\$1,000 minimum) or \$50,000. A maximum of one outstanding loan is permitted. Loans provide for repayment over a period not to exceed five years unless such loan is used to purchase a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25 - 9.50%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably via check or ACH.

Note 1: Description of Plan (Continued)

Payment of Benefits

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Terminated participants may receive the value of their vested account upon the date of severance from employment. If the vested account balance is greater than \$1,000, the participant may leave its account with the Plan. Distributions due to death, disability, or normal retirement (age 65), shall begin as soon as practicable after the date of the qualifying event. Participants may receive in-service distributions of their vested account on or after the attainment of age 65 (or upon age 59-1/2 for employee deferral amounts). Distributions are in the form of either a lump-sum distribution, substantially equal installments, or partial withdrawals. The Plan provides for hardship withdrawals under the provisions of the Internal Revenue Code. Distributions can be made in cash, insurance or annuity contracts.

Forfeitures

All forfeitures in the Plan are available to offset Plan expenses and reduce future employer contributions. For the year ended December 31, 2024, forfeitures of \$8,778 were used to reduce employer matching contributions. There were unallocated forfeitures of \$- and \$8,778 at December 31, 2024 and 2023, respectively.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Contracts

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements.

Fees related to investment management services are included in net appreciation (depreciation) in fair value of investments, as the fees are paid through revenue sharing, rather than a direct payment.

Subsequent Events

The Plan has evaluated subsequent events through July 28, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by The Standard Insurance Company, the Custodian of the Plan. The information disclosed in the accompanying financial statements relating to investments and notes receivable from participants held at December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by The Minnesota Life Insurance Company, the Custodian of the Plan.

Note 4: Fair Value Measurements

Accounting standards provide a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds held in pooled separate accounts: Fair value of mutual funds held in pooled separate accounts is based on quoted net asset values of underlying investments held by the pooled separate accounts adjusted by an asset charge. The underlying mutual funds held in the pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price.

Note 5: Fully Benefit-Responsive Investment Contract (FBRIC)

The Plan invests in a fully benefit-responsive investment contract with Minnesota Life Insurance Company. The investment is identified within the Plan as the Fixed Account. The Fixed Account is included in the financial statements at contract value as reported to the Plan by Minnesota Life Insurance Company. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Net investment income of the fund is not distributed, but reinvested and unit values adjusted accordingly.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Minnesota Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 5: Fully Benefit-Responsive Investment Contract (FBRIC) (Continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$8,256 and \$10,228, respectively.

Certain events limit the Plan's ability to transact at contract value with Minnesota Life Insurance Company. Such events include the following: (a) amendments to the Plan documents (including complete or partial termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

Note 6: Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by The Standard Insurance Company, the Custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are generally exempt from ERISA's prohibited transaction rules. Fees for investment management services during the plan year ended December 31, 2024, were offset against earnings.

Notes receivable from participants also qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

Note 7: Tax Status

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The plan administrator is not aware of any significant uncertain tax positions taken by the Plan.

Note 8: Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate its participation in the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their share of employer contributions and earnings thereon.

Note 9: Risks and Uncertainties and Investment Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Users of these financial statements should be aware that the financial markets' volatility may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024, may not necessarily be indicative of amounts that could be realized in a current market exchange.

At December 31, 2024 and 2023, four investment securities represented 58% and five investment securities represented 69% of plan net assets, respectively.
