Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The California Employers Healthcare Alliance Trust (the "Plan") is a multiemployer welfare benefit plan providing hospital, medical, dental care, prescription drug, vision care, chiropractic and mental health benefits to active participants on whose behalf employers contribute to the Plan in accordance with their collective bargaining agreement. Dependents of eligible active participants are also eligible for certain specified benefits. Retired participants are not covered under the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Contributions

Contributions are reported on the financial statements on the accrual basis. Employer contributions are contributions made by employers on behalf of eligible employees based on specified contribution rates for months worked during the year. Participant self-payments are payments by participants for months of coverage during the year. Contributions received in advance of the month worked or the month of coverage are reported as deferred contribution revenue. Contribution rates in effect during the year varied based upon amounts required to be contributed in accordance with collective bargaining agreements between participating unions and various employer groups. The Plan allows for continuation of coverage for eligible active participants as required under COBRA. Rates for COBRA continuation of coverage premiums are periodically approved by the Board of Trustees.

D. Employer Payroll Compliance Program

Employer remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under an audit, collection and delinquency policy and procedure.

E. Benefits

Benefits reported are premiums for eligible participants paid during the year (Premiums Paid). Benefit obligations consist of premiums payable, which is an estimate of premiums for coverage during the year, unpaid at the end of the year. The statements of changes in benefit obligations reflects the components of the changes in benefit obligations.

E. Benefits (Continued)

No retired participants are covered under the Plan, therefore, postretirement benefit obligations are not reported on the financial statements.

NOTE 3 - TAX-EXEMPT STATUS

The Plan is tax-exempt under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i, therefore, no provision is made for federal or state income taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - ADMINISTRATION AND SERVICE CONSULTANT FEES

The Plan is administered by PacFed Benefit Administrators, Inc. ("PacFed"). The monthly administration fees per participant for the years ended December 31, 2024 and 2023 were as follows:
