**1. DESCRIPTION OF THE PLAN:**

The following description of Sunbury' Motor Company 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of Sunbury Motor Company and Mertz Partnership (Companies). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year participants in the Plan may contribute up to the maximum annual amount allowable by the Internal Revenue Code (IRC) of pretax or after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Companies contribute a percentage of the participants' elective contribution which is established annually. In addition to these contributions, the Companies may, at the discretion of the Companies' management, make additional contributions to the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers thirty mutual funds, four pooled separate accounts and one guaranteed general account as investment options for participants. Contributions are subject to certain IRC limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Companies contributions, Plan earnings and forfeitures of terminated participants' nonvested accounts. Participants accounts are charged with administrative expenses that are paid by the Plan and reduced by distributions to participants. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. Any asset transfers from or to other retirement plans are also credited or charged to the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Companies contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a period not exceeding the life expectancy of the participant. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, the Plan allows for a hardship withdrawal if certain criteria are met.

**Forfeited Accounts**

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are used to pay plan expenses or to reduce future employer contributions. Forfeited nonvested accounts totaled \$26 and \$1 as of December 31, 2024 and 2023, respectively. During 2024, forfeited nonvested accounts of \$1,221 were used to pay Plan expenses and \$2,908 were used to reduce employer contributions.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value and contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are classified as dividends. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefit payments, including payments to participants and direct rollovers to other retirement plan accounts, are recorded upon distribution.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees related to custodial and record keeping services are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**3. INVESTMENT CONTRACT WITH INSURANCE COMPANY:**

The Plan has a traditional investment contract with Principal Life Insurance Company (Principal) for the years ended December 31, 2024 and 2023. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The following represents the traditional investment contract held by the Plan as of December 31, 2024 and 2023:

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer, but it may not be less than 0.15% or more than 3%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include plan termination, contract termination by the plan sponsor, and other withdrawals deemed to be plan sponsor directed as defined by the contract. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contracts permit the insurance company to terminate the agreement prior to the scheduled maturity date after five completed contract years and a 90 day written notice.

**4. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Valued at NAV as determined by Principal, the custodian.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**6. TAX STATUS:**

The Companies adopted a prototype non-standardized pre-approved profit sharing plan with CODA which received a favorable opinion letter dated June 30, 2020 from the IRS which stated that the non-standardized pre-approved profit sharing plan with CODA was acceptable under section 401 of the IRC for use by employers for the benefit of their employees. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**8. INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED):**

At December 31, 2024 and 2023, the Plan's investments were held by Principal, the custodian of the Plan. The following is a summary of the Plan's financial statements based on information certified by Principal as complete and accurate in accordance with Section 2520.103-8 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**9. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS:**

Plan investments are managed by Principal, the custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. These transactions qualify as party-in-interest transactions and are denoted as such on the supplemental schedule of assets held at end of year.

Principal provides recordkeeping services to the Plan. Fees paid by the Plan for recordkeeping services to Principal amounted to \$50,517 for the year ended December 31, 2024.

Prime Pensions, Inc. provides certain administrative services to the Plan. No fees were paid by the Plan for administrative services for the year ended December 31, 2024.

Sunbury Motor Company, the plan sponsor, charges an annual maintenance fee to terminated plan participants with certain vested account balances. No fees were paid by the Plan for maintenance fees for the year ended December 31, 2024.

The Companies pay directly any other fees related to the Plan's operations.

**10. PLAN AMENDMENTS:**

Effective January 1, 2024, the Plan was amended to comply with the required SECURE 2.0 Act provision related to discontinuing Roth required minimum distributions prior to a participant's death and the voluntary SECURE 2.0 Act provisions related to increasing the dollar limit for mandatory distributions from \$5,000 to \$7,000.

Effective May 1, 2024, the Plan was amended to reduce the hours requirement for a year of eligibility service from 1,000 to 500 hours.

**11. SUBSEQUENT EVENTS:**

Subsequent events have been evaluated through September 3, 2025, which is the date the financial statements were available to be issued.
