Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of The DeRoyal Employees' Savings & Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the DeRoyal Employees' Savings & Retirement Plan (the "Plan") provides only general information. Readers should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all eligible employees of DeRoyal Industries, Inc., its wholly-owned subsidiaries (Atlanta International Prosthetics, and Debusk Services, LLC) and its affiliated entities (DeRoyal Textiles, Inc., Royal Converting, Inc., and Waterstone Acquisition, LLC) (collectively the "Company") who have completed six months of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - Each year, participants may elect to defer a percentage of their compensation, as defined in the Plan. Total deferrals in any taxable year may not exceed a dollar limit which is set by law. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers thirty (30) registered investment companies, cash and a general account through the Plan's US Government Money Market account with State Street Institutional.

The Company may, at its discretion, make matching and non-matching contributions. The Company will match participants' contributions up to 4% of compensation.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions (if any) and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in employer contributions is based on years of continuous service. Employees hired before January 1, 2008 are subject to 0% vesting before their first year of service, 20% after 1 year of service and 100% after 2 years. For employees hired after January 1, 2008, employees are 0% vested until their second year of employment upon which they become 100% vested.

Participant Loans - Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear annual percentage rates ranging from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits - Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments, not extending beyond the participant's assumed life expectancy.

Forfeited Accounts - At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$653 and \$974, respectively. These accounts are available to be used to reduce future Company contributions.

Administrative Expenses - Diversified Investment Advisors charges the Plan for recordkeeping services. All other administrative expenses of the Plan are paid by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The Plan's financial statements have been prepared using the accrual basis of accounting.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - (Continued)

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Registered investment companies are valued based on the quoted market price of the underlying securities. Participant loans are valued at their outstanding balances, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Date of Management's Review - Management has evaluated events and transactions occurring subsequent to the December 31, 2024 for items that should potentially be recognized or disclosed in the financial statements. The evaluation was conducted through August 5, 2025, which is the date the financial statements were available to be issued.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. A valuation hierarchy has been established for disclosure of the inputs used to measure fair value. This hierarchy prioritizes the inputs into three broad levels. Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities. Level 2 inputs are quoted prices for similar assets and liabilities in active markets or inputs that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument. Level 3 inputs are unobservable inputs based on the Plan's assumptions used to measure assets and liabilities at fair value. A financial asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies

The fair value of registered investment companies (collective trust funds and mutual funds) is based on quoted net asset values of the shares held by the Plan at December 31, 2024 and 2023.

General Account

The general account is part of a group annuity contract which invests in stable value investment contracts. The contract value of the general account approximates fair value at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At December 31, 2024 and 2023, the Plan had no liabilities carried at fair value subject to remeasurement on a recurring basis. The following table provides the assets carried at fair value measured on a recurring basis as of December 31, 2024 and 2023:

NOTE 5 - GROUP ANNUITY CONTRACT

In 2015, the Plan entered into a group annuity contract with Reliance Trust Company ("Reliance"). Reliance maintains contributions in registered investment companies and a general account.

The general account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative fees. The general account is included in the statements of net assets available for benefits at fair value which approximates contract value as reported to the Plan by Reliance. The average yield on the general account was 3.06% and 2.28% for 2024 and 2023, respectively. The credited interest rate is set monthly.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their company contributions.

NOTE 7 - INCOME TAX STATUS

The Plan has adopted the Volume Submitter Tax-Favored Savings and Discretionary Contribution Plan and Trust Agreement sponsored by Diversified Investors Securities Corporation. The Internal Revenue Service has determined and informed the amended Plan by a letter dated March 31, 2014, that the Plan and related trust are in accordance with applicable sections of the Internal Revenue Code ("IRC").

The Plan recognizes tax loss contingencies when it is probable that a liability had been incurred and the amount of the loss can be reasonably estimated. The amount recognized would be subject to estimates and management's judgment with respect to the likely outcome of each uncertain tax position. Although the tax years ending December 31, 2021 through December 31, 2024 remain open for examination by various taxing authorities, it is management's opinion that no significant uncertain tax positions remain open at December 31, 2024.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with its investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - PARTY-IN-INTEREST

The Plan's investments are managed by Transamerica. Transamerica is the third-party administrator for the Plan. Accordingly, these transactions qualify as being with a party-in-interest. Another party-in-interest is Rodefer Moss & Co, PLLC who serves as the auditor of the Plan.
