We have performed audits of the financial statements of MidWestOne Financial Group, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of MidWestOne Financial Group, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1 - Description of Plan**

The following brief description of the MidWestOne Financial Group, Inc. 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution 401(k) plan that covers substantially all employees of MidWestOne Financial Group, Inc. and participating employers MidWestOne Bank, MidWestOne Insurance, and Central Bank (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The MidWestOne Bank Retirement and ESOP Committee is responsible for oversight of the Plan.

**Eligibility**

Effective February 1, 2024, employees are eligible to participate in the Plan if they are 18 years of age. Certain employees acquired on February 1, 2024, are eligible to participate in the Plan if they completed one month of service and are 18 years of age (the requirements prior to February 1, 2024).

**Entry Date**

Employees may enter the Plan on the first day of the month following the date they satisfy the Plan's eligibility requirements.

**Contributions**

Participants may elect to contribute a percentage of their compensation up to the maximum permissible under the Internal Revenue Code (IRC). Participants who have attained age 50 are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Until July 31, 2023, the Company contributed a safe harbor match to the Plan equal to 100% of the employee's contributions up to 3% of the employee's eligible compensation, plus 50% of the employee's contributions that exceed 3% not to exceed 5% of the employee's eligible compensation. After August 1, 2023, the Company contributes 100% of the employee's contributions up to 4% of the employee's eligible compensation, plus 50% of the employee's contributions that exceed 4% not to exceed 6% of the employee's eligible compensation.

For each Plan year, the Company may, at its sole discretion, contribute an additional amount to the Plan that is allocated to the participants based upon an individual's eligible compensation compared to total eligible compensation for all participating employees. No such additional contributions were made for the years ended December 31, 2024 and 2023.

### Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contributions, as well as allocations of the Company's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balance or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Investment Options

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

### Vesting

Participants are vested immediately in their contributions and employer safe harbor matching contributions. Vesting in profit sharing contributions is based on years of service. Vesting is based on years of credited services as set forth in the following table:

### Forfeitures

At December 31, 2024 and 2023, there were no forfeited non-vested account balances. Forfeited non-vested accounts may be used to reduce future employer contributions or offset plan expenses. During the years ended December 31, 2024 and 2023, no forfeitures were used to reduce employer contributions or offset plan expenses.

### Notes Receivable from Participants

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. The loan interest rate, determined at the time of origination, is set at the Wall Street Journal prime rate plus 1%. Principal and interest is paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the note were used to acquire the participant's principal residence, in which case the loan terms can range up to 15 years. A participant may have only two outstanding notes at any one time.

**Payment of Benefits**

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest, or installments, as defined in the Plan document upon retirement, termination of service, death, or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Distributions may be made from certain accounts at the participant's election prior to termination upon attainment of certain ages or hardship, as defined in the Plan document.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 2 - Significant Accounting Policies****Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by investment advisors, custodians, and other third parties. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

**Contributions**

Participant contributions and the related Company safe harbor matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred.

**Payments of Benefits**

Benefit payments to participants are recorded upon distribution.

**Expenses**

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

**Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (including the money market mutual fund) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective funds – Valued at fair value based on the NAV of units held of the collective fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### Note 4 - Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year then ended and the period from January 1, 2024, through January 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by American Trust Company (the trustee of the Plan) for the year ended December 31, 2023, and the period from January 1, 2024, through January 31, 2024.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from February 1, 2024 through December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan) for the period of February 1, 2024 through December 31, 2024.

#### Note 5 - Tax Status

For the year ended December 31, 2023, and from January 1, 2024, through January 31, 2024, the Plan used a pre-approved plan document sponsored by AT Retirement Services, LLC, which received an advisory letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Effective February 1, 2024, the Plan uses a pre-approved plan document sponsored by FMR LLC, which received an advisory letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6 - Related Party and Party-in-Interest Transactions**

Certain Plan investments consist or consisted of common/collective trust funds managed by Fidelity Investments, an entity related to Fidelity Management Trust Company, the trustee, and American Trust Company, the prior trustee as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under the ERISA.

#### **Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9 - Plan Amendments**

Effective February 1, 2024, the Plan changed its trustee and record keeper from American Trust to Fidelity Management Trust Company. At that time, eligibility requirements were changed to remove the service requirement of 1 month, with the exception of employees acquired on February 1, 2024. The entry date of the Plan was changed to the first day of each month.

**Note 10 - Transfer from MidWestOne Financial Group, Inc. Employee Stock Ownership Plan**

Throughout the 2024 plan year, certain participants elected to diversify their ESOP balances and transferred their ESOP assets into the Plan, totaling \$99,169.

**Note 11 - Subsequent Events**

Effective January 1, 2025, the Plan was amended to change the employer safe harbor matching contributions to 100% of the employee's contributions up to 6% of the employee's eligible compensation.

Effective May 7, 2025, the Plan was amended to merge in the MidWestOne Financial Group, Inc. Employee Stock Ownership Plan and Trust.

The Plan Sponsor has evaluated subsequent events through September 9, 2025, the date which the financial statements were available to be issued.
