INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of
Cerus Corporation 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Cerus Corporation 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of Cerus Corporation 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was adopted by Cerus Corporation (the “Company” and “Plan Sponsor”) on January 1, 1992, and was most recently amended effective August 1, 2024. The Plan is defined as a contribution retirement plan of the profit-sharing type containing a cash or deferred arrangement described in Internal Revenue Code (“IRC”) Section 401(a). All full-time employees of the Company are eligible to participate in the Plan upon employment. The entry date for eligible employees is the first day of each month. Certain classes of employees, as defined by the Plan document, are excluded from participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the IRC.

Plan Amendments

Effective January 1, 2024, the Plan document was amended to allow terminated participants to continue to make loan repayments.

Effective August 1, 2024, the adoption agreement was amended to include future after tax contributions, In-plan Roth conversions and to include partial withdrawals as a form of distribution. The definition of compensation was updated for compensation exclusions.

Plan Administration

The Company manages the operation and administration of the Plan. Fidelity Management Trust Company (“Fidelity”) is the appointed trustee and recordkeeper for the Plan, and acts at the direction of the Plan’s administrator.

Contributions

Employees are immediately eligible to participate in the Plan and may begin deferring a portion (up to 60%) of their compensation into the Plan on a before-tax, after-tax (Roth) or future after-tax basis pursuant to Code Section 401(k) up to the limits imposed by Section 402(g) of the IRC. The Plan has an auto enrollment provision with an initial 4% for newly-eligible employees 35 days after such employee date of hire, but no sooner than such employee entry date. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to 100% of eligible compensation, up to the annual catch-up limits as noted above. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct their investments into various investment options offered by the Plan. The Company may contribute a discretionary matching or nonelective contribution, but is not required to contribute to the Plan. Eligible participants must be employed on the last day of the Plan year and completed at least 1,000 hours of service in order to share in any employer nonelective contribution. During the year ended December 31, 2024, the Company approved a discretionary employer matching contribution of 50% of the employee elective deferrals up to 6% of eligible compensation, with a maximum contribution of \$5,000 per participant. Employer matching contributions amounted to approximately \$887,000 for the year ended December 31, 2024. For the year ended December 31, 2024, no nonelective contribution was approved or made.

Participant Accounts

Each participant's account is credited with the participant's contributions, Plan earnings or losses, and rollovers from other qualified plans. Plan earnings or losses are allocated based upon each participant's account balance. Participants are charged with an allocation of administrative expenses paid by the Plan. Certain fees are charged to the fund investments and are offset against Plan investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the funds prospectuses for details on the various types and amounts of investment fees charged to the Plan and their individual accounts.

Vesting

Participant contributions, employer matching contributions and rollovers, as well as net earnings on these contributions and rollovers, are fully vested when made or earned. Non-elective employer discretionary contributions, if any, vest according to the following schedule:

Forfeitures

Forfeitures amounted to approximately \$2,500 and \$1,700 as of December 31, 2024 and 2023, respectively. No forfeitures were used for the year ended December 31, 2024.

Notes Receivable from Participants

Participants are allowed one loan at any time and may borrow from their fund accounts a minimum of \$1,000 up to 50% of the value of their account balance, or \$50,000, whichever is less. Participant notes receivable terms range from one to five years, except for loans used to purchase a primary residence, which have a maximum term of ten years. The participant notes receivable are secured by no more than 50% of the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time the loan originates. As of December 31, 2024 and 2023, the interest rates on participant notes receivables were 4.25% to 9.50%. Principal and interest are paid in equal installments through regular payroll deductions.

Payment of Benefits

When participants leave the Company upon normal retirement age (59½) or for any other reason, those participants (or their beneficiaries) may receive the full value of their salary deferrals, rollovers, and the net earnings thereon in a single lump-sum payment. A participant who becomes disabled under the employer's long-term disability plan is eligible for disability retirement.

Payment of Benefits, continued

In-service withdrawals are permitted at age 59½ and for certain immediate financial hardship as defined by the Plan document subject to a \$500 minimum amount. A participant who continues employment after reaching normal retirement age shall have a continuing right to elect to receive a distribution of all or any portion of their account. Active employees are also permitted to withdrawal discretionary matching and non-elective contributions at age 55 providing they are 100% vested in those contributions.

Distributions under the Plan shall generally be made as soon as possible after the date of retirement, date of death, or termination of employment. The Plan allows for automatic lump sum distributions of participant vested account balances that do not exceed \$1,000. In the event of a mandatory distribution greater than \$1,000 but less than \$5,000 for which the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, the Plan's administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan's administrator.

In order to receive a distribution, participants (or their beneficiaries) are required to file the appropriate forms with the Plan's administrator. Account values will be determined as of the day the distribution is made.

Investment Options

Investments of the Plan are held by Fidelity. Upon enrollment in the Plan, a participant may direct his or her contributions in percentage increments into a series of mutual funds, brokerage link accounts or a money market fund offered by the Plan. Participants may change their investment options at any time.

SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since provisions of SECURE Act 2.0 include both required and optional elements, applicable provisions will be evaluated and implemented in accordance with accompanying regulations and guidance, and the Plan will be amended as required. Certain provisions became effective for 2024, including changes to long-term part-time eligibility and additional increases to the required minimum distribution age. These changes had no material impact to the Plan's financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are reflected on a trade date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan's administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are not paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Such expenses were primarily comprised of fees and expenses related to maintenance of the Plan's records.

Payment of Benefits

Benefit payments are recorded when paid.

Information Certified by the Trustee

Fidelity has prepared and certified as complete and accurate the Plan's schedule of investment assets, notes receivable from participants, transactions, and net realized and unrealized gains and losses on investments, and interest and dividend income, which was used to prepare the accompanying financial statements and supplemental schedule.

4. Fair Value Measurements

Accounting standards for fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these accounting standards are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Cash equivalent and money market fund: Valued based on redemption values on the last business day of the Plan year.

Preferred stocks, common stocks, corporate bonds, U.S. government securities, and brokerage link accounts: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity, the trustee of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

The Plan has a revenue sharing account ("RCP account"), which are applied to pay Plan administrative expenses or allocated to the accounts of the participants. As of December 31, 2024 and 2023, the RCP account amounted to \$17,000 and \$3,500, respectively. No RCP amounts were used for the year ended December 31, 2024.

6. Tax Status

The Plan Sponsor adopted a volume submitter defined contribution Plan document. The Plan document obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan document, as then designed, was in compliance with the applicable requirements of the IRC. The Plan document has been amended since receiving its opinion letter. However, the Plan's administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for federal or state income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan may be subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

The Company has established the Plan with the intention and expectation that the Plan will continue indefinitely. However, the Company reserves the right at any time to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, distributions will be made to participants as described in the Plan document, and participants would become 100% vested in their Company contributions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks will occur in the near term that could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

As of December 31, 2024, the Plan held investments in three funds that represented 23%, 15% and 10% of net assets.

As of December 31, 2023, the Plan held investments in two funds that represented 19% and 13% of net assets.
