To the Board of Trustees of

### HAYDON COMPANIES 401(k) PLAN

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of *Haydon Companies 401(k) Plan* (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### Opinion

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### (1) Description of the Plan

The following description of the *Haydon Companies 401(k) Plan* (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**A. General** – The Plan, established in 1998 and amended and restated at various dates, is a defined contribution plan covering all employees of Haydon Companies, LLC (the "Company") who are age eighteen or older. Union, leased, and nonresident alien employees are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 ("ERISA").

On January 1, 2023 and March 29, 2024, the Plan was amended to allow related employers of the Company to participate in the Plan. The Plan was further amended on April 3, 2023 to allow participation in the Plan for part-time employees and interns of the Company.

Effective March 29, 2024, the Plan was amended to update the Plan name from Haydon Building Corp 401(k) Plan to Haydon Companies 401(k) Plan and update the Plan Sponsor from Haydon Building Corp to Haydon Companies, LLC.

**B. Participant contributions** – Participants may contribute between 1% and 75% of their eligible compensation, as defined by the Plan, on a pre-tax or after-tax (Roth) basis, subject to certain limitations prescribed by the Internal Revenue Code ("IRC"). Roth elective deferrals are treated in the same manner as elective deferrals for all Plan purposes. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Plan entry date is on the first day of the month coinciding with or immediately following the date an employee satisfies the eligibility requirements of the Plan.

**C. Employer contributions** – Effective January 1, 2024 the Plan was amended to implement a safe harbor employer match, to be made based on each participant's annual eligible compensation, as defined by the Plan, and equal to 100% of the first 3% of the participant's compensation plus 50% of the next 2% of the participant's compensation deferred to the Plan. The Plan also contains provisions for additional matching employer contributions at the option of the Company. Participants may receive additional matching employer contributions, if authorized, only if they are a non-highly compensated employee. There were no additional matching employer contributions authorized for the 2024 Plan year.

**D. Participant accounts** – Each participant's account is credited with the participant's contributions, the Company's contributions, an allocation of Plan earnings, and charged with an allocation of administrative fees. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**E. Investments** – Participants direct the investment of their contributions and the Company's matching contributions into any of the investment options offered by the Plan.

**F. Vesting** – Participants are immediately vested in their elective and rollover contributions, the Company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's non-safe harbor matching contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant vests 25% after one year of credited service and becomes 100% vested after four years of credited service.

### (1) Description of the Plan (continued)

**G. Payment of benefits** – In general, distributions from the Plan will be made in one lump-sum payment in cash. If the value of a participant's vested benefit is more than \$7,000 on termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a certain period, and in no event exceeding the life expectancy of the participant as determined at the time of distribution. If the value of a participant's vested benefit is \$7,000 or less, a lump sum payment will be made to the participant. The Plan provides for the payment of benefits in amounts up to the entire vested balance in a participant's account upon one of the following:

- a) Termination of employment
- b) Death or disability of participant
- c) Attainment of age 59 ½
- d) Demonstrated hardship

**H. Notes receivable from participants** – Participants may borrow an amount not to exceed 50% of their vested account balance, up to a maximum of \$50,000 (but not less than \$1,000). The loans are secured by the balance in the participant's account and bear interest at the prime rate on the loan date plus 1% and is fixed over the life of the loan. The notes receivable must be repaid through an established repayment schedule, not to exceed five years from the date the proceeds are received, unless the entire proceeds are used to purchase the participant's primary residence, in which case the loan may be repaid over a longer term. Upon default, death, disability, or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable.

**I. Forfeited accounts** – Forfeited non-vested accounts are first used to pay administrative fees, if so directed by the Company; any remaining balances may be used to reduce the Company's contributions. Forfeited non-vested accounts totaled approximately \$15,500 and \$53,800 at December 31, 2024 and 2023, respectively. Forfeitures totaling \$148,872 were used to reduce the Company's contributions during the year ended December 31, 2024.

**J. Plan termination** – Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the Company's matching contributions.

**K. Administrative fees** – The Company has elected to pay certain administrative fees on behalf of the Plan. The Plan has no obligation to reimburse the Company for such expenses. Participant loan origination fees are charged to the account of the participant requesting the loan.

### (2) Summary of Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

**Basis of accounting** – The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

**Management's use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management of the Plan to make estimates and assumptions that affect the reported amounts of net assets and the reported amounts of additions to and deductions from net assets. Accordingly, actual results may differ from those estimates.

### (2) Summary of Significant accounting policies (continued)

**Investment valuation and income recognition** – Investments are reported at fair value. Fair value is the price that would be received if an asset was sold or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants** – Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

**Payment of benefits** – Benefits are recorded when paid.

**Risks and uncertainties** – The Plan invests in various investment securities that are exposed to various risks such as interest rate, market, and credit risks. The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such instruments. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Subsequent events** – Plan management has evaluated subsequent events through September 11, 2025, the date the financial statements were available to be issued.

### (3) Fair value measurement

FASB ASC 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### (3) Fair value measurement (continued)

The following is a description of the valuation methodologies used for the investments held by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds and money market fund:* Stated at net asset values, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.

*Self-directed brokerage (“SDB”) accounts:* SDB accounts consist primarily of mutual funds and interest-bearing cash. Mutual funds are valued at the net asset value of shares held by the Plan at year end, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions. Interest-bearing cash is stated at cost, which approximates fair value.

*Common collective trust:* Valued based upon the quoted redemption value of units, or the equivalent of net asset value, which is a practical expedient for estimating fair value. This investment had no unfunded commitments as of December 31, 2024 and 2023 and can be redeemed daily with no redemption notice period or other redemption restrictions.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### (5) Tax status

The Plan has adopted a defined contribution Prototype Plan document, which obtained a favorable opinion dated June 30, 2020 stating that the Prototype Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan administrator and the Company believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### (6) Party-in-interest transactions

Certain Plan investments are managed by Fidelity Management Trust Company, the Plan's trustee. In addition, Fidelity Workplace Services LLC (collectively, "Fidelity") provides the Plan recordkeeping and contract administration services; therefore, these transactions qualify as exempt party-in-interest transactions. Administrative fees paid by the Plan to Fidelity for the year ended December 31, 2024 totaled \$51,610.

There was also \$42,783 paid to two other parties during the year ended December 31, 2024 that consisted of advisory services.

The Company is the Plan Sponsor and provides all matching contributions to the Plan; consequently, these transactions also qualify as party-in-interest transactions.

### (7) Excess contributions refundable

The Plan is required to return contributions received during the year in excess of IRC limits. At December 31, 2024 and 2023, amounts refundable by the Plan to participants for contributions made in excess of amounts allowed totaled \$0 and \$172,809, respectively. The amounts have been reflected as excess contributions refundable in the accompanying statements of net assets available for benefits and as a reduction of participant contributions in the accompanying statement of changes in net assets available for benefits.
