INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
APT Manufacturing Solutions 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the APT Manufacturing Solutions 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

GENERAL – The Plan is a defined contribution plan, adopted January 1, 1997, covering all full-time employees of APT Manufacturing Solutions (“Company”), who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). APT Manufacturing Solutions investment committee oversees governance of the Plan.

ELIGIBILITY – All employees, except residents of Puerto Rico, and part-time, temporary, or seasonal employees of the Company are eligible to participate in the Plan after 90 days of service and make automatic contributions into the Plan, unless they opt out. For profit sharing contributions, employees must have one year of service (1000 hours min) and be 21 years of age.

CONTRIBUTIONS – Each year, participants may contribute a percentage of their compensation on a pre-tax or after-tax basis, up to IRS limits, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes “safe harbor” contributions in which they match 3% of participant compensation. Contributions are subject to certain statutory limitations. The Company may also make a discretionary profit-sharing contribution to participants’ accounts.

PARTICIPANT ACCOUNTS – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants may direct the investment of their account balances into various investment funds offered by the Plan.

VESTING – Participants are immediately vested in their contributions, the Company’s safe harbor contributions, and actual earnings thereon. Participants will be vested in the Company’s profit sharing contribution based on years of service as follows:

<u>Completed Years of Service</u>	<u>Vested Percentage</u>
Less than 2	0%
At least 2, but less than 3	20%
At least 3, but less than 4	40%
At least 4, but less than 5	60%
At least 5, but less than 6	80%
6 or more	100%

PAYMENTS OF BENEFITS – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or partial payments. If a participant terminates employment and the participant’s account balance does not exceed \$7,000 (\$5,000 in 2023), the Plan administrator will authorize the lump sum payment without the participant’s consent. If a participant terminates employment and the participant’s account balance is above \$7,000 (\$5,000 in 2023), the participant will be sent a separation package containing forms and details of their options.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

PLAN TERMINATION – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the trustee shall distribute all assets remaining in the Plan, after payment of any expenses properly chargeable against the Plan, to the participants in accordance with the value of the units credited to such participants as of the date of such termination. Upon termination of the Plan, participants become 100 percent vested in their account balances.

FORFEITED ACCOUNTS – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. These accounts will be used to reduce future employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

DATE OF MANAGEMENT’S REVIEW – Subsequent events were evaluated through September 8, 2025 which is the date the financial statements were available to be issued.

USE OF ESTIMATES – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

BASIS OF ACCOUNTING – The financial statements of the plan are prepared on the accrual basis of accounting.

INVESTMENT VALUATION AND INCOME RECOGNITION – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan’s valuation policies. See Note 3 for discussion of fair value measurements.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

PAYMENT OF BENEFITS – Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES - Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Fees for the administration are included in administrative expense.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan’s investments. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds - The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

Insurance Contract - The Standard Stable Asset A is available through a rider to Standard Insurance Company’s group annuity contract. As such, it is an insurance contract that is measured at contract value. Contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited.

NOTE 4 –CERTIFIED INVESTMENTS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023, and investment income for the years ended December 31, 2024 and 2023, that is disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank and Standard Insurance Company.

NOTE 5 – GROUP ANNUITY CONTRACT WITH STANDARD INSURANCE COMPANY

The Standard Stable Asset Fund is a fixed rate group annuity contract and investment product offered by Standard Insurance Company. Contributions are deposited into a general account. The contract provides a guaranteed return of principal and interest of 1% or above, that is declared shortly before each quarter. Contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. The Stable Asset Fund provides participants with full book value liquidity for benefit payments and transfers to other investment options with no penalties or fees on a daily basis. The average yield earned by the Plan was 3.04% and 2.78% for the periods ended December 31, 2024 and 2023, respectively. The yield credited to the participant accounts was 2.49% and 2.08% for the periods ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, the contract value of the fully benefit-responsive contract totaled \$501,641 and \$393,683.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

All Plan investments are managed by The Standard. The Standard is the record keeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Investment fees charged to the Plan are absorbed in investment income and amounted to \$27,544 and \$23,149 for the periods ended December 31, 2024 and 2023.

Venture Visionary Partners, LLC is a fiduciary to the Plan and, therefore, these transactions qualify as party-in-interest transactions. Investment fees charged to the Plan are absorbed in investment income and amounted to \$22,020 and \$21,000 for the periods ended December 31, 2024 and 2023.

NOTE 8– TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated, March 31, 2014 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
