## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
Farallon Consulting, LLC 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Farallon Consulting, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## Notes to Financial Statements

December 31, 2024 and 2023

---

### NOTE 1 – ORGANIZATION AND DESCRIPTION OF THE PLAN

The provisions of the Farallon Consulting, LLC (the Company) 401(k) Plan (the Plan) were effective January 1, 2003. The Plan has been amended and restated to comply with current legislation. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan that covers substantially all employees of the Company, excluding non-resident aliens, employees covered by a collective bargaining agreement, and leased employees. Effective January 1, 2025, part-time, temporary, or seasonal employees who are regularly scheduled to work less than 1,000 hours of service in an entry service period will also be excluded. Employees are eligible to participate in the Plan upon attaining age 21 and completing three months of service. Effective January 1, 2025, there will be no service requirement to participate in the Plan. The Plan contains arrangements for salary deferrals by employees under section 401(k) of the Internal Revenue Code, employer safe-harbor contributions, and discretionary employer contributions. Employees eligible to participate in the Plan may enroll on the first day of the month following the date the eligibility requirements are met. To be eligible to receive discretionary employer contributions, employees must be employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

#### Contributions

The Plan provides for automatic enrollment of employees. Newly eligible employees are enrolled in the Plan at a salary reduction rate of 3% with a step-up rate of 2% each subsequent year, up to a maximum of 11%. Participants may elect to defer up to 100% of their pre-tax or Roth after-tax eligible compensation to the Plan, within statutory limits, and as defined in the Plan document. Participants can stop or change their deferral elections at any time. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company provides safe-harbor contributions each pay period equal to 100% of salary deferrals up to the first 3% of compensation plus 50% of salary deferrals up to the next 2% of compensation. Participant and safe-harbor contributions are paid to the Plan after each pay period and placed in participant directed investments.

The Company may authorize discretionary contributions. The Company did not authorize a discretionary contribution during 2024.

## **NOTE 1 – ORGANIZATION AND DESCRIPTION OF THE PLAN (continued)**

### **Participant Accounts**

Individual participant accounts are maintained by the Plan's third-party administrator. Each account is credited or charged with the participant's contributions, the Company's contributions, allocations of investment income and losses on the individual account balances, and administrative expenses. Loan and distribution administration fees are deducted from the respective participants' accounts. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investment Options**

Participants direct employee and employer contributions among various mutual funds and a guaranteed interest account.

### **Vesting**

Participants are immediately vested in their own contributions and the safe-harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions, if any, is based on years of credited service, as defined in the Plan document, with 20% vesting after each year of service, with full vesting after five years of service. Upon normal retirement (65), death or disability, participants become fully vested in all benefits.

### **Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. Terms of the notes receivable may not exceed five years, except for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time of loan issuance as determined by the Plan Administrator. Interest rates are between 9% and 9.5% on notes receivable outstanding at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

### **Payment of Benefits**

Benefits may be distributed upon retirement, death, disability, or other termination of employment. Benefits equal to the value of the participant's vested account may be paid in a lump-sum. Under certain hardship circumstances or attainment of age 59 ½, participants may request a lump-sum distribution of their vested account balances prior to retirement.

### **Forfeited Accounts**

Upon termination, participants' non-vested account balances are forfeited. Forfeitures may first be used to pay Plan administrative expenses, if any, and any remaining forfeitures may be used to reduce employer contributions. If any forfeitures still remain, forfeitures will be allocated to active participants employed on the last day of the Plan year. There were no forfeited non-vested accounts at December 31, 2024 or 2023. During 2024, no forfeitures were used.

## **NOTE 1 – ORGANIZATION AND DESCRIPTION OF THE PLAN (continued)**

### **Subsequent Events**

The Plan has evaluated subsequent events through August 21, 2025, the date the financial statements were available to be issued.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following are significant accounting policies used by the Plan:

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, trustees, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances. Related fees are recorded as administrative expenses and are expensed when they are deducted from the participant's account. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrators deem the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### **Payment of Benefits**

Benefits are recorded when paid.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for individual transactions such as distributions and loans are deducted from the respective participant's account. Investment related expenses are included in net appreciation in fair value of investments.

## NOTE 3 – FAIR VALUE MEASUREMENTS

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan's investments at fair value consist solely of mutual funds, which are valued as of December 31, 2024 and 2023 using level 1 measurement.

## NOTE 4 – GUARANTEED INTEREST ACCOUNT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive investment contract (guaranteed income fund) with Principal Life Insurance Company (Principal Life). The contract is a guaranteed income fund and is reported at contract value. Contract value is the relevant measure for insurance contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the insurance company general account synthetic investment contract is \$3,806,021 and \$3,751,455 at December 31, 2024 and 2023, respectively.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is established by the contract issuer and the minimum will range between 0.15% and 3% depending on prevailing market conditions. The crediting rate is reset every six months. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **NOTE 4 – GUARANTEED INTEREST ACCOUNT WITH INSURANCE COMPANY (continued)**

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include the following:

- Amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan)
- Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions
- Bankruptcy of the Plan Sponsor or other Plan Sponsor events (i.e., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan
- The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974

Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed income fund may be terminated by Plan management at any time and may be subject to a surrender charge. In October 2024, the plan sponsor submitted a notice of intent to terminate the Plan's interest in the guaranteed income fund. Under the 12-month advance notice option, the Plan's interest will liquidate in October 2025 without applying a surrender charge.

#### **NOTE 5 – CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants that is disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest from guaranteed interest account, dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust), the trustee of the Plan.

#### **NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Principal Trust, the trustee. The Plan also invests in a guaranteed investment contract issued by its affiliate, Principal Life. Therefore, transactions with Principal Trust and its affiliates qualify as party-in-interest transactions. Fees are paid by the Plan to these parties for administrative services.

## **NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

## **NOTE 8 – TAX STATUS**

The Plan operates under provisions of a Pre-Approved Plan, which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the Pre-Approved Plan, as then designed, was acceptable under the applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and, therefore, believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan allows participants to invest in investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with the investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
