Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The Western Alliance Trust Fund (the “Plan”) is a multiemployer welfare benefit plan providing hospital, medical, chiropractic, life and accidental death, dental care, mental health, prescription drug and vision care benefits to participants on whose behalf employers contribute to the Plan in accordance with their collective bargaining agreement to provide specified benefits. Dependents of eligible participants are also eligible for certain specified benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Contributions

Contributions are reported on the financial statements on the accrual basis. Employer contributions are contributions made by employers on behalf of employees for months worked during the year. Contributions received in advance of the month worked or the month of coverage are reported as deferred contribution.

D. Employer Payroll Compliance Program

Employer remittance reports were accepted as submitted, without examination or verification of employers’ payroll records. The system of internal control provides for examination of employers’ records under an employer payroll compliance program.

E. Investments

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

E. Investments (Continued)

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Exchange Traded Funds, Mutual Funds, and Money Market Fund: The fair value is determined based on quoted prices in active markets on the valuation date (Level 1).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair values of investments were provided by the Plan's corporate trustee and investment manager. Dividends are recorded on the ex-dividend date. Interest income and investment expenses are recorded on the accrual basis. Purchases and sales of securities are recorded on the trade date basis. Realized gains or losses from the sale or redemption of investments and unrealized appreciation or depreciation in the fair value of investments is reported as net appreciation of investments.

F. Cash

Cash consists of cash deposited with financial institutions in a checking account.

G. Benefits

Benefits reported on statements of changes in net assets available for benefits are premiums for eligible participants paid during the year (Premiums Paid). Benefit obligations reported on statements of benefit obligations consists of premiums payable, which is an estimate of premiums for coverage during the year, unpaid at the end of the year. Statements of changes in benefit obligations reports the components of the changes in benefit obligations.

In case of retiree coverage, all of the benefit cost is covered by the retiree or the employer of the retiree. Therefore, there are no postretirement benefit obligations.

H. Other Income and Expenses

Other income and expenses are reported on the accrual basis, except for nominal amounts of recurring monthly expenses.

NOTE 3 - TAX-EXEMPT STATUS

The Plan is tax-exempt under Internal Revenue Code Section 501(c)(9) and from the state of California under Revenue and Taxation Code Section 23701i; therefore, no provision is made for federal or state income taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Contribution rates in effect during the years varied based upon amounts required to be contributed in accordance with collective bargaining agreements between participating unions and various employer groups.

E. Self Payment Under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA)

The Plan allows for continuation of coverage for eligible active participants as required under COBRA. Rates for COBRA continuation coverage are set by the Board of Trustees.

F. Administration

The Plan is administered by PacFed Benefit Administrators, Inc. The monthly administration fees per participant are as follows:

NOTE 6 - CONCENTRATION OF CREDIT RISK

The Plan maintains cash accounts at a financial institution, which exceeded the Federal Deposit Insurance Corporation limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan did not incur any losses on the uninsured balances. The uninsured balance at November 30, 2024 was \$5,511,370.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan has investments in securities that are exposed to various risks, such as interest rate, market fluctuation and credit risks. Due to the risk associated with investment securities and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect the amounts reported in the financial statements.

NOTE 8 - PLAN TERMINATION

Upon termination of the Plan, Plan assets shall be paid out by the Trustees, after payment of all liabilities of the Plan, in accordance with and in furtherance of the purpose of the Agreement and the Plan, at the sole discretion of the Board of Trustees, provided that no remaining assets of the Plan may be paid to any employer.

NOTE 9 - AMENDMENT

Amendment #1 to the Restated Trust Agreement was adopted in September 2024, and effective August 14, 2024. This amendment establishes term limits for Trustees selected to act as Chair of the Board and Secretary, respectively.

NOTE 10 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 6, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
