Independent Auditors' Report

G3 Enterprises, Inc. Retirement Plan Committee:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of G3 Enterprises, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of G3 Enterprises, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be

independent of G3 Enterprises, Inc. Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about G3 Enterprises, Inc. Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Notes to Financial Statements

Note 1. Plan Description

The following brief description of the G3 Enterprises, Inc. Retirement Plan (the Plan) is provided for general information purposes only. The Plan was formerly known as the G3 Enterprises, Inc. Profit Sharing Plan. Participants should refer to the summary plan description for more complete information.

General:

The Plan is a defined contribution plan that was established on January 1, 1983 for all employees of G3 Enterprises, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

The Plan permits participants to defer a percentage of their compensation into the Plan on a pre-tax or after-tax basis, pursuant to Section 401(k) of the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled unless they elect to not participate in Plan.

The Company provides for a matching contribution where applicable. In addition, where applicable, the Company makes annual profit sharing contributions or a nonelective contribution to the Plan based on participating employees' compensation (in each instance reduced by forfeitures of non-vested benefits), unless otherwise determined by its Board of Directors.

Contributions are funded currently.

Forfeited accounts:

At December 31, 2024 and 2023, the forfeited non-vested account totaled \$97,894 and \$41,133, respectively. Employer contributions receivable at December 31, 2024 and 2023 were reduced by \$97,894 and \$41,133, respectively, from forfeited non-vested accounts.

Participant accounts:

Each participant's account is credited with the participant's contributions and allocation of employer contributions, Plan earnings or losses, and Plan fees. Allocations of earnings are based on account balances as defined by the Plan. All amounts in participant accounts are participant directed; participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account. Accounts are valued daily. Distributions are based on the current day's valuation of account balances.

Notes to Financial Statements

Vesting:

Participants' salary deferrals, rollover contributions and earnings thereon are 100% vested and nonforfeitable. The vesting of employer contributions for non-union participants is as follows: (1) four-year graded vesting applies to the Company's profit sharing contributions; (2) matching contributions for these participants are immediately vested; and (3) three-year cliff vesting applies to the Company's matching contributions for hourly Chicago RDC employees.

Vesting associated with the employer contributions for union participants is dependent upon the collective bargaining agreement for the covered employee group.

Notes receivable, participants:

Participants can apply for up to two loans from the Plan. The total amount owed to the Plan by an individual participant cannot exceed the lesser of 50% of such participant's vested account balance or \$50,000, reduced by the highest outstanding balance of all loans during the preceding twelve months. The loans are secured by the balance in the participant's account and bear interest at the then current prime rate of interest plus 1%. Principal and interest is paid ratably through biweekly/semi-monthly deductions. The loans are held in the Master Trust Loan Fund (see Note 5).

Benefit payments:

Upon termination of service, early retirement, total and permanent disability or death, participants may elect to receive a distribution from the vested value of their account or leave the value of the account on deposit until minimum distributions are required to be made. Employees receive the value of their accumulated Plan benefits either as periodic payments, lump-sum or partial lump sum distributions. Participants immediately vest in Company contributions upon death, disability, retirement age or termination of the Plan. Hardship withdrawals are allowed from an employee's vested accounts. An employee can also withdraw from vested accounts upon reaching at least 59 ½ years of age.

Amounts allocated to accounts of persons who, at December 31, 2024, have elected to withdraw from the Plan but have not been paid are \$-0-.

Plan termination:

Although they have not expressed intent to do so, the Company has the right to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions. Payments of such amounts will be made to participants by the Trustees as directed by the Plan Committee.

Note 2. Significant Accounting Policies

The following is a summary of significant accounting policies applied in the preparation of these financial statements:

.

Notes to Financial Statements

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reporting amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

Notes receivable, participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of 2024 or 2023.

Benefit payments:

Benefits are recorded when paid.

Plan fees:

During the year ended December 31, 2024, certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Notes to Financial Statements

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB are described as follows: Level 1- inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access; Level 2 - inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means; Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement. There were no changes in the method used to measure fair value at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

Collective trusts: Represents a pool of capital invested in mutual funds and valued at the net asset value of the underlying mutual funds.

Stable value fund: Represents a pool of capital invested in investment contracts and security-backed contracts and valued at the net asset value of the underlying investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Party-in-Interest Transactions

For the years ended December 31, 2024 and 2023, certain Plan investments are shares of mutual funds managed by the Vanguard Fiduciary Trust Company, a subsidiary of the Vanguard Group, Inc., the Plan’s trustee. SEI Trust Company and Fidelity Investment manage separate funds for the Master Trust. Fees paid to the trustees amounted to \$131,763 for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

Note 7. Reconciliation of Financial Statements to Form 5500

Note 8. Tax Status

The Plan obtained its latest determination letter August 21, 2013, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC, and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 9. Subsequent Events

The Plan has evaluated events and transactions subsequent to December 31, 2024 through the date the financial statements were available to be issued, noting no significant items requiring further discussion.
