## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Miller Hull Partnership, LLP 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## Notes to Financial Statements

December 31, 2024 and 2023

---

### NOTE 1 – DESCRIPTION OF THE PLAN

The provisions of The Miller Hull Partnership, LLP (the Company) 401(k) Retirement Plan (the Plan) were effective January 1, 1995. The Plan has been amended and restated to comply with current legislation. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of the Company. Employees are eligible to participate in the Plan upon hire. The Plan contains arrangements for salary deferrals by the employees under section 401(k) of the Internal Revenue Code, employer safe-harbor contributions, and discretionary employer profit sharing contributions. To be eligible to receive discretionary profit sharing contributions, employees must be employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

#### Contributions

The Plan provides for automatic enrollment of participants. Newly eligible participants are enrolled in the Plan at a salary reduction rate of 5%, with a step-up rate of 1% each subsequent year, up to a maximum of 10%. Participants may elect to contribute up to 100% of their pre-tax or Roth after-tax compensation, as defined in the Plan document and within statutory limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may elect to change or stop the payroll deductions at any time. Participants may also contribute amounts representing distributions from other qualified plans.

The safe-harbor matching contribution is equal to 100% of salary deferrals up to 5% of compensation.

Participant and safe-harbor contributions are paid to the Plan after each pay period.

The Company may make a discretionary annual profit sharing contribution. No discretionary profit sharing contribution was authorized for the Plan years ended December 31, 2024 and 2023. The profit sharing contributions are allocated among participants based on eligible compensation as defined in the Plan document and are funded in the following Plan year.

## **NOTE 1 – DESCRIPTION OF THE PLAN (continued)**

### **Participant Accounts**

Individual participant accounts are maintained by the Plan's third party administrator. Each account is credited or charged with the participant's contributions, the Company's contributions, allocations of investment income and losses on the individual account balances, and administrative expenses. Distribution administration fees are deducted from the respective participant's account. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

### **Investment Options**

Participants direct employee and employer contributions among various mutual funds.

### **Vesting**

Participants are immediately vested in their own contributions and the safe-harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions is based on years of credited service, as defined in the Plan document, with 33.33% vesting each year, and 100% vesting after three years of service. Upon normal retirement (65), death or disability, participants become fully vested in all benefits.

### **Payment of Benefits**

Upon retirement, death, disability, or other termination of employment, a participant may elect to receive a lump-sum amount equal to the value of his or her vested account or installments over a period of time, as described in the Plan document. Upon attainment of age 59 ½, participants may request a partial distribution, payment stream option, or lump-sum distribution of their vested account balances prior to retirement. Under certain hardship circumstances, participants may request a lump-sum distribution of their vested contribution accounts, excluding Roth accounts.

### **Forfeited Accounts**

Upon termination, participants' non-vested account balances are forfeited. Forfeitures may be used to reduce employer contributions or pay Plan expenses. There were no forfeited non-vested accounts at December 31, 2024. Forfeited non-vested accounts totaled \$3,731 at December 31, 2023. During 2024, forfeitures of \$6,014 were used to pay Plan expenses.

### **Subsequent Events**

The Plan has evaluated subsequent events through July 21, 2025, the date the financial statements were available to be issued.

## **NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

The following are significant accounting policies used by the Plan:

### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for individual transactions such as distributions are deducted from the respective participant's account. Investment related expenses, and revenue sharing fees or credits, are included in net appreciation or depreciation in fair value of investments.

## **NOTE 3 – FAIR VALUE MEASUREMENTS**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### **NOTE 3 – FAIR VALUE MEASUREMENTS (continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan's investments consist solely of mutual funds which are valued as of December 31, 2024 and 2023 using level 1 measurements.

### **NOTE 4 – CERTIFIED INVESTMENTS**

Certain information related to investments that is disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (Schwab), the custodian of the Plan.

### **NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Schwab, the custodian. USI Consulting Group (USI) contracts with Schwab for custodial services. Therefore, transactions with Schwab and USI and their affiliates qualify as party-in-interest transactions. Fees are paid by the Plan to these parties for administrative services. Additionally, these affiliates collect revenue sharing from the Plan's investments to pay for administrative services.

### **NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their accounts.

### **NOTE 7 – TAX STATUS**

The Plan operates under provisions of a Pre-Approved Defined Contribution Plan which received an opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the Pre-Approved Plan, as then designed, was acceptable under the applicable sections of the Internal Revenue Code (IRC) for use by the employers for the benefit of their employees. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

**NOTE 7 – TAX STATUS (continued)**

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan allows participants to invest in investment securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with the investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
