To the Plan Administrator and Participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of M.R.A. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the M.R.A. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all eligible employees of Montclair Radiological Associates, P.A. (the “Company” or “M.R.A.”). Employees become eligible to participate on January 1st or July 1st coincident with or next following the later of the participant’s attainment of age 21 or after completion of one year of service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Trustees (“Trustees”) manage the operations and administration of the Plan.

Empower Trust Company, LLC (“ETC” or “Custodian”) serves as the custodian of the Plan investments. Empower Retirement, LLC (“Empower”) is the recordkeeper and certain investments are managed by Empower Annuity Insurance Company of America (“EAICA”).

Contributions – Employees who are eligible and elect to participate in the Plan may contribute through payroll deductions up to the legal maximum allowable amount as defined by the Internal Revenue Service (“IRS”). The Company makes safe harbor nonelective contributions (“Safe Harbor”), profit-sharing contributions, and may make additional discretionary contributions. For the year ended December 31, 2024, the Company made Safe Harbor contributions of 3% of the participant’s total compensation. Profit-sharing contributions are integrated based upon the social security wage base, therefore anyone who has income greater than the social security wage base is eligible for the higher percentage contribution. For the year ended December 31, 2024, the Company made profit-sharing contributions of 4.5% of the participant’s total compensation which were under the social security wage base. The Company made profit sharing contributions in the range of approximately 4.3% to 5.2% of the participant’s total compensation which were over the social security wage base. For the year ended December 31, 2024, employer Safe Harbor contributions and profit-sharing contributions were approximately \$120,184 and \$63,645, respectively. There were no additional discretionary contributions for the year ended December 31, 2024.

Participant Accounts – A separate account is maintained for each participant. Each participant’s account is credited with his or her contribution, the Company’s Safe Harbor contribution, profit-sharing contribution and an allocation of Plan earnings and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations of expenses are based upon the investment performance of the individual funds in which each participant’s account balance is invested. Allocations of expenses are based upon account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Participants may direct the investment of contributions into one or more formal investment options offered by the Plan. Participants may change their investment elections at any time through the Plan’s record-keeper.

Notes Receivable from Participants – Participants may borrow from their individual account balances in accordance with the Plan’s provisions. The maximum amount of any loan is the lesser of (a) \$50,000 or (b) one-half the value of the participant’s vested account but not less than \$1,000. Loans are collateralized by the participant’s vested account. All loans bear an interest rate as determined by the Plan administrator and must be repaid within five years unless used for the purchase of the participant’s principal residence. Principal and interest are paid ratably through biweekly payroll deductions. At December 31, 2024, notes receivable mature at various dates through March 2029 and have interest rates ranging from 9.25% to 9.50%.

Rollovers – Rollover contributions are permitted into the Plan in accordance with IRS regulations and Plan provisions.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN (continued)

Vesting – Plan participants are fully vested in their contributions, Company Safe Harbor contributions, and related account earnings or losses. Vesting of Company profit-sharing and additional discretionary contributions is based upon years of service. A participant is fully vested after six years of credited service.

Benefit Payments – Under the Plan, normal retirement age is 65. Upon termination of service due to death, disability, retirement or termination of employment, a participant shall receive a lump-sum amount equal to the value of the participant's vested account balance.

In the event a participant's employment is terminated, the participant's accumulated vested benefits will be distributed to the participant in accordance with the provisions of the Plan.

Forfeitures – Forfeited balances of terminated participants' nonvested accounts are utilized to reduce employer contributions and pay Plan expenses. At December 31, 2024 and 2023, unallocated forfeitures totaled \$81,230 and \$120,997, respectively. \$71,000 of forfeitures were utilized to reduce employer contributions during 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Valuation of Investments and Income Recognition – Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for descriptions of fair value measurements and fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest is recorded when earned. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Use of Estimates – The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included as administrative fees when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan document.

Payment of Benefits – Benefit payments to participants are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Expenses attributable to the administration or operation of the Plan are allocated pro rata on the basis of the account balances of all participants. Fees for the administration of notes receivable from participants are included in administrative fees and charged directly to the participant's account.

3. INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

The Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan's management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Custodian, except for comparing such information certified by the Custodian with information included in the Plan's financial statements and supplemental schedule of Form 5500, Schedule H, Part IV, Line 4i– Schedule of Assets (Held At End of Year).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

4. FAIR VALUE MEASUREMENTS (continued)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. These funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Valued at the NAV of units of a bank collective trust. NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

5. EMPOWER INVESTMENT FIXED ACCOUNT

The Plan invests in a fully benefit-responsive group annuity contract, the Empower Investments Fixed Account - Series I (“EIFA”), with EAICA. Because the EIFA is a general account product offered through the group annuity contract, principal and interest for participant-initiated benefit payments are fully guaranteed by the entire general account assets of EAICA. The EIFA credits interest daily to the group contract holder on a portfolio basis. The crediting interest rate may change or stay the same quarterly. The crediting interest rate was 1.41% and 1.23% and the contract value was \$86,758 and \$127,690 for the years ended December 31, 2024 and 2023, respectively. The guaranteed minimum interest rate is 0%. Contract value is the relevant measurement attribute for this fund. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfers of all or a portion of their investment at contract value.

Certain events may limit the Plan’s ability to transact at contract value with EAICA. Such events include the following (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Plan shall not offer competing funds unless mutually agreed with EAICA, in which case amounts withdrawn from EIFA must be transferred to a non-competing fund and remain there for at least ninety days before transferring to a competing fund. No events are probable of occurring that might limit the Plan’s ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

6. RISKS AND UNCERTAINTIES

The Plan invests in various securities including mutual funds, common collective trusts, and a fixed account. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants’ account balances and the amounts reported in the statement of net assets available for benefits.

7. FEDERAL INCOME TAX STATUS

The Plan’s management adopted a prototype non-standardized profit sharing and cash or deferred arrangement plan, which received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although, the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. PLAN TERMINATION

Although the Company has not expressed any intention to do so, the Company reserves the right to modify, suspend, amend or terminate the Plan in whole or in part at any time subject to the provisions of ERISA. If the Plan is terminated, the amounts credited to the employer contribution accounts of all participants become fully vested.

In October 2022, RadNet, Inc. (“RadNet”) acquired the assets of M.R.A. As a result of the acquisition, effective January 1, 2023, approximately 128 M.R.A. employees were terminated. As a result of a reduction of the Plan sponsor’s workforce, the Plan experienced a partial plan termination as defined by IRS Revenue Ruling 2007-43. Under the IRS rule, a partial plan termination occurs if 20% of the Plan’s participants are terminated due to the action taken by the Plan sponsor. If a partial plan termination occurs, full vesting in the employer’s contribution is required for the affected participants, but the remaining participants’ vesting continues to be determined per the Plan provisions.

All affected employees who were participants in the Plan were fully vested in their account balances at the date of their partial plan termination.

9. SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the Setting Every Community Up for Retirement Enhancement Act (“SECURE Act 2.0”). The SECURE Act 2.0 contains over ninety new retirement provisions, with varying effective dates through 2027. Since the SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Applicable provisions outlined in the SECURE Act 2.0 will be adopted if elected and/or required. The Plan administrator did not adopt any of the optional provisions for 2024 and accordingly, there was no material impact to the Plan’s 2024 financial statement.

10. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

A party-in-interest is defined under U.S. Department of Labor (“DOL”) regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As described in Note 2, certain fees are paid from the Plan’s assets and therefore qualify as party-in-interest transactions. Certain plan investments are managed by Empower (guaranteed interest contracts). Asset management fees and other administrative fees paid to Empower totaled \$46,231 and \$1,260, respectively. Loans to the participants are secured by balances in the respective participant accounts. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

11. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through August 19, 2025, the date which the financial statements were available to be issued. Based upon this evaluation, the Plan has determined that no subsequent events have occurred which would require disclosure in or adjustment to the financial statements.

12. RECONCILIATION TO FORM 5500

No material differences exist between the financial statements and Form 5500.
