The undersigned ("We") are providing this letter in connection with Forvis Mazars' audits of the financial statements of Capgemini Financial Services USA Inc. 401(k) Retirement Plan (the Plan) as of and for the years ended December 31, 2024 and 2023 and supplemental schedule as of December 31, 2024.

Our representations are current and effective as of the date of Forvis Mazars' report: September 8, 2025.

Our engagement with Forvis Mazars is based on our contract for services dated: June 25, 2025.

### **Our Responsibility & Consideration of Material Matters**

6. We acknowledge our responsibility for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the ERISA plan financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

7. The Plan and the trust established under the plan are qualified under the appropriate section of the Internal Revenue Code, and we intend to continue them as a qualified Plan and trust. We do not have any intention at present to terminate the Plan. Required nondiscrimination testing under the appropriate Code Sections has been completed for the Plan, and any excess contributions have been disposed of in accordance with regulations.
8. The Plan instrument has not been amended during the year.
9. The Plan operates under a non-standardized pre-approved profit sharing plan with CODA sponsored by FMR LLC. Further, the Plan Sponsor is solely responsible for all aspects of managing the Plan, including questioning the quality and valuation of investments.

16. We have informed you of all current risks of a material amount that are not adequately prevented or detected by our procedures with respect to:

  - b. Misrepresented or misstated assets or liabilities.
17. We have no knowledge of fraud or suspected fraud affecting the Plan involving:
  - a. Management or employees who have significant roles in internal control over financial reporting, or

- b. Others when the fraud could have a material effect on the financial statements.
18. We have no knowledge of any allegations of fraud or suspected fraud affecting the Plan received in communications from participants, former participants, regulators, third-party servicers or others.
19. We have assessed the risk that the financial statements may be materially misstated as a result of fraud and disclosed to you any such risk identified.

***Related Parties & Parties-in-Interest***

20. We have disclosed to you the identity of all of the Plan's related parties and parties-in-interest and all the related-party and party-in-interest relationships of which we are aware.

41. Financial instruments with off-balance sheet risk and financial instruments with concentrations of credit risk have been properly recorded or disclosed in the financial statements.



## **Note 1. Description of Plan**

The following description of the Capgemini Financial Services USA, Inc. 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering all full-time employees of Capgemini Financial Services USA, Inc. (Company). Employees who are nonresident aliens and who receive no earned income from the Company, which constitutes income from services within the United States, are not eligible to participate. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

### **Contributions**

Each year, participants may contribute up to 90% of pre-tax annual compensation, as defined in the Plan, subject to certain Internal Revenue Code (IRC) limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan provides for annual Company matching and/or profit-sharing contributions at the discretion of the Company's Board of Directors.

Effective January 1, 2017, the Plan adopted 401(k) safe harbor matching contributions. In 2024 and 2023, the Company made safe harbor matching contributions of 100% of the first 3% of the eligible participant's compensation contributed to the Plan and 50% of the next 2% of the eligible participant's compensation contributed to the Plan.

Effective June 1, 2017, the Plan adopted additional eligibility requirements for safe harbor matching contributions. Participants become eligible for safe harbor matching contributions after completing 1,000 hours or one year of service.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants immediately are vested in their contributions plus actual earnings thereon. Effective June 1, 2017, participants are immediately 100% vested in the annual Company matching and/or profit sharing as well as the safe harbor matching contributions. Prior to June 1, 2017, vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 100% vested after three years of credited service. Full vesting also occurs upon death, disability or retirement at designated ages.

### **Notes Receivable From Participants**

Participants may borrow from their funds accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a range of 4.00% to 10.25% at December 31, 2024, which is commensurate with local prevailing rates at the time of the loans.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, the entire balance in the participant's account will be payable to the participant, or their beneficiary, in either payment in the form of a joint and survivor annuity if married, or in the form of a life annuity if unmarried, payment in a lump sum, or payments in equal monthly, quarterly, semi-annual or annual installments over a period not to exceed the participant's life expectancy.

For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. When the participant's vested interests are less than \$5,000, the plan administrator may distribute such benefit in a lump sum without the participant's consent.

***Revenue Sharing***

Fidelity Management Trust Company (Fidelity) receives revenue from registered investment companies and common or collective trust fund service providers for services Fidelity provides to the funds. If the revenue received by Fidelity from such service providers exceeds the amount owed under the agreement, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts are used to reduce plan administrative expenses or allocated to the accounts of the participants. Revenue credits were \$118,308 and \$119,007 for the years ended December 31, 2024 and 2023, respectively. The Plan has revenue credits of \$105,933 and \$75,679 available as of December 31, 2024 and 2023, respectively.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,646 and \$250, respectively. Those accounts will normally be applied first to reduce the Company matching and/or profit-sharing contributions and any excess is applied to the payment of the Plan's administrative expenses. During 2024 and 2023, forfeitures of \$16,734 and \$64,342, respectively, were used to reduce Company contributions and administrative expenses.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. The Plan's investments in registered investment companies and common and preferred stocks are valued at quoted market prices. The fair value of money market accounts is carried at cost which approximates fair value. The fair value of other investments, corporate debt instruments and U.S. government securities held in the brokerage link account is supported by quoted prices in markets that are not active or other inputs that are observable and can be corroborated by observable market data.

The common or collective trust funds are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. There are no participant redemption restrictions for these investment and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Administrative Expenses***

Certain expenses of the Plan are paid by the Company. The Plan pays certain administrative expenses and transaction costs related to investment fees. Certain investment fees are expensed as incurred and certain investment fees are included in the net appreciation in fair value of investments. Administrative expenses paid by the Plan are expensed as incurred.

***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

**Note 3. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable input and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The fair value of money market accounts is carried at cost, which approximates fair value (Level 1 inputs).

The fair value of common and preferred stocks is supported by quoted prices in active markets (Level 1 inputs).

The fair value of other investments, corporate debt instruments and U.S. government securities held in the brokerage link account is supported by quoted prices in markets that are not active or other inputs that are observable and can be corroborated by observable market data. (Level 2)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 4. Party-in-Interest Transactions**

Certain plan investments are managed by Fidelity Management Trust Company, the trustee of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. During 2024 and 2023, the Plan made direct payments for administrative expenses of \$255,816 and \$385,488, respectively, before the use of revenue-sharing amounts of \$92,071 and \$124,934, respectively. The Company provides certain administrative services at no cost to the Plan.

#### **Note 5. Tax Status**

The Plan operates under a non-standardized pre-approved profit sharing plan with CODA sponsored by FMR LLC. This non-standardized plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter dated June 30, 2020, from the Internal Revenue Service stating that the non-standardized plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6. Information Certified by the Plan's Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income from notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

**Note 7. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
