INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ocean House Builders 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 1, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits for the period January 1, 2024 to October 1, 2024 and for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ocean House Builders 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of October 1, 2024 and December 31, 2023 and for the period January 1, 2024 to October 1, 2024 and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by a qualified institution agrees to, or is derived from, in all material respect, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Ocean House Builders 401(k) Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note G to the financial statements, effective October 1, 2024, the plan sponsor adopted the Aon Pooled Employer Plan (Aon PEP), and the Plan merged into the Aon PEP. Plan assets were transferred from Empower Annuity Insurance Company of America to the trustee for the Aon PEP, Voya Institutional Trust Company. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Ocean House Builders 401(k) Retirement Savings Plan's ability to continue as a going concern within one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Ocean House Builders 401(k) Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Ocean House Builders 401(k) Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A - DESCRIPTION OF PLAN

The following description of the Ocean House Builders 401(k) Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- (1) **General** - The Plan is a defined contribution plan covering all permanent employees of Nan Inc. (Company) who meet the eligibility criteria specified in the Plan documents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (2) **Participation** - Employees are eligible to make elective deferrals on the first day of the calendar quarter following the day on which they complete the earlier of three consecutive months of service, if they are regularly employed at the rate of at least 20 hours per week or one year of service with 1,000 hours of service during the twelve month period.

Employees are eligible for matching contributions and profit sharing contributions if they complete a year of service during the Plan year and are still employed by the Company on the last day of the Plan year.

- (3) **Contributions** - Participants may elect to defer compensation and are limited to the lesser of 100% of the participant's pretax annual compensation earned during the Plan year or amounts limited by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

At the discretion of the Company's board of directors, the Company may contribute a discretionary matching contribution to the Plan equal to a specified percentage of the participant's contribution. No discretionary matching contributions were made by the Company during the period January 1, 2024 to October 1, 2024 and the year ended December 31, 2023. In addition, the Company may contribute a discretionary profit sharing contribution amount to the Plan as determined by the Company. No profit sharing contribution was made for the period January 1, 2024 to October 1, 2024. The Company approved profit sharing contributions amounting to \$2,708,065 for year ended December 31, 2023.

Participants direct the investment of their contributions and Company discretionary contributions into various investment options offered by the Plan.

- (4) **Participant accounts** - Each participant's account is credited with the participant's contribution and an allocation of the Company's discretionary contributions. The balance of the participant's account is adjusted for earnings, gains, and losses attributable to investment of the account balances. Each participant's account is charged with expenses related to the participant's investment choices and an allocation of Plan administrative expenses, if applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- (5) **Vesting** - Participants are immediately vested in their voluntary contributions, rollover contributions, and Davis-Bacon contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions, plus actual earnings thereon, is based on years of service. A participant's matching account and discretionary profit sharing account is 100% vested after six years of credited service.

- (6) **Notes receivable from participants** - Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance or a minimum of \$1,000 reduced by the highest outstanding loan balance of the borrower during the preceding 12 months. The loans are secured by the vested balance in the participant's account balance and bear interest at prevailing local rates as determined by the Plan's administrative committee. Principal and interest are paid ratably through weekly payroll deductions.
- (7) **Payment of benefits** - Upon termination of service, a participant or the participant's beneficiary, will receive a lump-sum distribution or installment payments over a specified period of time equal to the value of his or her vested account balance if the individual's total vested account balance has not exceeded \$1,000. Vested benefits greater than \$1,000 will be paid in the form of a qualified joint and survivor annuity unless the participant makes a valid waiver election. By making a valid waiver election, the participant may choose an optional form which includes a lump-sum payment, or a rollover distribution to an eligible retirement plan. In addition, hardship distributions are permitted if certain criteria are met.
- (8) **Forfeited accounts** - Forfeited non-vested accounts will be used to restore forfeiture accounts, to pay Plan administrative expenses, and/or to reduce the Company's discretionary matching and/or profit sharing contribution. At December 31, 2023, forfeited non-vested accounts amounted to \$94,528, respectively. During the period January 1, 2024 to October 1, 2024 and the year ended December 31, 2023, forfeitures of \$151,292 and \$70,103, respectively, were used to reduce the Company's discretionary profit sharing contribution.
- (9) **Plan termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the ERISA. In the event the Plan terminates, participants would become 100% vested in their employer contributions.

NOTE B - SIGNIFICANT ACCOUNTING POLICIES

- (1) **Basis of accounting** - The financial statements of the Plan have been prepared on the accrual basis of accounting consistent with accounting principles generally accepted in the United States of America (U.S. GAAP).
- (2) **Use of estimates** - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- (3) **Investment valuation and income recognition** - Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gain and losses on investments purchased and sold as well as those held during the year.

- (4) **Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan agreement.
- (5) **Payment of benefits** - Benefits are recorded when paid.
- (6) **Administrative expenses** - Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements.
- (7) **Subsequent events** - Management has evaluated subsequent events through September 10, 2025, the date on which the financial statements were available to be issued. There were no subsequent events that required adjustment of or disclosure in the financial statements.

NOTE C - CERTIFIED INVESTMENTS

Certain information in the accompanying financial statements related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at October 1, 2024 and December 31, 2023, and net appreciation in fair value of investments, dividends, interest, and interest income on notes receivable from participants for the period January 1, 2024 to October 1, 2024 and the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America (Empower), as agent for Talcott Resolution Life Insurance Company (TRLIC).

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 1, 2024 and December 31, 2023.

Pooled separate accounts: These investments are valued using the net asset value ("NAV") of units held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that TRLIC will sell the investments for amounts different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

Pooled separate accounts held by the Plan totaled \$-0- and \$39,927,839 at October 1, 2024 and December 31, 2023, respectively. Pooled separate accounts represent investments at fair value as presented on the accompanying statements of net assets available for benefits.

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient at December 31, 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with TRLIC totaling \$0- and \$4,074,819 as of October 1, 2024 and December 31, 2023, respectively. TRLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The crediting rate as of October 1, 2024 and December 31, 2023 was 3%.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TRLIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Because of the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G - PLAN MERGER AND TRANSFER

Effective October 1, 2024, the Company adopted the Aon Pooled Employer Plan (Aon PEP), and the Plan merged into the Aon PEP. Plan assets were transferred from Empower to the trustee for the Aon PEP, Voya Institutional Trust Company. Upon adopting the Aon PEP, the Company became a participating employer while Grace Pacific LLC and G.P. Roadway became participating related employers.

NOTE H - TAX STATUS

Effective January 1, 2022, the Company adopted a Cades Schutte 401(k) Non-Standardized Pre-Approved Profit Sharing Plan. Cades Schutte received an opinion letter from the Internal Revenue Service dated June 30, 2020, specifying the form of the basic plan document is acceptable, as of the date of the opinion letter, for use by employers for the benefit of their employees under IRC Section 401. Once qualified, the Plan is required to operate in accordance with the IRC to maintain its qualification. The Plan sponsor has indicated that it will take the necessary steps, if any, to maintain the Plan's qualified tax status.

NOTE I - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments represent shares of pooled separate accounts managed by Empower. Empower is a current service provider of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid to Empower amounted to \$145,555 and \$117,633 for the period January 1, 2024 to October 1, 2024 and the year ended December 31, 2023, respectively.
