INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Verrex 401(k) Savings/Retirement Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules ("DOL") and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of the Plan:

The following brief description of the Verrex 401(k) Savings/Retirement Plan & Trust (the “Plan”) is for general information only. Participants should refer to the Plan Document for more complete information of the Plan’s provisions.

General - The Plan was established on January 1, 1990 and amended and restated on February 1, 2010. The Plan is a defined contribution plan that covers substantially all employees of Verrex LLC (the “Company” or the “Plan Sponsor”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration - The Plan is administered by the Plan Sponsor. The Plan’s assets are held by Reliance Trust Company (the “Custodian”), who is responsible for the custody and management of the Plan’s assets.

Eligibility - Employees of the Company are eligible to participate in the Plan, and receive employer discretionary matching contributions, after completing three months of service and upon the attainment of 21 years of age. Union employees whose employment is governed by a collective bargaining agreement, nonresident aliens, and leased employees are not eligible to participate in the Plan.

Contributions - The Plan provides each participant with an opportunity to make elective salary deferral contributions to the Plan, up to 90% of compensation, on a pre-tax or Roth basis, subject to the limitations of the Internal Revenue Code. The Company, at its discretion, may make matching contributions equal to a percentage of the participant’s elective deferrals. Effective July 12, 2024, the employer discretionary match was reinstated after being suspended since September 2022. The employer will match 10% of employee contributions per pay period.

The Plan includes an automatic salary deferral feature in which employees will automatically be enrolled upon completion of the Plan’s eligibility requirements, unless otherwise elected. Participants automatically enrolled in the Plan will have deemed to have elected a pre-tax contribution of 3% of their eligible compensation. Automatic deferral amounts will increase by 1% of compensation to a maximum of 6% of compensation on the one-year anniversary of the participants’ automatic enrollment into the Plan.

Participant Accounts - Each participant’s account is credited with their contributions, employer discretionary matching contributions and Plan earnings, thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their elective deferrals, rollover contributions and actual earnings thereon. Participants vest 25% in the discretionary matching contributions after one year of service, and will vest an additional 25% per year until fully vested after completing four years of service.

Forfeitures - The portion of a participant’s account balance, which is not vested upon termination of employment, is forfeited and remains in the Plan. Forfeitures may be used to pay plan administrative expenses for the plan year in which forfeitures are to be allocated, or to reduce the Company’s discretionary matching contributions. As of December 31, 2024 and 2023, the Plan’s forfeiture account balance was \$40,104 and \$13,019, respectively. During 2024, \$9,707 of forfeitures were used to reduce the Company’s discretionary matching contributions.

NOTES TO FINANCIAL STATEMENTS

Payment of Benefits - A participant's vested interest in their account balance is distributable generally upon termination, disability, retirement or death. Participants may withdraw from their individual accounts pursuant to specific guidelines as set forth in the Plan. In addition, the Plan provides for participant withdrawals in the event of serious financial hardship as defined by the Plan.

Note 2 - Summary of Significant Accounting Policies:

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

Risks and Uncertainties - Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan may invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

Concentration of Investment Risk - The Plan's investment in two funds comprised approximately 35% and 32% of total investments at December 31, 2024 and 2023, respectively.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to disbursements to participants, investment advisory and loan origination fees are paid by each participant and are included in administrative expenses. In addition, certain investment related expenses are included in the net appreciation of investments.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Hardship Withdrawals - The Plan provides for hardship withdrawals from participants' vested balances, not to exceed an amount required to meet an immediate need created by hardship, and then only to the extent that such immediate need cannot be satisfied by other sources reasonably available to the participant. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, and such other circumstances as the Plan Administrator may determine in accordance with Internal Revenue Service rules and regulations.

Payment of Benefits - Benefits are recorded when paid.

Notes Receivable from Participants - Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan deems the participant loan in default, the participant loan balance is reduced and a benefit payment is recorded.

Subsequent Events - The Plan Administrator has reviewed and evaluated all events and transactions from December 31, 2024 through August 28, 2025, the date the financial statements were available to be issued. The effects of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

Note 3 - Certified Investment Information:

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Custodian, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information included in the Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024, as shown on the ERISA-required supplemental schedule of assets (held at end of year).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

Note 4 - Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements FASB ASC 820, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for asset measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Common collective trust* - Valued at net asset value per share/unit on the valuation date as reported in the audited financial statements. The underlying assets of the trust are normally valued based on their closing sales price or, in the absence of sales, at their reported bid price.
- *Mutual funds* - Valued at the closing price in the active market in which the fund is traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023 there were no significant transfers in or out of Levels 1, 2 or 3.

Note 5 - Party-in-Interest Transactions:

The Custodian of the Plan manages certain Plan investments, therefore, these transactions qualify as party-in-interest transactions. The fees paid by the Plan to the Custodian for the year ended December 31, 2024 were \$2,654.

The Plan also utilizes the services of a third-party investment advisor. Fees paid by the Plan to the investment advisor for investment advisory services totaled \$29,282 for the year ended December 31, 2024.

Note 6 - Notes Receivable from Participants:

During employment, a participant may withdraw amounts applicable to employee contributions and income thereon, subject to certain restrictions. Furthermore, participants may borrow up to three loans against their account in an amount not to exceed \$50,000 or 50% of the participants vested balance and no less than \$1,000 of the participant's vested portion in their account. Loans are generally repaid through payroll deductions within five years and bear interest at a rate commensurate with prime rate plus 1% as of the date of the loan. Loan principal and interest payments are credited to the elective deferral account of the participant to whom the loan was granted and are invested in accordance with the participant's current investment election.

NOTES TO FINANCIAL STATEMENTS

Note 7 - Tax Status:

The Plan was written on an Internal Revenue Service (IRS) non-standardized pre-approved document, which obtained its latest opinion letter on October 6, 2020, in which the IRS stated that the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 8 - Plan Termination:

Although it has not expressed any intent to do so, the Company reserves the right to amend, alter or terminate the Plan subject to the provisions of the Employment Retirement Income Security Act of 1974 (“ERISA”). In the event of plan termination, participants would become fully vested in their individual accounts.

Note 9 - Common Collective Trust:

The Plan invests in investment contracts through its common collective trust (the “CCT”). The CCT’s fair value is a relevant measurement attribute. The CCT held by the Plan is a stable value investment which has an objective to preserve capital and to provide a competitive level of income over time that is consistent with the preservation of capital. To achieve this objective the fund invests primarily in synthetic guaranteed investment contracts and cash equivalents. Redemptions are allowed for participants daily, however in the event of a complete redemption the Plan is subject to a 24-month redemption notice period, which may be waived by the Custodian. There are no unfunded commitments.
