Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of E.W. Grobbel Sons, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE A - Description of the Plan

The following description of the E.W. Grobbel Sons, Inc. 401(k) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The E.W. Grobbel Sons, Inc. 401(k) Profit Sharing Plan (the Plan) was formed January 1, 1995 and is a defined contribution profit sharing and 401(k) plan covering employees of E.W. Grobbel Sons, Inc. The Plan assets, together with the income thereon, are administered by the Plan administrator, E.W. Grobbel Sons, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Essentially all full-time employees not subject to a collective bargaining agreement who have reached age 21 and have completed one year of eligibility service are eligible to participate.

Contributions

Employee Elective Deferrals - Participants who have met the eligibility requirements of the Plan may elect to defer their annual compensation up to the maximum amount allowed under the law. Federal law requires that amounts contributed on the participant's behalf for a given year may not exceed the lesser of \$69,000 (\$76,500 for participants age 50 and over) or one hundred per cent of the participant's annual compensation. Federal law further limits the annual total compensation which may be deferred from salary during 2024 to \$23,000 for participants under the age of 50 and \$30,500 for participants age 50 and above. Under the Plan, elective deferrals may not exceed eighty-six per cent of participant's compensation.

Employer's Non-Elective Contributions - The Plan Sponsor may make a non-elective contribution under provisions of the Plan for eligible employees. The employer did not make a non-elective contribution for the year ended December 31, 2024.

Employer's Safe Harbor Contributions - The Plan Sponsor will make a safe harbor match contribution equal to one hundred per cent of salary deferrals up to the first three per cent of Plan compensation plus fifty per cent of salary deferrals up to the next two per cent of Plan compensation. The contribution for the year ended December 31, 2024, amounted to \$375,756.

Investments

The Plan is entirely participant directed. All contributions made on the participant's behalf are invested in one of several registered investment companies or one of several common/collective trust accounts held by trustee Reliance Trust Company, at the participant's direction. Registered investment companies or common/collective trust account options are selected by the Trustee. Participants may change investment allocations daily.

Vesting

Employee elective contributions and employee rollover contributions are immediately fully vested.

Employer non-elective contributions are immediately fully vested.

Employer safe harbor match contributions are immediately fully vested.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Plan Sponsor's contributions, Plan earnings (losses), allocated administrative expenses and forfeitures. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that may be provided from the participant's account.

Upon termination of employment, a participant or the participant's designated beneficiary may receive a lump sum payment or an annuity payment equal to the value of his or her account after applying the appropriate vesting percentage.

Forfeitures

The allocation of forfeitures, if any, is based on the same criteria used to allocate employer non-elective contributions. Forfeitures held by the Plan as of December 31, 2024 and 2023 were \$671 and \$657, respectively. No forfeitures were reallocated during the year ended December 31, 2024.

Termination and Amendment of the Plan

Although it has not expressed any intent to do so, the Plan may be terminated or amended at the discretion of the Plan Sponsor. In the event of termination, any unvested participants' accounts would become 100% vested. The Plan was amended and restated July 26, 2022, effective July 31, 2022. The amendment and restatement had no significant effect on benefits or net assets available for benefits.

Administrative Fees

Certain administrative costs of the Plan and the Plan audit fee are paid by the Plan Sponsor at the Plan Sponsor's discretion. Certain account fees are charged to the individual participant's accounts as incurred.

NOTE B - Summary of Significant Accounting Policies

Basis of Accounting

The Plan is managed in accordance with the E. W. Grobbel Sons, Inc. 401(k) Profit Sharing Plan dated January 1, 1995, as amended. The accounting records are maintained on the accrual basis.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan trustee, Reliance Trust Company, establishes values for Plan assets in common/collective trust accounts and utilizes quoted market prices for registered investment companies shares. See Note C for discussion of fair value measurements.

The accounts increase or decrease with actual earnings or losses and decrease from Plan withdrawals or administrative expenses.

Tax Status

The Plan has adopted a prototype plan. The prototype plan has received a determination from the Internal Revenue Service that the prototype plan as designed met the requirements of certain portions of the Internal Revenue Code. Accordingly, no provision for income taxes has been made at December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

NOTE C - Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of registered investment companies (mutual funds) is based on quoted net asset values of the shares as reported by the fund. 1. Common/collective trust accounts (CCT) invest in a variety of mutual funds. The fair value of the common/collective trust is not publicly quoted pricing units. The fair value of mutual funds are publicly quoted pricing inputs. The fair value of all these investments are used in determining the net asset value (NAV) of the CCT, which is not publicly quoted. ASC 820 allows NAV per share to serve as a practical expedient to estimate the fair value of a CCT.
2. The stable value common/collective trust net asset value (NAV) is based upon the contract value as the fund is primarily composed of fully benefit-responsive investment contracts. This is because contract value is the amount the participant would receive if they were to initiate permitted transactions under the terms of the underlying Plan. ASC 820 allows NAV per share to serve as a practical expedient to estimate fair value of this common/collective trust.

NOTE D - Risks and Uncertainties

The Plan invests in various registered investment companies and common/collective trust accounts with underlying investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE E - Subsequent Events

Management has evaluated subsequent events through August 20, 2025, the date which the financial statements were available for issue. Management has determined that no material subsequent events are required to be disclosed.

NOTE F - Tax Status

The Internal Revenue Service has determined the Prototype Plan document and related trust utilized by the Plan are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations prior to 2021.

NOTE G - Information Certified by Trustee

The trustee of the Plan, Reliance Trust Company, holds the Plan's investment assets and executes all investment transactions. The related financial information included in the accompanying financial statements and supplemental schedules have been certified by the trustee as complete and accurate.

NOTE H - Related Party and Party-In-Interest Transactions

All Plan investments held in registered investment companies and common/collective trusts have indirect compensation paid to them on a formula basis as disclosed on Form 5500 Schedule C for 2024 and 2023. These transactions qualify as party-in-interest transactions.

ADP Retirement Services, third party administrator, is a record keeper for the Plan and qualifies as a party-in-interest. Direct compensation paid as disclosed on Form 5500, Schedule C for 2024 and 2023 were \$1,885 and \$1,357, respectively.

The Plan sponsor pays the Plan audit fees, as necessary. This qualifies as a party-in-interest transaction. The amounts paid for the fees during the years ended December 31, 2024 and 2023 were \$16,125 and \$15,085, respectively.

These party-in-interest transactions are exempt from prohibited transaction rules of ERISA.
