As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

*Opinion*

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1 - Description of Plan

The following description of the LAZ Karp Associates, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution retirement plan covering full-time employees of LAZ Karp Associates, LLC and its participating employers (collectively referred to as the "Company") who have completed one year of service with a minimum of 1,000 hours and are at least 21 years of age. Collective bargaining (union) employees, as defined, are excluded from participation in the Plan. Eligible employees can enter the Plan on the first day of the month after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors is responsible for oversight of the Plan. The Fund Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors.

##### **Contributions**

Each year, participants may contribute from 1% to 75% of pre-tax annual compensation, as defined in the Plan. Participants may designate all or a portion of their contributions as Roth salary deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes matching contributions to the Plan equal to 50% of elective deferrals, up to a maximum contribution equal to 2.5% of eligible compensation, as defined by the Plan. The Company may also make discretionary nonelective contributions to the Plan. Discretionary nonelective contributions are allocated in the ratio that each eligible participant's compensation bears to the total compensation for all eligible participants for the Plan year. No discretionary nonelective contributions were declared by the Company for the year ended December 31, 2024. Participants also direct the investment of Company contributions. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

##### **Participant accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as an allocation of any Company discretionary nonelective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. In the event of termination due to death, total and permanent disability or normal retirement, participants shall become 100% vested in the Company contribution portion of their account. For all other participants, vesting in the Company contribution portion of their account is based on credited years of service, as defined in the Plan, according to the following schedule:

#### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the excess of the participant's highest outstanding loan balance during the 12-month period ending on the date of the loan, over the participant's current outstanding loan balance on the date of the loan. The loans are secured by the vested balance in the participant's account. The loan interest rate is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

#### Payment of benefits

On termination of service for any reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in installments over a period of not more than the participant's or beneficiary's assumed life expectancies. Participants with account balances less than \$1,000 will receive the vested interest in their account as a lump-sum distribution. Participants with a vested account balance of \$1,000 or more but less than \$7,000 who do not receive a distribution from the Plan will have their account balances rolled over into an Individual Retirement Account as allowed by the Plan. Participants with a vested account balance greater than \$7,000 may defer payment of benefits until a later date, unless a minimum distribution is required.

Withdrawals from a participant's salary deferral account may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Participants who have become disabled or have attained age 59½ are eligible to make in-service withdrawals, in accordance with the provisions of the Plan.

#### Forfeited accounts

At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$56,467 and \$40,929, respectively. These amounts are used to reduce future Company contributions. In 2024, forfeitures of \$248,257 were used to reduce Company contributions.

#### Note 2 - Summary of accounting policies

##### Basis of presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Investment valuation and income recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Fund Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Contributions**

Contributions from Plan participants and the matching contributions and discretionary nonelective contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Excess contributions payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025. The Plan also distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Participant accounts are also charged with an asset-based fee for recordkeeping and certain investment advisory services. Other investment related expenses are included in the net appreciation in fair value of investments.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Subsequent events**

The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Note 4 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

#### Note 5 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### Note 6 - Tax status

The prototype plan document, for which the Plan has adopted a nonstandardized adoption agreement, obtained its latest opinion on October 6, 2020, in which the IRS stated that the prototype plan as then designed was in accordance with sections of the IRC. The Plan has not obtained an individual determination letter. The Plan's adoption agreement has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7 - Related party transactions and party-in-interest transactions

Reliance Trust Company is the trustee as defined by the Plan and, therefore, a party-in-interest. ADP Retirement Services is the record-keeper of the Plan and is also a party-in-interest. Fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. Total administrative fees paid directly by the Plan to parties-in-interest were \$216,730 for the year ended December 31, 2024. The Plan sponsor pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

The Plan has entered into a revenue sharing arrangement with Reliance Trust Company. The revenue credit account is treated as a Plan asset and must be used only for legitimate Plan expenses. The balance in the account totaled \$69 and \$56 at December 31, 2024 and 2023, respectively. Unused amounts for expenses may be allocated to participant accounts. Reliance Trust Company contributed \$52,888 into the revenue credit account for the year ended December 31, 2024, which is included in other income in the accompanying financial statements. During 2024, \$52,888 was utilized from this account to pay Plan expenses.

#### Note 8 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
