Scope and Nature of the ERISA Section 103(a)(3)(C) Audits of the Financial Statements

We have performed audits of the financial statements of Hart Hotels, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and December 31, 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of the Hart Hotels, Inc. 401(k) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of the Plan

The following description of Hart Hotels, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for more complete descriptions of the Plan's provisions.

General

The Plan is a defined contribution plan covering the employees of Hart Hotels, Inc. and related companies (the Companies). The Plan is subject to the provisions of ERISA.

The Plan Sponsor is Hart Hotels, Inc. (Plan Sponsor). The 401(k) Plan Advisory Committee is responsible for the oversight of the Plan and determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Eligibility

As of July 1, 2024, employees who are age 18 are eligible to participate upon completing 500 hours of service within a year, as defined, excluding employees covered by a collective bargaining agreement which does not expressly provide for participation in the Plan. Prior to July 1, 2024, employees who were age 21 were eligible to participate upon completing 1,000 hours of service within a year.

Contributions

Each year, participants may contribute up to 25 percent of pretax annual compensation, as defined in the Plan, and elect to defer up to 90 percent of bonus compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation. Participants' automatic deferral rates are automatically increased by 1 percent each year, up to a maximum of 6 percent, unless they opt to contribute a different percentage.

At its discretion, the Companies may contribute an amount to each participant's account based on a percentage of the participant's contributions into the Plan. For the years ended December 31, 2024 and December 31, 2023, the Companies matched 50 percent of the first 1 percent of compensation contributed by the participant and 20 percent of the remaining compensation contributed by the participant, up to 3 percent of a participant's eligible compensation, as defined.

Contributions are subject to certain limitations of the Internal Revenue Code. Participants direct the investment of contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, Plan Sponsor contributions, and earnings as allocated. The account is reduced by the payment of benefits and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The Companies' contributions become 20 percent vested after two years of credited service, as defined, with vesting increasing at 20 percent increments each year thereafter to 100 percent after six years of credited service.

1. Description of the Plan (Continued)

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus one percent on the date the loan is taken out (at December 31, 2024, the prime rate was 7.50 percent). A participant may not have more than two loans outstanding at any given time. Loan terms may not exceed five years unless the purpose of the loan is to acquire the participant's principal residence, in which case a longer loan term may be granted. Principal and interest are generally paid bi-weekly through payroll deductions.

Benefit Payments

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a distribution of the participant's vested interest in the participant's account in the form of a lump-sum payment, partial payments, installment payments, or purchase of an annuity contract. For termination of service for other reasons, a participant with a vested account balance up to \$1,000 may receive the value of the vested interest in his or her account as a lump-sum distribution or roll over distribution into another qualified plan. For a participant with a vested account balance that exceeds \$1,000 but does not exceed \$5,000, the Plan Sponsor may instruct that the participant's balance be distributed as a lump-sum payment to an individual retirement account through Merrill Lynch if the participant does not make an affirmative election to either receive or roll over the distribution. Benefits are provided for normal retirement at an attained age of 65 or may be deferred if the participant continues in active service with the Plan Sponsor. The Plan also permits in-service withdrawals for participants who have attained age 59 ½ and specific hardship.

Forfeitures

Forfeited non-vested accounts are used to pay administrative expenses of the Plan or to reduce future employer contributions. At December 31, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$15,999 and \$16,568, respectively. During the years ended December 31, 2024 and December 31, 2023, plan sponsor contributions were reduced from forfeited non-vested accounts in the amount of \$13,740 and \$11,666, respectively. During the years ended December 31, 2024 and December 31, 2023, plan sponsor expenses were reduced from forfeited non-vested accounts in the amount of \$9,500 and \$-0-, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's policy is to prepare its financial statements on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Contributions and Contributions Receivable

Contributions from Plan participants and the related employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

2. Summary of Significant Accounting Policies (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and December 31, 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan is required to distribute the excess contributions by March 15th of the following year.

Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are stated at fair value, as certified by the custodian, Reliance Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan may be paid directly by the Companies and are excluded from these financial statements. Expenses may also be charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation/depreciation in fair value of the investments.

Subsequent Events

The Plan has evaluated subsequent events through September 4, 2025, which is the date the financial statements were made available to be issued.

3. Fair Value Measurement

Fair value is the price at which an asset could be exchanged in a current transaction between knowledgeable, willing parties. Fair value measurements are categorized into one of three levels based on the lowest level of significant input used: Level 1 (unadjusted quoted prices in active markets); Level 2 (observable market inputs available at the measurement date, other than quoted prices included in Level 1); and Level 3 (unobservable inputs that cannot be corroborated by observable market data).

3. Fair Value Measurement (Continued)

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There have been no changes in the methodology used at December 31, 2024 and December 31, 2023.

The preceding method described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table presents information about the investments measured at fair value on a recurring basis as of December 31, 2024 and December 31, 2023, and indicates the fair value hierarchy of the valuation techniques utilized to determine such fair value:

5. Party-in-Interest Transactions

Certain plan investments are managed by Reliance Trust Company, who is the custodian and record keeper for the Plan. In Addition, the Plan uses other service providers for investment advisory, contract administration services and assurance services. Transactions with these parties qualify as party-in-interest transactions. Fees paid by the Plan for administrative and professional services amounted to \$47,437 and \$22,512 for the years ended December 31, 2024 and December 31, 2023, respectively. Fees paid by the Plan for other investment management services are included in the net appreciation in fair value of the investments as they are paid through revenue share rather than a direct payment. The Plan Sponsor pays directly any other expenses related to the Plan’s operations.

Notes receivable from participants qualify as exempt party-in-interest transactions as defined by ERISA. Interest earned on notes receivable from participants amounted to \$10,877 and \$5,053 for the years ended December 31, 2024 and December 31, 2023, respectively.

6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination or partial termination, participants would become 100 percent vested in the Plan Sponsor contribution portion of the participant's account.

7. Tax Status

The Plan uses a prototype plan document sponsored by Automatic Data Processing Inc. (ADP). ADP received an opinion letter from the IRS dated October 6, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code. The Plan itself has not received an opinion or determination letter from the IRS. Although the Plan has been amended since ADP received the opinion letter, the Plan Sponsor believes that the Plan is designed and currently being operated in compliance with the applicable provisions of the Internal Revenue Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

9. Corrective Distributions

For the year ended December 31, 2024, the Plan's actual deferral percentage and actual contribution percentage discrimination test was completed in 2024. Based on the results of this test, it was determined that the Plan had excess contributions of \$4,305. These excess contributions were recorded as a liability as of December 31, 2024, with a corresponding reduction to contributions.

For the year ended December 31, 2023, the Plan's actual deferral percentage and actual contribution percentage discrimination test was completed in 2023. Based on the results of this test, it was determined that the Plan had excess contributions of \$23,437. These excess contributions were recorded as a liability as of December 31, 2023, with a corresponding reduction to contributions.

The Plan distributed \$27,363 and \$25,050 for excess contributions in 2024 and 2023 related to contributions for the years ended December 31, 2023 and December 31, 2022, respectively.

10. Qualified Nonelective Contributions

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation. The Plan also includes an automatic contribution escalation provision whereby participants can elect to automatically increase their deferral percentages on an annual basis. For the year ended December 31, 2023, certain employees who became eligible under the automatic enrollment option and who did not affirmatively decline participation were not enrolled in the Plan.

As a result of the missed enrollments and lack of increase in deferral percentages, the Plan Sponsor calculated the amount of missed participant contributions by recalculating the amounts that should have been contributed based on participants' elections. Based on the results of this assessment, the Plan Sponsor calculated a qualified nonelective contribution (QNEC), which is equal to fifty percent of the employees' missed deferral during the year ended December 31, 2023 by multiplying the actual deferral percentage for the employees by the employees' compensation.

10. Qualified Nonelective Contributions (Continued)

The amount of the QNEC for the year ended December 31, 2023 amounted to \$472. The QNEC is not reported as a delinquent contribution as this relates to employer funds and not participants' funds.

11. Subsequent Event

Effective September 1, 2025, the Plan was amended to allow participants to make Roth 401(k) contributions. Under this amendment, participants may elect to contribute a portion of their eligible compensation as designated Roth contributions, which are made on an after-tax basis.
