### Note 1 - Plan Description

The following description of Western Michigan University Homer Stryker M.D. School of Medicine 403(b) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all employees of Western Michigan University Homer Stryker M.D. School of Medicine (the "School"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees of West Michigan Air Care, Inc. are also eligible to participate in the Plan.

#### ***Plan Administration***

The Plan is administered by two investment custodians: Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF) (collectively, TIAA-CREF) and Fidelity Management Trust Company (Fidelity). TIAA investments consist of registered investment companies, a group annuity contract, and a pooled separate account. CREF investments consist of registered investment companies. Fidelity investments consist of mutual funds.

#### ***Contributions***

The Plan provides for employee salary 403(b) contributions up to a maximum of 95 percent of annual compensation subject to maximum tax-deferred and pretax (Roth) limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 95 percent of their compensation on an after-tax and pretax basis subject to maximum limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer discretionary matching contributions to the Plan. For the year ended December 31, 2024, the School matched 50 percent of employee deferrals up to 2 percent of eligible compensation. All employees are eligible to receive matching contributions except the following: any employee who receives contributions under the School's 457(b) deferred compensation plan; any faculty member or other employee who receives a cash payment in lieu of contributions to the School's 457(b) plan; and any resident, fellow, or student.

Effective July 1, 2024, the Plan no longer allows contributions through TIAA-CREF.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the School's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### ***Vesting***

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the School's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the School 20 percent after two years of service, an additional 20 percent after three years of service, and another 20 percent after four years of service and are fully vested after five years of service.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future school contributions or to pay administrative expenses of the Plan.

**Note 1 - Plan Description (Continued)**

***Benefit Payments***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of annual installments or a lump-sum amount equal to the vested balance of a participant's account. Participants may also request distributions upon attainment of age 59½.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan agreement. The plan administrator must approve any such hardship withdrawals.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by TIAA-CREF, Fidelity, or their affiliates. TIAA-CREF is a service provider of the Plan, and Fidelity is a custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. Additionally, various administrative costs are paid by the School.

***Termination***

While it has not expressed any intent to do so, the School has the right under the Plan to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation***

The Plan's investments are stated at fair value except as noted below. The TIAA Traditional Fund is a guaranteed fixed annuity contract invested in TIAA that invests in the general assets of TIAA. The Plan is specifically invested in the Group Supplemental Retirement Annuity (GSRA) contract in the TIAA Traditional Fund. TIAA considers GSRA to be benefit responsive, and, as a result, the investment is valued at contract value. Contract value represents principal invested, plus interest earned, less any withdrawals.

The registered investment companies are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. The pooled separate account is valued at net asset value per share (or its equivalent) of the fund, which is based on the fair value of the fund's underlying assets, which consist primarily of rental property subject to long-term leases, and has been estimated on the basis of future rental receipts and estimated residual values discounted at interest rates commensurate with risks involved. All other investments are valued based on quoted market prices reported in active markets. See Note 6 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Benefit Payments***

Benefits are recorded when paid.

***Allocated Contracts***

The Plan has allocated insurance contracts for retirees who were covered under the Plan in prior years. These contracts remain intact, and additional contracts have been purchased. The activity related to the allocated insurance contracts for retirees receiving benefits is excluded from the financial statements. The Plan receives no income from these allocated insurance contracts.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including July 9, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

TIAA-CREF and Fidelity hold the Plan's investments and execute all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by TIAA-CREF and Fidelity.

**Note 4 - Tax Status**

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS dated March 31, 2017.

**Note 5 - Annuity Contract**

The Plan has a benefit-responsive investment contract with TIAA. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a vintages approach. Under this methodology, TIAA groups the dollars it receives over time periods into vintages and determines a crediting rate for the applicable vintage. Interest crediting rates are determined during the accumulation phase of the applicable declaration year. When establishing interest crediting rates for this product, TIAA considers many factors, including the net investment earnings rate of the TIAA assets supporting that vintage, administrative expenses during the time period, and required contingency reserves. The minimum crediting rate for the contract is 3 percent; however, in some recent contracts, it has been between 1.00 and 3.00 percent.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

**Note 6 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
