Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Carter Mario P.C. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of the Plan

The following description of Carter Mario P.C. 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan provisions.

General

The Plan is a defined contribution plan covering all employees of Carter Mario P.C. or any affiliate (the “Company”), who have reached the age of twenty-one, completed two consecutive months of service and are not covered by a collective bargaining agreement and non resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Voya Retirement Insurance and Annuity Company (“Voya”) is the Plan’s trustee.

Contributions

Participants may contribute a specific portion of their annual compensation, as defined in the Plan document, up to the maximum allowed by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make “catch-up” contributions to the Plan as defined under the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan is required to return excess contributions received during the Plan year in excess of IRC limits.

The Plan has a safe harbor matching program for participants of the Plan. The matching program provides for a 100% match of the first 3% of eligible compensation that is contributed to the Plan and 50% of the next 2% of eligible compensation that is contributed to the Plan, for a maximum employer matching contribution of 4% of an employee’s eligible compensation.

The Company may, at the discretion of management, contribute additional profit sharing amounts to the Plan. Employees must be employed at year-end to be eligible for an allocation of the profit sharing contribution. The Company elected not to make any profit sharing contributions in 2024.

Participants’ Accounts

Each participant’s account is credited with the participant’s contribution, allocations of the Plan’s earnings (losses), employer contributions and administrative expenses. Allocations are based on a participant’s earnings (losses), account balances, or specific participant transactions, as defined. All investments are participant directed.

1. Description of the Plan (*continued*)

Vesting

Participants are immediately vested in their contributions, including rollovers, as well as matching contributions plus earnings thereon. Vesting in the Company's profit sharing contributions are based on years of continuing service as follows:

Forfeited Accounts

Forfeitures of the non-vested portion of terminated participants' accounts are maintained in a separate account and may be used to pay administrative expenses or to reduce future employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8 and \$7,789. During 2024, \$7,928 was used to reduce employer contributions and none were used to reduce administrative expenses.

Notes Receivable from Participants

The Plan allows participants to borrow money from their account balances and repay the loans through payroll deductions. Two loans may be outstanding at any given time. The minimum loan amount is \$1,000 and the maximum loan amount may not exceed the lesser of (a) one half of the participant's vested interest in the Plan or (b) \$50,000 reduced by the excess, if any, of the highest outstanding loan balance from the Plan during the one year period ending on the day before the new loan is to be made over the current outstanding balance of loans as of the date of the new loan. The loan repayment period may not exceed five years unless the proceeds of the loan are used to purchase the participant's principal residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate that is one percentage point above the prime rate. Principal and interest are repaid ratably through payroll deductions.

Investment Options

Upon enrollment in the Plan, a participant may direct their contributions to any of the various investment options available under the Plan. Participants may change their investment options at their discretion.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest or installment payments either monthly, quarterly, semi-annually, or annually. Participants whose account balances are \$5,000 or less may receive a lump sum payment or have their account balance rolled over to an Individual Retirement Account. Participants may withdraw funds from their accounts who have demonstrated hardship (as defined under Internal Revenue Service Regulations).

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

The Plan follows U.S. GAAP guidance which removed the requirement to categorize within the fair value hierarchy investments whose fair value is measured using net asset value ("NAV") as a practical expedient. At December 31, 2024 and 2023, all of the Plan's common/collective trusts, that were valued at fair value, were valued at NAV using the practical expedient.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the Voya Fixed Account, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investment Valuation and Income Recognition (continued)

The common/collective trusts are valued at the NAV of units held by the Plan. The NAVs, as provided by the trustees, are used as a practical expedient to estimate fair value. The NAVs are based on the fair value of the underlying investments held by the funds less their liabilities. The practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV.

The Voya Fixed Account is reported at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses related to the operation of the Plan are paid by the Plan. The primary expenses paid by the Plan relate to recordkeeping, third-party administration, trust and audit services. Certain other costs for administering the Plan are paid by the Company. Expenses relating to specific participant transactions (i.e. loan set up, distributions, etc.) are charged directly against the appropriate participant's account.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 4, 2025.

3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation in value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, a qualified institution.

4. Investment Contract with Insurance Company

The Voya Fixed Account (the “Account”) is a fully benefit-responsive investment contract with Voya. The Account guarantees principal and a minimum guaranteed interest rate for the life of the contract, as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period – currently one calendar year. The guaranteed minimum floor rate may change after the defined period, but it will never be lower than the minimum guaranteed interest rate that applies for the life of the contract.

Voya’s determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets.

Voya may impose limitations on the ability to transfer funds into or out of this investment option. Withdrawals from the Account for other than the payment of benefits to participants may be subject to a market value adjustment and a surrender charge. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The Account is presented on the face of the statements of net assets available for benefits at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Voya is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody’s Investors Service (A2 as of September 2024), Standard and Poor’s (A+ as of September 2024), and Fitch (A+ as of September 2024).

5. Common/Collective Trusts

The Plan offers various common/collective trusts. The unit value of each of these funds is determined on a daily basis. Units are issued and redeemed daily at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the unit value.

6. Tax Status

The Internal Revenue Service has determined and informed the prototype document preparer by a letter dated June 30, 2020, that the Plan is designed in accordance with the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Company may at any time terminate the Plan and discontinue all contributions, subject to the applicable provisions of ERISA. In the event the Plan is terminated, all participants shall become fully vested in their account balances.

8. Party-in-Interest Transactions

Investments of the Plan are managed by Voya, and, therefore, these transactions qualify as exempt parties-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

Certain employees of the employer perform administrative services to the Plan at no cost to the Plan.

9. Risks and Uncertainties

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
