As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the New England Life Insurance Company Agents' Retirement Plan and Trust (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General Information

The Plan, a frozen money-purchase pension plan sponsored by New England Life Insurance Company (the "Company"), is intended to comply with the applicable requirements of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), and the United States Internal Revenue Code ("IRC").

The Plan was established July 1, 1942 and covers former full-time agents of the Company employed prior to December 31, 2014, the date the Plan was frozen.

Contributions

The Plan no longer accepts employer or participant contributions. However, any participants who took a required minimum distribution (RMD) in 2020 from the Plan prior to the implementation of CARES Act provisions had the opportunity to roll those funds back into the Plan in accordance with the CARES Act provisions and the guidance in the IRS Notice 2020-51.

Forfeitures

Participant forfeitures of employer contributions may be used to offset future employer contributions or pay any administrative expenses of the Plan.

Participant Accounts

Each participant's account is charged with withdrawals and allocated investment earnings or losses and may include an allocation of participant incurred fees as provided by the Plan document. A participant is entitled to benefits that are equal to the participant's vested account balance. Each participant directs the investment of his or her account to any of the investment options available under the Plan. Participants may change their investment options at any time.

Vesting

All participants are fully vested in their accounts.

Payment of Benefits

A participant may request withdrawals from the Plan under the conditions set forth in the Plan document. The participant or beneficiary may elect to receive either a lump sum, installment payments, or an annuity that is actuarially equivalent in value to the participant's account as of the benefit commencement date.

For a participant who elects an annuity, the Plan purchases an individual annuity contract from Metropolitan Life Insurance Company ("MLIC"). Upon the purchase of such an annuity, the benefits thereunder become fully guaranteed by MLIC. Accordingly, the Plan's financial statements exclude assets and liabilities which pertain to such annuity contracts.

Administrative, Investment Management Expenses and Participant Incurred Fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Participant incurred fees and certain investment management fees are charged to the Plan as a reduction of Plan assets or investment returns, respectively, and included in these financial statements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Risks and Uncertainties:

The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the estimated fair values of investments will occur in the near term and that such changes could materially affect participants account balances and the value of the Plan's investments as reported in the accompanying financial statements.

Investment Valuation and Income Recognition

The Plan's investments are reported at estimated fair value as further described in Note 4, with the exception of fully benefit-responsive investments.

The New England Financial ("NEF") Stable Value Fund, which represents a fully benefit-responsive stable value fund in the general account of MLIC (see Note 5), is reported at contract value as a single amount reflected separately in the Statements of Net Assets Available for Benefits.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded as earned. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments.

Payment of Benefits

Benefit payments to participants are recognized when paid.

NOTE 3 - UNAUDITED INFORMATION - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (“CSTB”) and MLIC.

NOTE 4 – ESTIMATED FAIR VALUE MEASUREMENTS AND DISCLOSURES

Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. In most cases, the exit price and the transaction (or entry) price will be the same at initial recognition. Subsequent to initial recognition, fair values are based on unadjusted quoted prices for identical assets or liabilities in active markets that are readily and regularly obtainable. The Plan categorizes its assets and liabilities measured at fair value into a three-level hierarchy based on the significant input with the lowest level in its valuation. The input levels are as follows:

Level 1: Unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2: Quoted prices in markets that are not active or inputs that are observable either directly or indirectly.

Level 3: Unobservable inputs that are supported by little or no market activity and are significant to the estimated fair value of the assets or liabilities.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds

The estimated fair values of mutual fund investments are determined by using publicly quoted market prices in active markets and are classified as Level 1 within the hierarchy.

Self-Directed Account

The estimated fair value of the investments held in the self-directed accounts ("SDA") is determined by reference to the underlying shares of the publicly available mutual funds, common stock and exchange traded funds held within each participant's respective account. Such estimated fair values are based on the net asset values ("NAV") published by the respective fund managers or on quoted market prices on the applicable reporting date, respectively. Accordingly, such values are classified within Level 1 of the estimated fair value hierarchy.

Stock Funds

The estimated fair values of the Brighthouse Financial, Inc. common stock and MetLife, Inc. common stock held in the Brighthouse Financial Frozen Stock Fund and MetLife, Inc. Frozen Stock Fund, respectively, are based each on the respective publicly traded stock price plus any cash held by the funds less any participant incurred redemption fees. Accordingly, such fund values were classified within Level 1 of the estimated fair value hierarchy.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENTS WITH MLIC

The NEF Stable Value Fund is a traditional investment contract invested in the general account of MLIC. The funds are considered fully benefit-responsive investments under GAAP. The Plan's assets invested in the fully benefit responsive contract are included in the Plan's financial statements at contract value as a single amount reflected separately in the Statements of Net Assets Available for Benefits. Contract value represents accumulated contributions directed to the investment, plus interest credited, less participant withdrawals and expenses.

Participants may direct the withdrawal for benefit payments or transfer all or a portion of their investment to other investments offered under the Plan at contract value.

The crediting interest rate is established annually by MLIC in a manner consistent with its practices for determining such rates, but which may not be less than zero percent.

The Plan's investment in the NEF Stable Value Fund had a contract value of \$28,922,741 and \$35,532,674 as of December 31, 2024 and 2023, respectively. Upon termination of the NEF Stable Value Fund contract by the Plan, proceeds will be paid for the benefit of the participants at the contract value, determined on the date of termination, in ten equal annual installments plus additional interest credited.

The fully benefit-responsive investment has certain restrictions. For example, a partial plan termination or meaningful divestitures are events that could result in such restrictions that may affect the ability of the Plan to collect the contract value. Plan management believes that the occurrence of events that would cause the Plan to enter into transactions at less than contract value is not probable. The MLIC may not terminate the contract at any amount less than the contract value.

While the Plan Administrator may do so at any time, the Company does not currently intend to terminate the NEF Stable Value Fund contract. There are no reserves against the reported contract value for credit risk of MLIC, as the issuer of the contract.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain related party transactions between the Plan and the Company qualify as exempt party-in-interest transactions as that term is defined under ERISA. Certain administrative functions are performed by employees of Brighthouse Services, LLC, an affiliate of the Company. No employee of the Company or of the Company's affiliates receives compensation from the Plan. The Plan holds shares of Brighthouse Financial, Inc. common stock, the indirect parent of the Company. In addition, the self-directed brokerage accounts and shareholder services to the Plan are provided by affiliates of CSTB, the Trustee of the Plan. Transactions in such investments qualify as exempt party-in-interest transactions.

Furthermore, Plan investments include shares of MetLife, Inc. common stock and a traditional investment contract offered by MLIC and managed by MetLife Investment Advisor, LLC ("MLIA"), affiliates of MetLife, Inc. during the 2024 and 2023 Plan years. Transactions in such investments qualified as exempt party-in-interest transactions.

NOTE 7 - TERMINATION OF THE PLAN

The Company reserves the right to amend, modify or terminate the Plan at any time. In the event of a termination, each participant would have a right to receive a distribution of his or her interest in accordance with the provisions of the Plan.

NOTE 8 - TAX STATUS

The United States Internal Revenue Service (the “IRS”) has determined and informed the Company by a letter dated April 29, 2014 that the terms of the Plan document satisfy the applicable requirements of the IRC. The Plan has been amended since receiving such determination letter. The Plan Administrator believes that the Plan is currently being operated in material compliance with the applicable requirements of the IRC and the Plan document and continues to be tax exempt under the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires management to evaluate tax positions taken by the Plan. The Company has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events for recognition and disclosure through August 22, 2025, the date these financial statements were issued, and there are no subsequent events.
