Notes to Financial Statements

For the year ended December 31, 2024

Note 1 – Nature of the Plan

The following description of the Hibiscus Children’s Center Inc. 401(K) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan for the benefit of the employees of Hibiscus Children’s Center Inc. (the “Sponsor”). The Plan became effective January 1, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Board of Trustees oversees governance of the Plan. The Plan’s Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Trustees.

Eligibility

Participants are eligible to participate in the plan after attaining 21 years of age and completing three consecutive months of service.

Contributions

Upon meeting eligibility requirements, participants may elect to contribute a portion of their compensation to the Plan on either a pre-tax or Roth (after-tax) basis, subject to annual limits imposed by the Internal Revenue Code. For 2024, the maximum elective deferral is \$23,000, with an additional \$7,500 catch-up contribution allowed for participants age 50 or older. Participants may also contribute eligible rollover amounts from other qualified retirement plans.

The Plan includes an automatic enrollment provision under which newly eligible employees are automatically enrolled at a 3% deferral rate, unless they opt out or select a different percentage. The deferral rate automatically increases by 1% annually, up to a maximum of 10%, unless otherwise elected by the participant. The maximum deferral percentage is 100% of eligible compensation, subject to Internal Revenue Code limitations and nondiscrimination requirements.

The Company provides a matching contribution equal to 3% of eligible compensation and may also make discretionary profit-sharing contributions. Company contributions vest according to the Plan’s vesting schedule.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Sponsor’s matching contribution, Plan earnings (losses), and charged with an allocation of investments gains or losses, withdrawals, and any administrative fees paid by the plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments

Upon enrollment in the Plan, contributions are automatically invested in a designated balanced fund until directed by the participant. The Plan currently offers various mutual funds, a money market fund, and bonds.

Note 1 – Nature of the Plan (continued)

Forfeiture Account

When a terminated participant requests a distribution, any non-vested assets will be reallocated to the forfeiture account. Forfeited accounts are maintained separately and invested in the Plan’s money market account. Forfeitures may be used to pay appropriate Plan expenses, to reduce employer contributions (other than elective deferrals), or as an employer profit sharing. As of December 31, 2024, forfeited account totaled \$12,458.

Vesting

Participants are immediately vested in their contributions and actual investment earnings and losses thereon. Employees vest based on a three year schedule: year 1 - 0%, year 2 - 50%, and year 3 - 100% in accordance with the Plan document, or immediately if employment is terminated due to death or disability.

Participants or their beneficiaries are eligible to receive distributions of their vested account balances upon retirement or other termination of employment. Distributions of benefits while the participant is still employed are permitted for rollovers of the account balances, after-tax distributions, financial hardship, as defined, or upon the attainment of age 59 ½. Participants or their beneficiaries may elect to receive a lump sum payment or minimum required payments.

Participant Loans

Participants are allowed to borrow against their individual vested accounts. Loan amounts are limited to 50% of a participant’s vested balance to a maximum of \$50,000, with an interest rate that approximates the current market rates. Participant notes receivable are valued at their outstanding principal value plus accrued unpaid interest. At December 31, 2024, the interest rates on outstanding loans ranged from 4.25% to 9.5%. The financial risk and all associated costs with non-performing loans is borne by the individual loan holder. As of December 31, 2024, the Plan had outstanding notes to participants with principal balances totaling \$136,425.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or as provided by the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Prior Period Information

The financial statements include certain prior year corresponding totals intended to be read only in relation to the current period presentation. The corresponding information was derived from the Plan’s audited financial statements for the year ended December 31, 2023 but does not include sufficient detail to constitute a presentation in conformity with accounting principles generally accepted in the United States of America. The prior year corresponding totals may also reflect certain reclassifications of amounts to conform to the current year presentations.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting – The Plan uses the accrual basis of accounting for transactions in accordance with accounting principles generally accepted in the United States of America except that benefits paid to Plan participants are recorded on the cash basis.

Note 2 – Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the plan’s valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan’s gains and losses on investments bought and sold as well as changes in value of investments held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance has been recorded as of December 31, 2024. Delinquent loans are treated as distributions based on the terms of the Plan document.

Contributions

Contributions from employees are recorded as they are withheld from participant’s wages.

Excess Contributions

If material, amounts in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as accounts payable, with a corresponding reduction to contributions. The Plan would distribute any 2024 excess contributions after December 31, 2024. There were no material excess contributions for the year ended December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Sponsor and are therefore excluded from these financial statements. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant’s account. Investment related expenses are included in net appreciation in fair value of investments. The Plan paid \$11,065 of administration fees during the year ended December 31, 2024.

Note 3 – Investments (UNAUDITED)

The Plan’s investment were held in trust and administered by the trustee, Mid Atlantic Trust Company for the year ended December 31, 2024. All investment information disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.

Note 4 – Fair Value Measurements

Fair value measurements in accordance with current accounting standards, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 – Related Party Transactions

Certain Plan investments are managed by Mid Atlantic Trust Company, the trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Sponsor. These transactions qualify as party-in interest transactions.

Note 6 – Plan Termination

Although it has been expressed that there is no intention to do so, the Sponsor retains the right to terminate or amend the plan. In the event of Plan termination, all amounts credited to participants’ accounts become fully vested subject to the requirements of ERISA.

Note 7 – Federal Income Tax Status

The Sponsor has adopted a prototype standardized plan through Paychex Inc. pre-approved by the IRS. The IRS issued an opinion letter dated August 31, 2020, that the prototype standardized plan is acceptable with the applicable section of the Internal Revenue Code. Although the Plan has been amended since receiving this letter, the Sponsor and plan administrator (Paychex Inc.) believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan and related trust continue to the tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Notes to Financial Statements (continued)

Note 7 – Federal Income Tax Status (continued)

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan provides for various investment options in money market and mutual funds. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 – Concentrations

As of December 31, 2024 approximately 15% of the Plan’s assets were invested in Vanguard Federal Money Market Fund Investor Shares. Additionally, approximately 15% of the Plan’s funds were invested in Dimensional 2030 Target Date Retirement Income Fund Institutional Class. Therefore, the underlying value of the funds growth is dependent on the performance of each of these funds. It is at least reasonably possible that changes in the fair value of these funds in the near term could materially affect participants’ account balances and the amounts reported in the statement of assets available for benefits and that statements of changes in assets available for benefits.

Note 10 - Subsequent Events

For the year ended December 31, 2024, the Plan has evaluated subsequent events for potential recognition and disclosure through the report date of July 9, 2025, the date the financial statements were available to be issued.
