Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Milliman Profit Sharing and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Milliman Profit Sharing and Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Milliman Profit Sharing and Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Milliman Profit Sharing and Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 – Description of Plan

The following description of the Milliman Profit Sharing and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more comprehensive description of the Plan's provisions.

General – The Plan is a defined contribution plan established by Milliman, Inc. (the Sponsor) under the provisions of Sections 401(a) and 401(k) of the Internal Revenue Code (IRC), which includes a qualified deferred arrangement as described in Section 401(k) of the IRC.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – The Plan covers employees of the Sponsor. Employees who are regularly scheduled to work at least 1,000 hours per year become participants on the first of the month following or coincident with hire date or benefits eligibility date. Employees who are not scheduled to work at least 1,000 hours per year become eligible on the January 1 or July 1 following a year of service in which they complete at least 1,000 hours of service.

Contributions

Participant contributions – Participants are allowed to make voluntary (pre-tax and Roth after-tax) contributions up to a total cumulative amount of 75% of aggregate considered earnings, as defined in the Plan document, subject to certain limitations by the IRC. Participants may also contribute amounts representing distributions from other qualified plans and individual retirement accounts. Certain participants may also make catch-up contributions. New employees who are eligible to participate in the Plan will be automatically enrolled to contribute 6% of their aggregate considered earnings to the Plan unless the participant elects a different contribution percentage or elects not to contribute.

Sponsor contributions – Sponsor contributions include a discretionary profit sharing contribution and a matching contribution. On or before the last day of each Plan year, the Sponsor's board of directors determines the profit sharing contribution to the Plan based on the Sponsor's net operating profits. This profit sharing contribution is allocated to each participant based on the participant's eligible earnings for the Plan year in proportion to total eligible earnings of all participants for the same Plan year. Participants are eligible for the profit sharing contribution once they have completed six months of service, and are employed on the last day of the Plan year, or if they retire, become disabled, or are deceased during the year. In 2024, the profit sharing contribution was 10% of eligible earnings with an additional 5% contribution on eligible earnings over the social security wage base (\$168,600). For the year ended December 31, 2024, the profit sharing contribution was \$43,191,427 after forfeitures applied.

The Sponsor makes matching contributions equal to 50% of the portion of the participant's contribution that does not exceed 6% of the participant's eligible compensation. Catch-up contributions are not eligible for matching contributions.

Contributions are subject to regulatory limitations.

Milliman Profit Sharing and Retirement Plan Notes to Financial Statements

Participant accounts – Each participant’s account is credited with the participant’s contributions, Sponsor’s contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting – Participant contributions, plus actual earnings and losses thereon, are 100% vested at all times. Participant accounts attributable to the Sponsor’s contributions, plus actual earnings thereon vest, as follows:

Notes receivable from participants – The Plan allows participants to take loans of a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance for a term of up to five years or 15 years for the purchase of a principal residence. The interest rate charged on loans is 1.0% greater than the prime rate on the day on which the loan is requested. The interest rates charged on outstanding loans as of December 31, 2024, ranged from 4.25% to 9.50% with loan maturities through October 2039.

Payment of benefits – An active participant may apply to the Plan to withdraw their pre-tax, matching and profit sharing balances from their account if they have reached normal retirement age (age 59 ½). For purposes of withdrawals from pre-2003 prior money purchase plan contributions, the normal retirement age is 62. In addition, an active participant may apply for a withdrawal in the event of hardship, as defined in the Plan document. All hardship withdrawals are subject to the approval of the Sponsor and must meet the hardship requirements as defined by the Internal Revenue Service (IRS). The Plan also allows active participants to take withdrawals from their after-tax or rollover account balances.

On termination of service, if a participant’s vested balance is less than \$1,000, they will receive a lump sum payment equal to the vested portion of their account. If a participant’s vested balance is greater than \$1,000, but not more than \$5,000, they may elect to receive the value of the vested portion of their account in a lump-sum payment or a direct rollover. If no election is made by a specified date, the amount will be rolled over to an IRA. If a participant’s vested balance is over \$5,000, they may elect to receive lump sum, installment payments, partial distributions, or in the form of a qualified annuity (for married participants with pre-2003 prior money purchase plan contributions only).

Milliman Profit Sharing and Retirement Plan Notes to Financial Statements

Forfeitures – Termination of participation in the Plan without a fully vested interest in the Sponsor’s contributions results in a forfeiture of all nonvested Sponsor contributions, plus actual earnings thereon. An employee may be entitled to reinstatement of forfeiture contributions upon reemployment by the Sponsor within five years of the date of termination so long as the participant repays in cash the value of the distribution subject to vesting at the time of withdrawal. In the event of normal retirement, disability, or death of an active participant, all amounts credited to a participant’s account are fully vested.

Forfeited nonvested Sponsor contributions, resulting from the termination of participants in the Plan, are used to reduce the Sponsor’s current contributions to the Plan, and the related earnings from those forfeited nonvested Sponsor contributions are used to reduce qualified Plan expenses. For those former participants who are reemployed within a five-year period, the amount required to reinstate their prior Sponsor contribution account in the Plan will be funded from the current year’s forfeited contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,602,938 and \$2,722,208, respectively. For the year ended December 31, 2024, the Plan used \$2,632,160 of the unallocated forfeitures to reduce 2023 Sponsor contributions receivable. Subsequent to December 31, 2024, the Plan used \$2,454,475 of the unallocated forfeitures to reduce the 2024 Sponsor contributions receivable.

Trustee and administration – The assets of the Plan are held in trust by Charles Schwab Trust Bank (the Trustee). The Trustee receives contributions and executes transactions under the direction of the Milliman Retirement Committee, the Plan administrator. Investment management, investment consultants, and trustee fees are paid by the Plan. Substantially all administrative costs are paid by the Sponsor.

The Sponsor has a revenue sharing agreement with the Trustee whereby fees paid by certain investment managers to the Trustee are available to the Plan. During 2024, \$111,490 was available to the Sponsor. The Sponsor chose to allocate the total balance to those participants who invest in funds managed by the applicable investment managers.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

Use of estimates – The preparation of financial statements in accordance with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. The Plan’s trustee, Charles Schwab Trust Bank, certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Notes to Financial Statements

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation or depreciation of those investments.

Contributions – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan document.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through August 22, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Mutual funds are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Collective trust funds: Units held in collective trusts (CT) are valued using the NAV practical expedient of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. There are no restrictions to trading the collective trust funds at their NAV practical expedients at December 31, 2024 and 2023.

The Plan has investments in the following collective trusts that are not direct filing entities:

MetWest Total Return Bond Fund – A collective trust that invests in domestic and international fixed income sectors. Its goal is to seek to outperform the aggregate bond market over full market cycles.

Vanguard Institutional 500 Index Trust – A collective trust that invests all its assets in Institutional Select shares of the Vanguard 500 Index Fund. It seeks to track the performance of a benchmark index that measures the investment return of large-capitalization stocks.

Vanguard Institutional Extended Market Index Trust – A collective trust that invests all its assets in Institutional Select shares of the Vanguard Institutional Extended Market Index Fund. It seeks to track the performance of a benchmark index that measures the investment return of small and mid-capitalization stocks.

Vanguard Total International Stock Index Trust – A collective trust that invests all its assets in Institutional Select shares of the Vanguard Total International Stock Index Fund. It seeks to track the performance of a benchmark index that measures the investment return of stocks issued by companies located in developing and emerging markets.

Note 4 – Tax Status

The Plan document is a prototype volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

Note 6 – Information Certified by the Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments and participant loans reflected on the schedule of assets (held at end of year).

Note 7 – Party-In-Interest Transactions

The Plan invests in the Unified Trust Funds. A portion of these funds are sub-advised by Milliman's Financial Risk Management practice (FRM) and therefore qualify as party-in-interest transactions. Neither FRM nor Unified Trust receives fees for the funds held by the Plan.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
