Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Lloyd, Inc. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 – Description of the Plan

Lloyd, Inc. (the “Company”) sponsors an employee savings and retirement plan. The following description of the Lloyd, Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

A. **General**

The Plan is a defined contribution plan covering substantially all full-time and part-time employees of the Company effective the first day of January or July that follows the completion of three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

B. **Contributions**

Elective Contributions - Each year, participants may contribute, pretax, up to a specified dollar amount determined by the Internal Revenue Service, as defined in the Plan. Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants can elect a percentage or specified amount in addition to excess employer benefits.

Employer Matching Contributions – The Company contributes a safe harbor match of 4% for all employees with six months of service. Additionally, the Company may make a discretionary profit sharing contribution.

C. **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching and profit sharing contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. **Vesting of Benefits**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution of their portion of their accounts is based upon a graduated scale where the Company contributions become fully vested after six years of service. Upon termination of employment and participation in the Plan, participants are entitled to receive the amounts they contributed and any vested contributions plus the interest that has been credited to their account.

E. **Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, a participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account.

F. **Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$2, respectively. Forfeited amounts may be used to reduce future employer contributions.

Note 2 – Summary of Significant Accounting Policies

A. *Basis of Presentation*

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the valuation policies utilizing information provided by the investment advisers and custodians. Fair value measurements are discussed in Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends, if applicable, are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. *Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

E. *Payment of Benefits*

Benefits are recorded when paid.

F. *Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

G. *Subsequent Events*

The Plan has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted price in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Shares held in mutual funds are valued based on the market price of the shares held by the Plan at year end, which are based on the share prices quoted by the fund, representing the fair value of the underlying investments.

Note 4 – Fair Value Measurements (continued)

Stable Value Account: A stable value fund is composed primarily of fully benefit responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5 – Related-Party Transactions and Party in Interest Transactions

Fees incurred by the plan for the investment management, recordkeeping and audit services are charged to the plan participants on a pro rata basis. The Plan Sponsor pays directly any other fees related to the plan's operations. Certain fees of administering the Plan are paid to the Trustee by the Plan. These transactions qualify as exempt party-in-interest transactions.

Note 6 - Termination of the Plan

Although the Company has not expressed any intention to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan.

Note 7 - Tax Status

The Plan is using a prototype plan and filed an adoption agreement on January 1, 2015. The prototype plan most recently received an opinion letter on November 30, 2020 in which the Internal Revenue Service stated that the form of the Plan document was acceptable under the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
