Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Soltesz, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended November 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Soltesz, Inc. Notes to Financial Statements

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Soltesz, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General - The Plan is defined as a Profit Sharing Plan with a 401(k) provision. The Plan, which became effective December 1, 1984, and was fully restated effective December 1, 2022, is a defined contribution plan covering the employees of Soltesz, Inc. and all of its wholly owned subsidiaries (together, the "Company" or "Plan Sponsor"). The Plan is intended to qualify under Section 401(k) of the Internal Revenue Code ("IRC") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). An employee is eligible to participate in the Plan at the beginning of the month following employment commencement date and attainment of the age of 21.

The Plan is administered by the Company. The Chief Executive Officer and the Chief Financial Officer of the Company serve as the Plan's trustees. The Plan's assets are held in the custody of Delaware Charter Guarantee & Trust Company, conducting business under the name Principal Trust Company ("Principal"), and Voya Retirement Insurance and Annuity Company ("Voya"), collectively Principal and Voya are referred to as the ("Custodians").

Contributions - Each year, eligible participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Contributions are made through payroll deductions. In addition, participants 50 years of age or older may elect to make a catch-up deferral contribution (\$7,500 for the year ended November 30, 2024). Distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions invested in a designated investment until changed by the participant.

Pursuant to the plan document, the Company may make discretionary matching contributions. The Company may make discretionary matching contributions up to 50 percent of the first 6 percent calculated based on employees' deferrals at the end of each pay period. The discretionary matching contributions for the year ended November 30, 2024 were \$279,987. Each year, the Company may also make a discretionary profit-sharing contribution that is allocated based on eligible wages. Eligible participants who are employed on the last day of the plan year, as defined, are to receive the profit-sharing contribution. There was no profit sharing contribution during the year ended November 30, 2024.

All contributions are subject to certain IRS limitations.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based upon participant net earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is that which can be provided from the participant's vested account.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50 percent of their vested account balance not to exceed \$50,000. Loan terms cannot exceed five years. A participant is permitted to have one outstanding loan at a time. The loans are secured by the balance in the participant's account and bear interest at 8.0 to 10.0 percent. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In the event a participant terminates or retires, and the participant's vested account balance is less than \$5,000, the balance will be rolled into an IRA if in excess of \$1,000 or paid in a lump-sum distribution if less than \$1,000.

Forfeitures - Terminated participants forfeit non-vested company contributions. Remaining forfeitures shall be applied in accordance with specific provisions of the Plan. As of November 30, 2024 and 2023, the balance of the unallocated funds from forfeited accounts totaled \$0.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements of the Plan are prepared using the accrual basis in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Investments Valuation and Income Recognition - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. The Plan invests in pooled separate accounts that determine fair value using the net asset value ("NAV") of the funds. The NAV is determined by each fund's trustee using the fair value of the underlying securities within the fund at year-end (see Note 3 for further detail).

Purchases and sales of investments are recorded on a trade-date basis. Earnings from assets are recorded as earned using the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Administrative expenses include certain fees paid by participants, such as related loan fees. Certain investment management fees and other charges paid to the Custodians are offset against fund performance in net realized and unrealized appreciation in fair value of investments and are not, therefore, separately reflected as administrative expenses.

Risks and Uncertainties - Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Subsequent Events - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 8, 2025, the date the accompanying financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets.
- b. Quoted prices for identical or similar assets or liabilities in inactive markets.
- c. Inputs other than quoted prices that are observable for the asset or liability.
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable and significant inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2024 and 2023.

Pooled separate accounts are valued at unit value, which is based on the aggregate fair value of the underlying assets in relation to the total number of units outstanding. Unit value is the equivalent of NAV, which is a practical expedient for estimating the fair values of these investments. Each of these investments may be redeemed daily with a notice period of one day and the Plan had no unfunded commitments on these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of November 30, 2024 and 2023, the Plan's entire investment balance that is measured at fair value consists of investments using NAV as a practical expedient. Therefore, no investments are included in the fair value hierarchy.

NOTE 4 - INVESTMENTS

The Custodians have certified that certain information related to investments and notes receivable from participants included in the accompanying financial statements and supplemental schedule is complete and accurate.

The following table summarizes the information included in the Plan's financial statements, which was prepared by the Custodians for the years ended November 30, 2024 and 2023, and furnished to the plan administrator. The plan administrator has obtained a certification from the Custodians that such information is complete and accurate.

NOTE 4 - INVESTMENTS - CONTINUED

The Plan maintains a guaranteed investment option, the Voya Fixed Account, issued by Voya. The contract underlying this investment option is considered to be fully benefit-responsive. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses.

As discussed in Note 2, the contract is included in the accompanying statements of net assets available for benefits at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk.

There are no unfunded commitments. Under the terms of the contract, the plan sponsor must provide a minimum of 90 days notice prior to the redemption of the contract.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) plan amendments (including partial or complete termination of the Plan or merger of the Plan with another plan); (2) the failure of the Plan's trust to qualify for exemption from federal income taxes or any required prohibited exemption under ERISA; and (3) changes in the Plan's prohibition on competing investment options. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable of occurring.

NOTE 5 - TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified as tax exempt.

U.S. GAAP requires plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 30, 2024, there are no uncertain positions taken or expected to be taken. It is the Plan's policy to recognize interest and/or penalties related to uncertain tax positions, if any, in income tax expense. As of November 30, 2024, the Plan had no accruals for interest and/or penalties. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain plan assets are invested in pooled separate accounts sponsored by Principal and Voya. Transactions involving these investments are considered to be party-in-interest transactions for which statutory exemption exists under the Department of Labor Regulations. Additionally, the Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions.

NOTE 7 - ADMINISTRATION OF PLAN ASSETS

The Plan's assets, which include shares of Principal and Voya pooled separate accounts, are held by the Custodians of the Plan.

Contributions are held and managed by the Custodians, which invests cash received, interest, and dividend income as directed by participants.

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Fees related to the refund of excess deferrals, contributions, or annual additions are absorbed directly by the Plan Sponsor.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.
