Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Linak US, Inc. 401K Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to the Financial Statements

1. Description of the Plan

The following description of the Linak US, Inc. 401K Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a safe-harbor defined contribution plan covering all eligible employees of LINAK US, Inc. (the Sponsor and Plan Administrator). The Plan became effective July 1, 1998 and was restated effective January 8, 2024. The Plan is administered by a trust. Effective January 8, 2024, the trustee changed from Matrix Trust Company (Matrix) to Empower Trust Company, LLC (Empower). In January 2024, the majority of account balances were transferred from Matrix to Empower. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

An employee becomes eligible to participate after three months of service. Entry into the Plan occurs on the first day of each calendar quarter following satisfaction of the service condition. The Plan excludes non-resident aliens and temporary, intern and seasonal employees; however, if a temporary, intern or seasonal employee completes one year of service, the employee will enter the Plan on the next entry date.

Contributions

Eligible employees may make pretax and Roth contributions from their eligible compensation subject to limits set by the Internal Revenue Service Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Sponsor makes a non-elective sponsor safe-harbor contribution to all eligible employees equal to 3% of the employee's compensation. In addition, the Sponsor may contribute a discretionary amount as determined by the Board of Trustees. No discretionary employer contributions were made for the year ended December 31, 2024. The Plan was amended in October 2024, to include, in addition to the nonelective contribution, a discretionary matching employer contribution effective January 1, 2025.

New participants that meet the eligibility requirements are automatically enrolled in an elective deferral contribution of 6% of the participant's eligible compensation, unless the participant affirmatively elects a different percentage or elects not to make a contribution. Employees that are automatically enrolled will have their contribution percentage rate annually increased by 1% up to a maximum of 10% on January 1 each year, unless the employee affirmatively elects otherwise.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Sponsor's contributions and an allocation of the Plan's earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of the Plan, continued

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in 1% increments to any of several investment options offered by the Plan. Participants may change their investment options at their discretion.

Vesting

Participants are immediately vested in their contributions and non-elective Sponsor safe-harbor contributions, plus actual earnings (losses) thereon. Vesting in the Sponsor's discretionary contribution portion of their accounts, plus actual earnings (losses) thereon, is based on years of continuous service. A participant vests 20% per year after the first year of service, and is 100% vested after five years of credited service.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or their beneficiaries may elect to receive either a lump sum distribution, installments over a period of time, or a direct rollover to another qualified plan equal to the value of the participant's vested account. If a participant has more than \$5,000 in their account, upon termination, they may elect to keep their account in the Plan indefinitely. Participants can elect to take a distribution in the event of certain hardships as defined by the Plan.

Forfeited Accounts

Forfeited accounts are used to reduce future employer contributions. As of December 31, 2024 and 2023, there were no forfeited accounts. During the year ended December 31, 2024, there were no forfeitures used to reduce employer contributions.

Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Administrative Expenses

Certain fees of the Plan are charged directly to the participant's account as provided in the Plan adoption agreement. All other administrative expenses are paid by the Plan Sponsor.

2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Contributions

Participant contributions and the employer safe-harbor contributions are recorded in the year in which employee compensation is earned.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through August 13, 2025, the date that the financial statements were available to be issued.

3. Information Certified and Provided by the Trustee

The Plan's cash and investments included in this note and throughout the Plan's financial statements and supplemental schedule were prepared or derived from information provided by Matrix and Empower, the trustees of the Plan during the year, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustees that the information provided to the Plan Administrator by the trustees is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the cash and investment information which appears throughout the financial statements and the supplemental schedule.

Empower and Matrix also certified to the completeness and accuracy of \$3,079,501 of net realized and unrealized appreciation in the fair value of the investments and \$585,923 of interest and dividends related to the investments for the year ended December 31, 2024. Net realized and unrealized appreciation in the fair value of the investments includes \$254,982 of depreciation in value that was not certified.

4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued based on the NAV of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

4. Fair Value Measurements, continued

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

In accordance with accounting standards, investments as December 31, 2024 and 2023 that are measured at fair value using the NAV practical expedient have not been classified as Level 1, 2 or 3 in the fair value hierarchy, but are included above to permit reconciliation of the fair value hierarchy tables to the amounts presented in the statements of net assets available for benefits.

5. Tax Status

Prior to January 8, 2024, the Plan used a prototype plan document sponsored by OneAmerica Financial Partners, Inc. (OneAmerica). OneAmerica received an opinion letter from the Internal Revenue Service (IRS), dated August 19, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. Effective January 8, 2024 the Plan used a prototype plan document sponsored by Empower Retirement LLC (Empower Retirement). Empower Retirement received an opinion letter from the IRS, dated November 14, 2022, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

6. Exempt Party-In-Interest Transactions

OneAmerica (until January 8, 2024) and Empower are the third party recordkeepers and MCF Advisors, LLC is the investment advisor of the Plan. Administrative expenses of \$83,518 for the year ended December 31, 2024 were paid by the Plan for investment management and recordkeeping services.

Additionally, indirect fees are paid to Empower based on investment account values. These fees range from 0.02% to 0.50% of the investment account value. The fees decrease net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.
