Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the RIDGEVIEW PSYCHIATRIC HOSPITAL AND CENTER, INC. RETIREMENT PLAN (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note (4) to the financial statements, is complete and accurate.

Opinion

(1) Description of Plan

The following description of the Ridgeview Psychiatric Hospital and Center, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a non-contributory defined contribution plan which was adopted on September 30, 1970 to provide retirement benefits for employees of Ridgeview Psychiatric Hospital and Center, Inc. (the "Plan Sponsor"). The Plan covers substantially all employees who are age eighteen or older and have completed one year of service which is defined as at least 1,000 hours of service, in a twelve month period ("participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

(b) Contributions

The Plan Sponsor may elect to make a discretionary profit sharing contribution to the Plan annually. The Plan Sponsor elected to contribute 2% in 2024 and 2023 of each participant's eligible compensation as defined in the plan agreement.

(c) Participant accounts

Each participant employed at the end of each plan year has his or her account credited with the Plan Sponsor's contribution, as determined above. The participants may transfer their investments daily among the investment options provided. Each participant's account is also credited or charged with the actual investment earnings (losses) of the investment options selected by the participant and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Vesting is based on years of continuous service, subject to certain break in service rules as defined in the Plan. A Participant is 100% vested in his or her account after six years of credited service according to the following schedule:

Participants may also become 100% vested in one of the following ways: (1) reaching normal retirement age [65], (2) death, (3) total and permanent disability, or (4) reaching early retirement age [55].

(e) Notes receivable from participants

The Plan does not permit participants to borrow from their accounts.

(f) Payment of benefits

Participants may elect to receive their vested account balance (insurance contract is subject to certain restrictions discussed in Note (9)) in either one lump-sum payment or in monthly installments under various forms of annuities.

(g) Forfeited accounts

Participants terminating before six years of service forfeit a specified percentage of their accumulated benefits. Forfeitures may be used to reduce the Plan Sponsor's contributions. Forfeitures totaling \$3,909 and \$5,177 were utilized by the Plan Sponsor to reduce contributions for the years ended December 31, 2024 and 2023, respectively.

Participants who have 100% non-vested balances when they terminate, forfeit their entire balance on the date they terminate. For participants who are partially vested in their account balance when they terminate, forfeitures are determined at the earlier of (1) the last day of the Plan year in which the former participant incurs five consecutive one-year breaks in service or (2) the distribution of the entire vested portion of the participant's account. Potential forfeited amounts which had not yet met the five year break in service period requirement or the vested portion distributed were \$14,104 and \$23,580 as of December 31, 2024 and 2023, respectively.

(h) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's vested account balance.

(i) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the processing of distributions are included in administrative expenses and charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

(j) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principals generally accepted in the United States of America ("GAAP").

(b) Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by Voya Retirement Insurance and Annuity Company ("Voya"). See Note (3) for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits are recorded when paid.

(d) Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Events occurring after reporting date

The Plan has evaluated events and transactions that occurred between December 31, 2024 and August 29, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Fair value measurements

Fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, fair value accounting standards establish a fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity including quoted market prices in active markets for identical assets (Level 1), or significant other observable inputs (Level 2) and the reporting entity's own assumptions about market participant assumptions (Level 3). The Plan does not have any fair value measurements using significant unobservable inputs (Level 3) as of December 31, 2024 and 2023.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- (i) *Insurance contract*: Valued at fair value which approximates contract value based on the amount the Plan Sponsor would receive if they terminated the contract at the reporting date, which is book value less an early withdrawal charge, discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. See Note (9).

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan holds various pooled separate accounts that are not direct filing entities. A majority of these pooled separate accounts seek to mirror the investment objectives and strategies of the underlying mutual fund for which the pooled separate account is named. Certain other pooled separate accounts are target date funds which seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date. And, others are lifestyle funds which seek returns consistent with the stated investment style.

(4) Certified information

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including the fair value of investments held at December 31, 2024 and 2023, net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Sponsor and certified as complete and accurate by Voya.

(5) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan which received a favorable opinion letter from the Internal Revenue Service ("IRS") on November 30, 2020, which stated that the non-standardized pre-approved profit sharing plan was designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Related party and party-in-interest transactions

Certain Plan investments are units of pooled separate accounts and an insurance contract managed by Voya and, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note (1), the Plan paid expenses to various service providers which also qualify as party-in-interest transactions.

(8) Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(9) Insurance contract

The Plan provides a group annuity insurance contract with Voya as an investment option. Voya maintains these unallocated funds in its general account which supports insurance and annuity obligations of the insurance company. The contract is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses of Voya. The contract is included in the financial statements at fair value which approximates contract value as reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses of Voya.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but was not allowed to be less than 1.35% through December 31, 2024 and 2023. Such interest rates are reviewed on a monthly basis for resetting.

Transfers and partial withdrawals from the annuity contract are generally limited to 20% of a participant's balance per year. Full withdrawals from the annuity contract may be in the case of death, retirement, separation from service, hardship and small account balances. Full withdrawals for other reasons are limited and generally must be made in five-installment payments over five years.
