Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Davidson Group, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Operations

The Plan is a defined contribution profit-sharing plan covering eligible employees of Davidson Group, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Basis of Accounting

The financial statements are reported using the accrual basis of accounting in which revenue is recognized when earned or otherwise available, and expenses are recognized when incurred.

Investment Valuation and Income Recognition

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the statements of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Contributions receivable at year end are valued at cost, and represent contributions for the Plan years ended, which were received subsequent to the year end. Therefore, no allowance for doubtful accounts is deemed necessary.

Notes Receivable from Participants

Notes receivable from participants are recorded at unpaid principal balance at year end plus any unpaid accrued interest. Delinquent notes receivable from participants are reclassified as deemed distributions based upon the terms of the Plan document.

Payment of Benefits and Excess Contributions

Benefits are recorded when paid. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability on the statements of net assets available for benefits and as a deduction on the statements of changes in net assets available for benefits. The excess contributions payable for the year ending December 31, 2024 and 2023 were \$26,873 and \$36,951, respectively. Since the plan distributed these excess contributions to the applicable participants prior to the required due date, there was no excise tax liability.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 2 DESCRIPTION OF PLAN

The following brief description of Davidson Group, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Contributions

Employees become eligible to participate in the Plan upon attaining the age of 18. Financing of the Plan comes from employer and participant contributions and investment income. Rollover contributions by participants are permitted. Employer contributions, other than matching contributions, are allocated using a nonintegrated (prorata) allocation formula. In no event will the employer plus employee elective deferral contributions exceed the maximum amount permitted by law. The Board of Trustees of the Company determines annually, at its discretion, the amount of employer matching and non-elective contributions to be made to the Plan.

Participants may contribute up to 50% of eligible pre-tax compensation as defined in the Plan, subject to maximum annual additions allowed by law. Participants' contributions qualify for an employer discretionary matching contribution. For 2024 and 2023, the employer matched 100% of up to 2% of the eligible pre-tax compensation. There were no non-elective employer contributions made to the Plan for 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and employer matching contributions, as well as allocations of any employer non-elective contributions and Plan earnings. All investments are directed by the Plan participants.

Vesting

Participants are immediately 100 percent vested in employee contributions. The Company has a vesting period related to its employer contributions as follows:

Forfeitures

The non-vested portion of a terminated participant's account is forfeited when they receive a distribution of their entire vested account or after they have incurred five consecutive one year breaks in service. Forfeitures can be used to offset administrative expenses of the Plan and/or employer contributions to the Plan. Forfeitures available to offset future administrative expenses and/or future employer contributions totaled \$15,966 and \$11,305 at December 31, 2024 and 2023, respectively. Forfeitures used to reduce employer contributions during were \$0 for both December 31, 2024 and 2023.

Payment of Benefits

Benefit payments are made upon normal retirement, death, disability, or termination of service. The benefits are paid in a lump-sum payment or distributed in installments in accordance with the Plan document. The Plan also allows hardship withdrawals. The Plan has a mandatory cash out provision if the participant terminates employment and their vested account balance does not exceed \$5,000.

Notes Receivable from Participants

The Plan allows for participant loans. Participants may borrow from their accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans shall be for a fixed term of not more than five years, except a loan which shall be used to acquire any dwelling. If within a reasonable time, the dwelling is to be used as the principal residence of the borrower, a longer repayment term may be allowed. The loans are collateralized by no more than 50% of the vested balance in the participant's account and bear interest at a rate determined reasonable based on interest rates charged for similar types of loans by other lenders. Only one loan is permitted at a time.

Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets of the Plan will be allocated as prescribed by ERISA and regulations pursuant thereto.

NOTE 3 FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board authoritative guidance on fair value measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Collective Investment Trust: Valued at net asset value of shares held by the Plan at year end as determined by its sponsors.

All assets have been valued using a market approach, except as noted above.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 TAX STATUS

The Plan is an adoption of a prototype standardized profit-sharing plan and is qualified under Section 401(a) of the Internal Revenue Code plan. The Plan adopted the amendment and restatement of the previous prototype plan effective January 1, 2022.

The prototype plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 5 SUMMARY OF INFORMATION CERTIFIED BY PLAN TRUSTEE

The total value of investments held in trust was \$16,664,723 and \$14,224,286 at December 31, 2024 and 2023, respectively. The total amount of uninvested cash held in trust was \$0 and \$1 at December 31, 2024 and 2023, respectively.

The trustee, NBT Bank, N.A., has supplied the Plan's administrator with a certification as to the completeness and accuracy of all information regarding investment assets, transactions, and income presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 6 PARTIES-IN-INTEREST

A party-in-interest is defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. Plan assets are used to pay some expenses for administration of the Plan and the remaining administrative expenses are paid by the employer. Payments to such service providers by the Plan qualify as party-in-interest transactions.

NBT Bank, N.A., the Plan's trustee, also performs various administrative and recordkeeping functions for the Plan. Fees paid by the Plan to NBT Bank, N.A. were \$46,994 and \$39,330 during 2024 and 2023, respectively.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan may invest in various types of investment securities. Investment securities are exposed to various market risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 8 SUBSEQUENT EVENTS

The plan administrator has evaluated subsequent events through September 3, 2025, which is the date the financial statements were available to be issued.
