Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1 - Description of Plan

The following description of the Quantum Imaging & Therapeutic Associates, Inc. Profit Sharing & 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan covering employees of Quantum Imaging & Therapeutic Associates, Inc. (the "Company") who have completed a one year service requirement of 1,000 hours, reached the age of 21 and subject to certain other restrictions. Beginning in 2024, long-term, part-time employees who have completed three consecutive years of service (where the employee completes at least 500 hours of service) can participate in the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan has provisions for employee deferral contributions and qualified non-elective contributions, employer matching contributions and employer non-elective contributions.

In September 2021, the Plan was restated in which a new volume submitter plan document that Fidelity Management Trust Company ("Fidelity") updated was adopted to incorporate required amendments, regulatory changes and other enhancements.

The Board of Trustees is responsible for oversight of the Plan. The Company finance committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Administration of Plan assets

Fidelity serves as trustee and custodian for current Plan activity, such as where current employee and employer contributions are deposited and new participants are enrolled.

Note 1 - Description of Plan (continued)

Contributions

Each year, participants may contribute up to 80% of pretax annual compensation, as defined by the Plan. Participants may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participant contributions to the Plan are recorded in the period that payroll deductions are made from participants. The Company makes a safe harbor matching contribution equal to 100% of the participant's salary deferral contributions, up to a maximum of 5% of the participant's compensation, totaling \$1,023,767 and \$1,051,750 for the years ended December 31, 2024 and December 31, 2023, respectively. The Company may also contribute, at the sole discretion of its management, a Company profit sharing contribution. The Company made a profit sharing contribution of \$1,710,039 and \$1,819,096 for the years ended December 31, 2024 and December 31, 2023, respectively. Additionally, the Company may make a qualified non-elective contribution to non-highly compensated employees. The Company made a qualified non-elective contribution of \$15,898 and \$10,757 for the years ended December 31, 2024 and December 31, 2023, respectively. Contributions are subject to certain IRS limitations.

Participant contributions and loan remittances are credited to participant accounts within the time period prescribed in Department of Labor Regulation Section 2510.3-102(b). Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain limitations. Investment options include common and preferred stocks, corporate and municipal bonds, mutual funds, U.S. government securities and certificates of deposit.

Participant accounts

Each participant's account is credited with the participant's contribution and Company's contributions, as well as allocations of Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

All contributions, earnings on investments, and charges are recorded in separate accounts maintained for each participant. Participants generally can change their investment options.

Vesting

Participant contributions and employer contributions plus actual earnings are fully vested and non-forfeitable when made. If a participant dies before the start of retirement benefit payments, the full current value of the participant's account is payable to the beneficiary(ies) under the options offered by the Plan.

Rollovers

A participant may elect at the time and in a manner prescribed by the Plan administrator to have a portion of an eligible rollover distribution paid directly to an eligible retirement plan as described in IRC Section 457(b). The Plan permits transfers or rollovers from another qualified plan into the Plan, provided that all legal requirements with respect to the transfers are satisfied.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 3.25% to 8.50%, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence.

Payment of benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum distribution, the purchase of an annuity contract or choose to leave their balance in the account for withdrawal at a later point in time or receive annual installments required to satisfy required minimum distribution rules. Generally, a participant may elect to receive a distribution of the vested account balance upon termination of employment.

A participant can request a hardship distribution under the terms of the Plan, dependent upon an immediate and heavy financial need and the distribution is necessary to satisfy the need. The Plan defines an immediate and heavy financial need to include medical expenses, purchase of a principal residence, payment of educational related expenses, payments necessary to prevent eviction from a principal residence and other defined circumstances.

Note 1 - Description of Plan (continued)

Investment options

Upon enrollment in the Plan, a participant may direct participant contributions as well as employer contributions in approximately 30 investment options offered through Fidelity. The Plan's default investment fund is the Freedom Fund with the target date closest to the year in which the participant is estimated to retire, which is a targeted retirement date fund. In addition to the standard investment options offered through Fidelity, a participant may elect additional investment choices by participating in the Fidelity BrokerageLink investment option.

Note 2 - Summary of Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The finance committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and December 31, 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded. Loans are secured by participant accounts.

Allowance for Credit Losses

The plan provides an allowance for credit losses based on management's evaluation of year-end receivables. No allowance was deemed necessary at December 31, 2024 and 2023.

Payment of benefits

Benefits are recorded when paid. At December 31, 2024 and December 31, 2023, there were no benefits processed and approved for payment, but not paid.

Deemed distributions

A deemed distribution is a taxable event triggered by a failure to adhere to the terms of the notes receivable from participants, and is treated as a distribution for income tax purposes.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. All reasonable Plan administrative expenses may be paid from the assets of the Plan, to the extent permitted by the individual agreements. These expenses may be allocated among the Plan participants or, for expenses directly related to a participant such as recordkeeping fees, fees for processing distributions or loans, charged against their account balance. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

Management has evaluated subsequent events through September 3, 2025, the date the financial statements were available to be issued. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with generally accepted accounting principles in the United States of America. Management has determined that there are no nonrecognized subsequent events that require additional disclosure.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and December 31, 2023.

Changes in fair value levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and December 31, 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

Note 5 – Related Party Transactions

Certain Plan investments are managed by Fidelity, the trustee and custodian, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 - Tax Status

The Company has adopted a prototype plan document and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020. The letter states that the prototype and related trust are designed in accordance with applicable sections of the IRC. Although the prototype plan has been amended since receiving the opinion letter, the prototype sponsor and the Plan administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
