Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Enterprise 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Enterprise 401(k) Plan's (the Plan) financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

NOTE A BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

General - The Enterprise 401(k) Plan (the Plan) was adopted effective July 1, 1990 and restated January 1, 2014 to establish a savings and investment plan for the exclusive benefit of the employees of Enterprise Products Company (the Company) and their beneficiaries. The Plan Sponsor for the Plan is Enterprise Products Company. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Basis of Presentation - The Plan's financial statements are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States (GAAP). Interest and dividend income are recognized when earned.

Estimates - The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan provides for several investment options which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Valuation of Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In accordance with the policy of stating investments at fair value, net investment gain or loss is included in the carrying value of related investments in the statements of net assets available for plan benefits and the changes in the net investment gain or loss are reflected in the statement of changes in net assets available for plan benefits. See Note D for discussion of fair value measurements.

Notes Receivable from Participants - Loans to participants are reported as a receivable from participants at the unpaid principal balance plus any accrued but unpaid interest.

Federal Income Tax - The Internal Revenue Service informed the Plan Administrator, by letter dated May 14, 2013, that a favorable determination on the Plan's design had been made on the Plan, and the Plan is tax exempt. The Plan has been amended since the determination letter was obtained. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, the Plan Administrator believes the Plan was qualified and the related trust was tax-exempt as of December 31, 2024 and 2023.

The Plan believes that all significant tax positions utilized by the Plan will more likely than not be sustained upon examination. As of December 31, 2024, the tax years that remain subject to examination by the major tax jurisdictions under the statute of limitations are from the year 2021 forward (with limited exceptions). Tax penalties and interest, if any, would be accrued as incurred and would be classified as tax expense in the statement of changes in net assets available for plan benefits.

NOTE A BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES
(CONTINUED)

Subsequent Events - The Plan has evaluated subsequent events through August 26, 2025, the date the financial statements were available to be issued. No subsequent events occurred which require adjustment or additional disclosure to the financial statements at December 31, 2024.

NOTE B PLAN DESCRIPTION

The following description of the Plan provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Participation - To participate in the Plan an employee must be included in the eligible class. Eligible class as defined by the Plan is an employee that is employed by the Sponsor, is not a member or represented by a collective bargaining agreement, is not a nonresident alien, and is not a leased employee or independent contractor. An employee in the eligible class is eligible to become a participant in the Plan on the first entry date after the date of hire. An individual who becomes an employee in the eligible class either as a result of (i) a transfer from an affiliate to the Company, or (ii) the acquisition of an entity or a business operation may become a participant on the date the individual becomes an employee in the eligible class.

Contributions - Participants may elect to make pretax contributions to the Plan in an annual amount up to 75% of their compensation, limited to \$23,000 for 2024. This limitation is adjusted periodically to reflect cost-of-living increases. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 for 2024). During 2024, the Company contributed a matching contribution equal to 100% of each participant's contribution limited to 6% of eligible compensation.

The employer shall contribute to the post-2013 profit sharing account of each eligible participant an amount equal to a percentage of their eligible compensation for that pay period, based on years of service as follows:

<u>Years of Service</u>	<u>Contribution Percentage</u>
Less than 10	4%
10, but less than 20	5%
20 or more	6%

Eligible compensation is limited to \$345,000 for 2024.

Participant Accounts - Each participant's account is credited with the participant's contribution, the Company's contributions and earnings attributable to each participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE B PLAN DESCRIPTION (CONTINUED)

Vesting - A participant is immediately fully vested with respect to the portion of the participant's account attributable to participant contributions, rollover contributions, employer matching contributions, and pre-2008 profit sharing contributions. Vesting in a participant's post-2013 profit sharing account shall be determined based on years of service in accordance with the following schedule:

<u>Year of Service</u>	<u>Vested Percentage</u>
Less than 3	0%
3 or more	100%

Regardless of period of service, an employee who is a participant in the profit sharing component on or after reaching their retirement age shall be 100% vested in their post-2013 profit sharing account.

Forfeitures - Forfeited employer contributions and the related earnings will be used to reduce future employer contributions, if not used to pay Plan expenses. Forfeitures of \$1,512,645 were used to reduce employer matching contributions and profit sharing contributions for the year ended December 31, 2024. The amount of forfeitures available to offset future employer contributions at December 31, 2024 was \$392.

Investments - Each participant directs the investment of their account into any of the available investment options designated by the Plan Administrator.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as transfers between the investment fund and participant loans receivable. Loan terms range from 1 to 5 years, with the exception of those participants whose loans rolled in from a prior employer's plan with original maturities of up to 15 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates. Interest rates on loans outstanding at December 31, 2024 range from 4.25% to 10.50%. Principal and interest is paid ratably through payroll deductions.

Forms of Benefits - The normal form of benefit payable under this Plan is a lump sum. If the amount payable is \$1,000 or less, the participant may receive a lump sum distribution as soon as feasible following the date of termination. If the amount payable is greater than \$1,000 but less than or equal to \$7,000, the participant's vested account balance will be directly rolled over as soon as practical, after notice to the participant, into an individual retirement account maintained by an entity selected by the Company. If the amount payable is greater than \$7,000, the participant must give written consent before the distribution can be made.

Administration - Five members of Company management comprise the Administrative Committee for the Plan. The Company is the Plan Administrator and Plan Sponsor. Any Plan expenses shall be paid by the Plan, and the Plan Sponsor is not obligated, but in its discretion may elect to pay some or all of the expenses.

Plan Termination - Although the Company has not expressed intent to do so, it has the right under the Plan to terminate the Plan subject to provisions set forth in ERISA. Upon termination, all participants would become fully vested in their account balances as of the date of termination.

NOTE D FAIR VALUE DISCLOSURES

GAAP provides a framework for measuring fair value using a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value based upon whether the inputs to those valuation techniques are observable or unobservable. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical financial instruments and the lowest priority to unobservable inputs. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. These inputs are summarized in the three broad levels listed below:

Level 1 – Unadjusted quoted prices for identical financial instruments in active markets that the Plan has the ability to access.

Level 2 – Other significant observable inputs (including quoted prices in active and inactive markets for similar financial instruments), or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the financial instruments.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the financial instruments. The fair value of Level 3 financial instruments is determined using pricing models or similar techniques which require significant management judgment or estimation.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during 2024 and 2023.

Registered investment companies and interest bearing cash are valued at the market value of shares held by the Plan at year end.

Common collective trusts are valued by the trustee of the funds based upon the market value of shares or the net asset value provided by the issuer, calculated as the value of the underlying assets owned by the funds, less its liabilities divided by the number of shares outstanding.

Self-directed brokerage accounts include corporate bonds, common and preferred stocks, registered investment companies, and interest and non-interest bearing cash. Corporate bonds are valued by the asset manager. Observable inputs used to value these securities can also include, but are not limited to, reported trades, benchmark yields, issuer spreads, and non-binding broker quotes. Common and preferred stocks are valued at the closing price reported by the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
