Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of North Star Resource Group Salary Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of North Star Resource Group Salary Savings Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

NOTE 1 DESCRIPTION OF PLAN

The following description of North Star Resource Group Salary Savings Plan and Trust (the Plan) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 1991 and amended and restated throughout the years to comply with tax legislation. The Plan was last restated effective March 1, 2022 and last amended effective January 1, 2022 to change the Plan to a safe harbor Plan and change the automatic escalation rates. The Plan covers all employees of North Star Consultant's, Inc. (Employer), who have attained age 21 and have completed 30 days of service. The Plan excludes employees covered by collective bargaining agreements, nonresident aliens and part-time, temporary, and seasonal employees whose regularly scheduled service is less than 1,000 hours of service and were hired or rehired on or after January 1, 2010. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees are responsible for the oversight of the Plan.

Contributions

The Plan includes a cash or deferred arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or after-tax Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. In addition, the Plan includes an auto escalation provision where employee pre-tax deferrals are increased by 1% up to 15% of compensation on the first day of each Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Employer did not authorize a profit sharing contribution for the years ended December 31, 2024 and 2023. In order to be eligible for profit sharing contributions, participants must be employed on the last day of the Plan year and complete one year of service unless termination is due to death, permanent disability, or retirement.

The Company has a QACA safe harbor matching contribution to be 100% of the first 1% of the participant's deferral contributions plus 50% of the participant's deferral contributions that exceed 1% but do not exceed 6%.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into the various investment options offered under the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's deferral contributions, the Employer discretionary contributions, the QACA safe harbor matching contribution, and an allocation of Plan earnings or losses. Employer matching contributions and QACA safe harbor matching contributions are allocated to a participant based on a percentage of the participant's salary deferral contributions. Employer profit sharing contributions are allocated based on compensation. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral contributions plus actual earnings thereon. Vesting for the QACA safe harbor matching contribution plus actual earnings thereon is 100% after two years of continuous service. Vesting in the Employer's matching and profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is vested at a rate of 20% per year of service, starting with the first year of service, and is 100% vested after the completion of five years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age (65), death, or permanent disability. A participant's service prior to the attainment of age 18 is excluded for vesting purposes.

Payment of Benefits

Upon termination of service due to death, disability, or normal retirement, a participant may receive the value of the vested interest in their account in the form of a lump-sum payment or partial withdrawals. The Plan permits in-service distributions at age 59½ subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, or \$7,000 (effective in 2024), the Plan administrator will authorize the benefit payment without the participant's consent and may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The note terms may not exceed five years unless the note is for the purchase of a principal residence. A participant may have up to three notes outstanding at any time. The notes are secured by the vested balance in the participant's account and bear interest at reasonable rates established by the Plan administrator. Principal and interest is paid ratably through ACH transfers directly from the participant's bank account to the Plan's recordkeeper.

Forfeited Accounts

Forfeited nonvested accounts are first used to pay the Plan's ordinary administrative expenses. Any remaining forfeitures may be used to reduce any future Employer contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$54,133 and \$49,415, respectively. Forfeitures used to pay administrative expenses were \$5,154 and \$7,498 for the years ended December 31, 2024 and 2023, respectively. Forfeitures used to reduce Employer contributions were \$16,638 and \$13,284 for the years ended December 31, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Benefit Payments

Benefit payments are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

The Standard Insurance Company, the current qualified institution, has certified to the completeness and accuracy of the notes receivable from participants and all investment information reflected on the accompanying statement of net assets available for benefits as of December 31, 2024, the statement of changes in net assets available for the year then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Minnesota Life Insurance Company, the former qualified institution, has supplied the Plan administrator with a certification as to the completeness and accuracy of all notes receivable from participants and investment information reflected on the accompanying statement of net assets available for benefits as of December 31, 2023 and the statement of changes in net assets available for benefits for the year then ended.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

General Account: The insurance company general account is not fully benefit responsive and is valued by Minnesota Life Insurance Company at fair value. Fair value is determined by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan entered into a traditional investment contract with Minnesota Life Insurance Company (Minnesota Life). Minnesota Life maintains the contributions as directed by participants in separate accounts or a general account. The general account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Minnesota Life. Due to transfer restrictions within the contract, it is not deemed to be fully benefit-responsive and is valued at fair value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations.

The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer accounts.

NOTE 7 PLAN TAX STATUS

The Employer adopted a non-standardized prototype plan sponsored by Minnesota Life. The document is pre-approved as evidenced by an opinion letter from the IRS dated June 30, 2020, which stated that the pre-approved language of the prototype is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 RELATED PARTY TRANSACTIONS

The Plan investments and notes receivable are managed by The Standard Insurance Company (The Standard) as of and for the year ended December 31, 2024 and were managed by Minnesota Life Insurance Company as of and for the year ended December 31, 2023. Therefore, these transactions qualify as party-in-interest. The Plan paid \$13,556 to The Standard for administrative services for the year ended December 31, 2024, and \$12,584 to Minnesota Life Insurance Company for the year ended December 31, 2023.
