NOTE A - DESCRIPTION OF PLAN

The following description of the Bush Auto Group Retirement Fund (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, sponsored by Infiniti of West Chester, Inc. (the "Company"), is a qualified defined contribution multiple employer plan which allows eligible employees of Infinity of West Chester, Inc., Chester County Nissan LLC dba Exton Nissan, Nissan 422 LLC, and Bush Auto Brokers, LLC, the participating employers, to contribute on a pretax or Roth basis towards their own retirement, and permits additional contributions by the Company. In order for employees to be eligible to participate in the Plan, they must be at least 21 years of age and fulfill one year of service, as defined in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Company has appointed an individual as Plan trustee. On December 31, 2024 and 2023, the assets of the Plan were held by Nationwide Trust Company.

Contributions

Each year, eligible participants may contribute up to the maximum dollar amount permissible under the Internal Revenue Code. Participant deferrals cannot exceed the maximum contribution allowed by law. The Company's matching contribution will be 25% of participants' deferral up to a maximum of 4% for eligible participants. Participants who are age 50 and older and contribute the maximum permitted under the Plan may elect to defer additional amounts (called "catch-up contributions") of up to the maximum allowed by law. Salary deferrals that are catch-up contributions will not be matched by the employer. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

Discretionary matching contributions may be made at the discretion of the Company not to exceed 4% of participant's compensation. There were no Company discretionary contributions for the year ended December 31, 2024.

Participation

An employee may become a participant of the Plan on the first day of the Plan Year or the first day of the seventh month coincident with or next following the date the employee attains age 21 and completes one (1) Year of Eligibility Service. Year of Eligibility means an Eligibility Computation Period during which an employee works a consecutive twelve-month period beginning with the employee's first day of employment and in which the employee completes at least 1,000 hours of service.

Participant Accounts

A separate investment account is maintained for each Plan participant. Participants may direct the investment of their accounts into various funds specified by the Plan. Participant accounts are credited with the participant’s contribution, an allocation of the Company’s matching contribution and an allocation of plan earnings/(losses) and are charged with an allocation of administrative expenses, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Upon enrollment in the Plan, participants may direct their contributions and Employer contributions in a variety of investment options.

Vesting

Participants are immediately 100% vested in their own contributions to the plan plus earnings/(losses). Vesting in the Company’s match and non-elective discretionary contributions and earnings is as follows:

Less than three years	0%
Three or more years	100%

Regardless of the vesting schedule, a participant will become fully vested upon death, disability, and at normal retirement age.

Forfeitures

Employees who terminate employment and are not vested will forfeit the nonvested portion of their account balance to the Plan as specified in the Adoption Agreement. Forfeitures will be applied to reduce employer contributions or pay plan expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$576. Forfeitures are maintained in an account separate from the individual participant accounts. During 2024, no forfeitures were used to pay plan expenses or to reduce employer contributions.

Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be fully repaid through payroll deductions within 5 years unless the loan is used to purchase the participant's primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1.50%. Interest rate on existing loans range from 4.75% to 10.00%, as of December 31, 2024. Principal and interest are paid ratably through payroll deductions. The maximum number of loans outstanding at any one time is one.

Payment of Benefits

Participants are eligible to receive a distribution of the vested portion of their individual account balance in the event of death, disability, termination of employment, a proven hardship, retirement, or attainment of age 59-1/2 while still employed. A participant (or participant's beneficiary in the event of death) receives an amount equal to the value of the participant's vested interest in their account in the form of a lump-sum payment. The normal retirement age under this Plan is 65.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their share of Company discretionary matching and profit sharing contributions.

Plan Amendments

On December 29, 2022, the "Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act" was signed into law in the United States. The Secure 2.0 Act is an expansion of the Secure Act passed during 2019. The Act includes several mandatory and optional provisions that will become effective across several years. The Secure 2.0 Act aims to expand retirement access, increase retirement savings, and simplify plan administration. Plans may choose to operationally implement the provisions of the Secure 2.0 Act, however plan administrators have until December 31, 2026 to officially amend the plan document to reflect the provisions adopted by the plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments

Plan investments in mutual funds are stated at fair value at December 31, 2024 and 2023. Quoted market prices are used to value investments. Net appreciation or depreciation of investments is reported on the statement of changes in net assets available for benefits and consists of realized gains and losses and the unrealized appreciation or depreciation of these investments. All underlying investments options are valued daily. This daily price is considered the selling price for transfers and withdrawals and is calculated each day the principal market is open and available to any participant in the Plan.

Purchases and sales of mutual funds are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded as of the ex-dividend date.

Investment Income Recognition and Method of Accounting

All transactions are recorded on the accrual basis. Purchases and sales of investments are recorded based on the trade date. Interest and dividends are recorded when received. Capital gain distributions are included in dividend income. Realized gain or losses- on security transactions are determined using the average cost of securities sold on the trade date. Expenses are recorded as incurred.

Benefit Payments

Benefit payments to participants are recorded when paid.

Party-in-Interest Transactions

Certain investments of the Plan are managed by the custodian. Also, certain participants have outstanding loans with the Plan as of December 31, 2024 and 2023. These transactions qualify as party-in-interest transactions allowable under ERISA guidelines.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company. Investment and recordkeeping expenses are paid by the Plan and/or the participants to the extent that such expenses are not paid by the Company. Any investment expenses associated with the Plan's investments are netted with earnings/(losses) by Nationwide Trust Company, the Plan's custodian, and reported to the Plan as a net amount. Distribution administration fees paid by participants, in combination with administrative fees totaling \$10,683 for the year ended December 31, 2024, are reflected on the Plan's statement of changes in net assets available for benefits.

Excess Contributions Payable

Contributions for the years ended December 31, 2024 and December 31, 2023, are net of payments of \$0 and \$22,839, respectively, to be made during the following plan year to certain active participants to return excess contributions as required to satisfy the relevant nondiscrimination provisions of the plan. These amounts are included in the Plan's statements of net assets available for benefits as excess contributions payable at December 31, 2024 and December 31, 2023. The excess contribution payments are also reflected in the statement of net assets available for benefits and in Note G – reconciliation of financial statements to the Form 5500.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Participant accounts are charged with an allocation of certain administrative expenses, such as recordkeeping fees, that are paid by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Date of Management's Review

Management has evaluated subsequent events through August 21, 2025, the date which the financial statements were available to be issued.

NOTE C - FAIR VALUE MEASUREMENTS

FASB ASC 820 establishes a framework for measuring fair value. That framework provided a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs are other than quoted prices that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument.

Level 3 inputs are unobservable inputs based on the Plan’s assumptions used to measure assets and liabilities at fair value. The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds have quoted prices for identical assets in active markets; therefore, the investments are measured at fair value using these readily available Level 1 inputs.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Under that section, no auditing procedures are required to be performed with respect to the investment information certified by the custodian of the Plan, Nationwide Trust Company, other than comparing such information to that contained in the financial statements and schedule.

NOTE E - TAX STATUS

The Plan has adopted a volume submitter document with an IRS favorable opinion letter dated June 30, 2020, which stated the volume submitter plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan, as amended, is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however; there are currently no audits for any tax periods in progress.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
