Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedule of the Schedule of Assets Held for Investment Purposes as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included

in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### Notes to Financial Statements

#### Note 1 – Plan Description

The following description of the Denmar Associates, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan, established January 1, 2002, is a defined contribution plan covering all eligible employees of Denmar Associates, LLC (the Company) and provides for retirement, death, and disability benefits. Employees of the Company who have completed 3 months of service and have attained the age of 18 are eligible to participate in the Plan. The plan administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan’s offerings and monitors investment performance.

In April 2023, the Plan was formally amended to change the service eligibility requirement from one year of service to 3 months of service and the employer matching contribution was increased from matching 25% up to a total of 4% of eligible compensation to 50% up to a total of 4% of eligible compensation. Additionally, the Plan was amended to decrease the number of years for participants to become fully vested in employer contributions from six years of credited service to four years of credited service.

Contributions – Eligible participants may contribute up to 100% of eligible compensation, not to exceed the annual amount permitted by Federal law. Eligible employees are automatically enrolled at 4% of compensation to be deferred to the Plan. Catch-up contributions are permitted for eligible participants age 50 or older by the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company matches participant contributions to the Plan. Beginning in April of 2023, the Company matched 50% of employee elective deferrals up to a maximum of 4% of compensation. For the period beginning January of 2023 through March of 2023, the Company matched 25% of employee elective deferrals up to a maximum of 4% of compensation. The Company made matching contributions of \$446,206 and \$338,985 for the years ended December 31, 2024 and 2023, respectively.

The Company may also make a discretionary employer profit sharing contribution at the option of its Board of Directors. There were no such profit sharing contributions made for the years ended December 31, 2024 and 2023. Additionally, the Company may make a qualified non-elective contribution that is sufficient to satisfy certain required regulations. There were no such qualified non-elective contributions made for the years ended December 31, 2024 and 2023.

Participant Accounts – Each participant's account is credited with the participant's contribution and the participant's share of the employer contributions, an allocation of Plan earnings or losses based on the participant's directed investment accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investments for their account.

### Notes to Financial Statements

#### **Note 1 – Plan Description – Continued**

Vesting – Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Participants are vested in employer contributions based on years of continuous service as follows:

<u>Years of Vesting Service</u>	
1 year	25%
2 years	50%
3 years	75%
4 years	100%

Payment of Benefits – Upon termination of service, a participant may elect to receive either a lump-sum distribution equal to the vested value of his or her account or a partial distribution. Automatic distributions will be made to terminated participants with vested balances less than \$1,000. If a terminated participant's vested balance is in excess of \$1,000 but not greater than \$5,000, the plan administrator will make the distributions to an individual retirement account (IRA) absent a distribution directive from the participant. If the terminated participant's vested account balance exceeds \$5,000, a written request from the participant is required before distribution. A participant may also elect to have the amount rolled into an IRA or another qualified plan.

Hardship withdrawals are permitted from fully vested employee deferral accounts. In-service distributions are permitted for participants who have reached age 59 ½.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account. The interest rate charged will be a rate reasonable at the time of application, considering the purpose of the loan and the rate being charged by representative commercial banks in the area for a similar loan (3.74%-8.74%). Principal and interest are paid ratably through payroll deductions. Loan origination fees and monthly maintenance fees are charged and financed with the loan.

Forfeitures – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10,581 and \$8,295, respectively. These amounts can be used to reduce Plan administrative expenses or reduce employer contributions. Forfeitures used to reduce employer contributions totaled \$8,295 and \$4,301 for the years ended December 31, 2024 and 2023, respectively.

#### **Note 2 – Significant Accounting Policies**

Basis of Accounting – The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Notes to Financial Statements

#### **Note 2 – Significant Accounting Policies – Continued**

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value as determined and certified by the Plan's trustee. Mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. The money market funds are valued at the quoted redemption value at year end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Investment income is recorded on the accrual basis. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statements of changes in net assets available for benefits.

Subsequent Events – Events that occurred subsequent to December 31, 2024 have been evaluated by the Plan's management through August 20, 2025 which is the date the financial statements were available to be issued.

#### **Note 3 – New Accounting Standards**

Pronouncements issued by the Financial Accounting Standards Board (FASB) with future effective dates are either not applicable or are not expected to be significant to the Plan's financial statements.

#### **Note 4 – Investments**

During the years ended December 31, 2024 and 2023, the Plan's investments (including gains and losses on investments bought, sold, and held during the year) appreciated in value by \$1,283,052 and \$1,527,453, respectively.

#### **Note 5 – Fair Value Measurements**

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

#### Note 5 – Fair Value Measurements – Continued

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Funds:* Valued at the quoted redemption price at year end.

*Mutual Funds:* Valued at quoted market prices, which represent the net asset value ("NAV") of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination or partial plan termination, participants will become 100 percent vested in their accounts.

#### **Note 7 – Parties-In-Interest Transactions**

Administrative expenses were paid to Matrix Trust Company for the period from June 9, 2023 to December 31, 2024. Matrix Trust Company is the trustee and record keeper as defined by the Plan. Administrative expenses were paid to Fulton Bank, N.A. for the period from January 1, 2023 to June 8, 2023, when Fulton Bank, N.A. was the trustee and record keeper as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Administrative expenses, net of rebates, paid to Matrix Trust Company and Fulton Bank, N.A. by the Plan totaled \$63,759 and \$47,470 for the years ended December 31, 2024 and 2023, respectively.

The Plan may issue loans to participants that are secured by participant account balances. All of these transactions qualify as party-in-interest transactions.

#### **Note 8 – Tax Status**

The Company adopted a Non-Standardized Prototype Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020. The opinion letter stated that the Prototype Plan, as then designed, is in accordance with applicable sections of the Internal Revenue Code (IRC). The prototype has been amended since receiving the determination letter for various amendments. However, the plan administrator and third-party administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan continues to be tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and the Department of Labor. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 9 – Information Prepared and Certified by Trustees**

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Matrix Trust Company and Fulton Bank, N.A., the trustees.

#### **Note 10 – Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
