**Note 1 - Description of the Plan**

The following description of the Trinity 401(k) Plan and Trust (the Plan) provides general information only. Participants should refer to the plan document for complete information regarding the Plan’s definitions, benefits, eligibility, and other matters.

**General** - The Plan is a defined contribution plan that was established effective January 1, 2004, for the benefit of employees of Trinity Glass International, Inc. (the Sponsor). All employees at least 18 years of age become eligible to participate in the Plan on January 1<sup>st</sup>, April 1<sup>st</sup>, July 1<sup>st</sup> or October 1<sup>st</sup> following the completion of six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions** - Participants may contribute to the Plan through voluntary deferrals of eligible compensation. Eligible employees may contribute from 1% to 100% of their eligible compensation as pre-tax contributions or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible defined benefit or defined contribution plans (rollover).

The Sponsor, at its sole discretion, may make a matching contribution which would equal a percentage of a participant’s voluntary deferrals. For the year ended December 31, 2024, management elected to make a matching contribution equal to 50% of the participant’s salary deferral contributions up to 6% of eligible compensation. The Sponsor may also elect to make a discretionary profit-sharing contribution. To be eligible for this contribution, an employee must be eligible to participate in the Plan and be actively employed on the last day of the plan year. This contribution is allocated to the participant accounts based on the ratio of the individual participant’s compensation to total compensation of all participants. For the year ended December 31, 2024, no profit-sharing contributions were authorized or provided.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts** - Each participant’s account is credited with the participant’s contributions and matching contributions, as well as allocations of the Company’s profit-sharing contributions (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** - Participants are immediately vested in their voluntary salary deferral contributions plus actual earnings thereon. Vesting in the Sponsor’s discretionary matching and profit-sharing contributions is based on years of continuous service as follows:

**Forfeited Accounts** - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$11,000 and \$17,000, respectively. During 2024, \$35,000 in forfeited accounts were used in accordance with the provisions specified in the Plan document.

**Payment of Benefits** - Upon termination of service, death, disability, or retirement, a participant may elect to receive a distribution of their vested account balance in the form of a lump-sum payment. Participants who have attained age 59½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document.

#### Note 2 - Significant Accounting Policies

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities with disclosure on contingent assets and liabilities at the date of financial statements and reported amounts of additions to or deductions from plan assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments represents the change in fair value of assets from one period to the next and realized gains and losses on investments.

**Excess Contributions Payable** - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants before March 15, 2024.

**Benefits Paid to Participants** - Benefits paid to participants are recognized when paid.

**Administrative Expenses** - Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Administrative costs for investment consulting and custodian services are paid by the Plan. The Sponsor may elect to pay other expenses related to the Plan's administration. Expenses that are paid by the Sponsor are excluded from these financial statements.

**Subsequent Events** - The Plan's management has evaluated subsequent events through September 4, 2025, the date on which the Plan's financial statements were available to be issued. Subsequent to year end, the Plan's management and those charged with governance approved a change in the Plan's asset custodian and recordkeeper. The change is expected to be completed in September of 2025. No significant changes to plan provisions are expected as a result of this change.

#### Note 3 - Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1 - Unadjusted quoted prices available in active markets for identical assets or liabilities;

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. As of December 31, 2024 and 2023, there were no assets held by the Plan subject to the fair value hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled Separate Accounts - The fair value of participation units in the pooled separate accounts is determined by Voya Retirement Insurance and Annuity Company (Voya) based on the valuation of the underlying investments at the end of the year. Net asset value (NAV) per unit is used as a practical expedient for measuring fair value. Participant transactions (purchases and sales) may occur daily. Participants eligible to receive benefit payments may withdraw the value of their pooled separate accounts, in whole or in part, at any time without penalty. There are no participant redemption restrictions for these investments. However, if the Sponsor terminates the group annuity contract with Voya, redemption restrictions may apply to the pooled separate accounts.

#### Note 4 - Fully Benefit-Responsive Investment Contracts

The Plan invests in a guaranteed interest account which are fully-benefit responsive insurance contracts with Voya. Contributions to the guaranteed interest account are invested in the Voya Fixed Account (the FA) and maintained in an unallocated fund. The FA is commingled with the general assets of Voya. The FA is credited with earnings of the underlying investments and charged for plan withdrawals and administrative expenses charged by Voya.

Because the guaranteed investment account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value.

#### Note 5 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Voya Retirement Insurance and Annuity Company, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

#### Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

#### Note 7 - Income Taxes

The Company adopted an Ascensus LLC pre-approved plan document. Ascensus LLC received an approval letter from the IRS dated June 30, 2020, which states that the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

#### **Note 8 - Party-in-Interest Transactions**

The Plan invests in funds managed by an affiliate of Voya. Voya is the custodian of the Plan and, therefore, investment transactions with these funds qualify as party-in-interest transactions. In addition, Future Plan is contracted to provide recordkeeping services for the Plan. The Plan pays certain expenses related to plan operations to various service providers. These transactions are party-in-interest transactions.

#### **Note 9 - Risks and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
