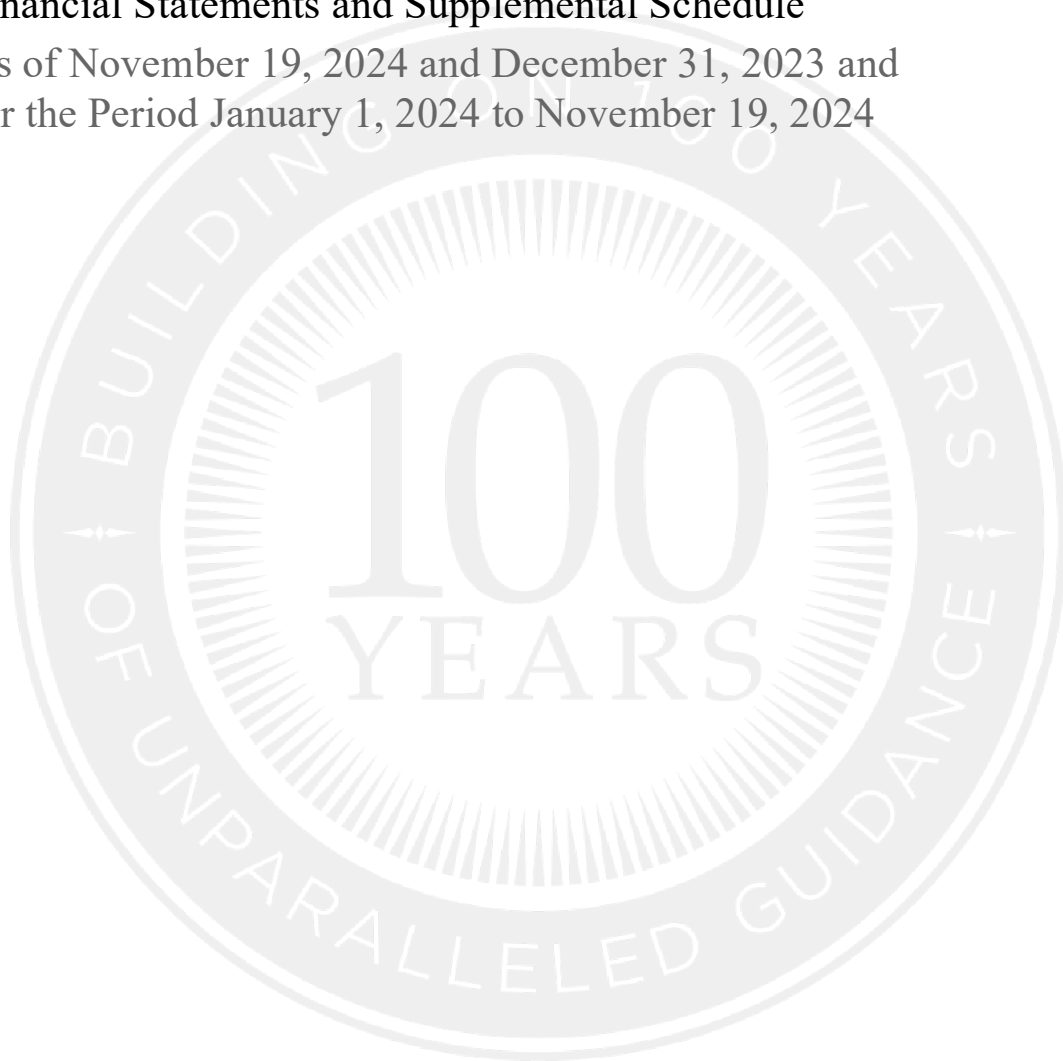

To the Plan Administrator of Connectus Wealth, LLC 401(k) Retirement Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of Connectus Wealth, LLC 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of November 19, 2024, the related statement of changes in net assets available for benefits for the period January 1, 2024 to November 19, 2024, and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to, any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of November 19, 2024 and for the period January 1, 2024 to November 19, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion on the 2024 Financial Statements***

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion on the 2024 Financial Statements***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

***Emphasis of Matter—Plan Termination and Liquidation Basis***

As discussed in Note 1 to the financial statements, the Board of Directors of Connecticut Wealth, LLC, the Plan's sponsor, voted on June 1, 2024 to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditor's Responsibilities for the Audit of the 2024 Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - 2023 Financial Statements***

We performed a compilation engagement with respect to the 2023 financial statements, we did not audit or review those financial statements and, accordingly, express no opinion or other form of assurance on them.

## Notes to Financial Statements

As of November 19, 2024 and December 31, 2023 and for the Period January 1, 2024 to November 19, 2024

### 1. DESCRIPTION OF PLAN

The following description of the Connectus Wealth, LLC 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering all employees of Connectus Wealth, LLC (the “Company”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan was established effective as of January 1, 2021.

The Plan's trustee is Charles Schwab Trust Bank. The Plan's recordkeeper is Sentinel Benefits Group.

Effective June 1, 2024, the Company was acquired by The Colony Group, LLC. The Plan merged into two plans. During 2024, the Plan assets were transferred to the Kovitz Investment Group Partners, LLC Employees’ Retirement Plan and The Colony Group, LLC 401(k) Profit Sharing Plan. The merger does not impact participant benefits as the benefit provisions were incorporated into the Kovitz Investment Group Partners, LLC Employees’ Retirement Plan and The Colony Group, LLC 401(k) Profit Sharing Plan.

#### *Eligibility*

The Plan states that employees of the Company are eligible to participate in the Plan upon attainment of age 21. Union employees, nonresident aliens, and interns are excluded from participating in the Plan.

#### *Contributions*

Participants may defer pre-tax and post-tax (ROTH) contributions to be made to the Plan through reduction of their compensation as defined in the Plan in amounts up to 100% of their eligible compensation, subject to certain limits under the Internal Revenue Code (the Code). Participants who are projected to be age 50 or older by the end of the calendar year may also make additional “catch up” contributions subject to limits under the Code. Rollovers from qualified plans are permitted.

Participants are eligible the first day of the month coinciding with attaining age 21 for Company safe harbor nonelective contributions at 3% of participant deferral contributions.

Discretionary employer matching contributions may be made as determined by the Company. Participants are eligible for the matching contributions upon attainment of age 21, completion of a year of service, as defined in the Plan agreement, and employed on the last day of the Plan year. A participant who becomes disabled, retired, or died during the Plan year is eligible for the employer match.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

## ***Participant Accounts***

A separate account is established for each participant at the time of enrollment in the plan. Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses and Plan losses.

Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## ***Vesting***

Participants are immediately 100% vested in their elective contributions plus cumulative earnings thereon. Participants vest in the Company's contributions (safe harbor nonelective and discretionary employer matching) and the cumulative earnings thereon as follows: after one year of service, 25%; after two years of service, 50%; after three years of service, 75%; after four years of service, 100%. Upon death or disability, participants become 100% vested in their accounts.

## ***Forfeitures***

Any non-vested amounts attributable to Company contributions shall be forfeited after a participant terminates employment. The forfeiture will occur in the Plan year that the participant receives a distribution of their entire vested account, or after five consecutive one-year breaks in service. In accordance with Plan provisions, forfeitures are to be used to pay administrative expenses and reduce future Company contributions to the Plan. At November 19, 2024 and December 31, 2023, there were no forfeited non-vested accounts.

## ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions. A participant may have one loan outstanding at any time.

## ***Payments of Benefits***

Participants (or their beneficiaries) shall become eligible to receive their vested account and balances upon retirement (normal retirement age is 65), death, disability or

termination. Participants or their beneficiary may elect to receive their benefit payments as a lump-sum payment. Distributions can also be made as in-service withdrawals upon attaining age fifty-nine and a half.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### *Basis of Accounting*

Due to the decision to terminate the Plan during 2024, management determined that liquidation of the Plan is imminent and the financial statements for 2024 have been prepared using the liquidation basis of accounting. The 2023 financial statements were prepared as a going concern on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on an ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default based upon the terms of the plan document, the participant loan balance is reduced and a benefit payment is recorded.

### *Contributions*

Contributions from Plan participants and the Company matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

### *Payment of Benefits*

Benefits are recorded when paid.

## *Administrative Expenses*

Certain expenses of the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

### **3. CERTIFIED INVESTMENT INFORMATION**

Certain information in the accompanying financial statements and notes receivable from participants held as of November 19, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2024 to November 19, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (the Trustee), a qualified institution.

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 19, 2024 and December 31, 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust Fund:* The investments in the common collective trust funds can be redeemed immediately at the current NAV. The NAV as reported by the Trustee is used as a practical expedient to estimate fair value, which is based on the fair value of the underlying assets in the trust, less its liabilities. These investments are direct filing entities. The underlying assets of the common collective trust funds include conventional investment contracts, synthetic investment contracts, wrap contracts and other investments. There are no withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for these investments as of November 19, 2024 or December 31, 2023.

There were no investments held by the Plan as of November 19, 2024. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023.

### 5. INCOME TAX STATUS

The Plan adopted the Sentinel Benefits Group Inc (Sentinel) Non Standardized Defined Contribution Pre Approved plan with CODA. The IRS has determined and informed Sentinel by letter dated November 30, 2020 that the Plan is designed in accordance with the applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

# Connectus Wealth, LLC 401(k) Retirement Plan

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor (“DOL”). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 19, 2024 and December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to tax examinations since inception.

## 6. RELATED-PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Trustee and Sentinel is the Plan’s recordkeeper; therefore, these transactions qualify as party-in-interest transactions. The Plan paid Sentinel \$5,337 during 2024 related to recordkeeping fees.
