1) Description of Plan

The following description of the Ute Mountain Ute Tribe Enterprise 401(k) Plan (the “Plan”) is provided for general information purposes only. Plan participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Casino and Travel Center who have satisfied the eligibility requirements. Full-time employees are eligible to participate after completing 90 days of eligibility service and all other employees of the participating employer are eligible to participate after completing one year of service.

Effective January 1, 2007, the Plan was spun-off from the Ute Mountain Ute Tribe Governmental 401(k) Plan, in connection with the Sponsor’s reasonable and good faith efforts to comply with Section 906 of the Pension Protection Act of 2006 (PPA). Although the Sponsor maintains that the Plan may be entitled to governmental status following the passage of the PPA, the Plan is documented, operated and maintained as a non-governmental plan compliant with the Employee Retirement Income Security Act of 1974 (ERISA). The Sponsor reserves its right to assert governmental status for the Plan, pending further guidance under the PPA from the U.S. Departments of Treasury and Labor. The Sponsor has not waived its sovereign immunity in connection with the Plan, and neither any provision of the Plan nor the Sponsor’s operation of the Plan shall be construed as a waiver of sovereign immunity.

Contributions

For 2023, participants may contribute up to \$22,500 plus an additional \$7,500 if the participant reaches age 50 or older during the Plan year. Total contributions on behalf of each participant for the year, including participant contributions and the Sponsor’s contributions, cannot exceed \$66,000 in 2023.

The employer, in its discretion, may make Employer Matching Contributions each month or other period, as established by the Plan Administrator, to the Plan on behalf of its employees who are participants and who have elected to make Pre-Tax Contributions during such period. Any Employer Matching Contributions are subject to the Plan’s special multiplier provisions for employees with long-term service. The Employer Matching Contributions range from 100% to 200% of the amount declared by the Tribal Council, depending upon the participant’s length of service.

Forfeitures

Any available forfeitures shall be used to pay qualified Plan expenses and/or to reduce employer contributions otherwise required and shall not be allocated in addition to employer matching contributions. At December 31, 2023 and 2022, there was \$9,427 and \$38,625, respectively, in forfeitures available to pay Plan expenses or offset employer contributions.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contribution, the employer's matching contribution and allocations of Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Direction

Participants can direct all contributions to the account of their choice of available investments.

Vesting

Participants are vested immediately in their voluntary contributions to the Plan, plus any earning thereon. Matching, profit sharing contributions and earnings thereon become vested as follows:

Payments of Benefits

Upon termination of employment, participants may elect to keep their vested accounts invested in the Plan for retirement (with certain exceptions) or roll the vested accounts into an IRA or other employer tax qualified plan. Participants with a vested account balance valued at \$5,000 or less may receive a lump sum cash distribution (subject to tax and withholding requirements).

Retirement

Normal retirement age under the Plan is 55 ½ years of age with 5 years of service.

2) **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Valuation of Investments

Investments are stated at fair value as certified by the Plan's custodian, John Hancock. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are reported on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

The Plan recognizes benefit payments in the period the benefits are paid.

Administrative Expenses

Expenses of the Plan, to the extent that the Employer does not pay such expenses, may be paid out of the assets of the Plan. Expenses that may be paid by the Plan shall include any expenses incurred by the Plan Administrator or Trustee in the exercise of their duties under the Plan, including, but not limited to, expenses for recordkeeping and other administrative services; accounting fees and expenses of the custodian; expenses for investment education and investment management services; and direct costs that the Employer incurs with respect to the Plan.

Subsequent Events

Subsequent events were evaluated through August 12, 2025, which is the date the financial statements were available to be issued.

3) **2022 Investment Information Prepared and Certified by Custodian**

The 2022 balances of investments on the statements of net assets were prepared and certified by John Hancock Life Insurance Company (U.S.A.). The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the accompanying financial statements.

4) **Corrective Distributions Payable**

At December 31, 2023 and 2022, a liability of \$3,089 was recorded for amounts to be withdrawn from the Plan for contributions made by participants in excess of amounts allowed by the Internal Revenue Service (IRS). Excess contributions would be withdrawn from the Plan in accordance with regulatory deadlines.

5) **Party-In-Interest Transactions**

Certain Plan investments are managed by John Hancock. John Hancock is the custodian and record keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

6) Fair Value Measurement

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements – The fair value of shares of registered investment companies is based on quoted net asset values of the shares held by the Plan at year-end.

Level 2 Fair Value Measurements – The fair value of certain equity and fixed income funds for which quoted market prices are not available are valued based on net asset values for underlying assets held by the pooled funds.

Level 3 Fair Value Measurements – Inputs to valuation methodology include discounted cash flow and theoretical transfer (exit value). Unobservable inputs include the application of a risk-adjusted discounted rate.

The following are descriptions of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts – Valued at the net asset value (NAV) or equivalent based on units of the pooled separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

As of December 31, 2023 and 2022, all Plan investments are held in pooled separate accounts with a fair value of \$4,851,530 and \$4,174,914, respectively. These investments are valued and reported at their NAV and are not included within the fair value hierarchy.

7) Plan Termination

Although it has not expressed intention to do so, the Plan's sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8) Reconciliation of Financial Statements to Form 5500

There were no reconciling items to the Form 5500 filed for the year ended December 31, 2023.

9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10) Administrative Expenses

The Plan sponsor absorbs significant administrative expenses, such as audit fees, not included in these financial statements.

11) Tax Status

The Internal Revenue Service has determined and informed the Ute Mountain Ute Tribe by a letter dated February 7, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

12) Non-Exempt Party-In-Interest Transactions

During Plan year 2022, employee deferrals and employer matching contributions for multiple pay dates were not remitted to the Plan's custodian, as noted in Supplemental Schedule of Delinquent Participant Contributions. The Plan will report the delinquent contributions in the Form 5500 and is currently working with the Plan's Third-Party Administrator to correct the error. The Tribe is operating the Plan in reasonable and good faith compliance with Section 906 of the Pension Protection Act, pending publication of final guidance.

13) Contingency

The Plan has not complied with the Department of Labor's reporting requirements which required the Plan to be audited timely. The possibility exists that the Plan could be subject to fees and penalties related to noncompliance in current and prior years.
