We have performed audits of the financial statements of 10 Roads Express 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. 1. Plan Description

The following description of the 10 Roads Express 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for eligible employees of 10 Roads Express, LLC, 10 Roads Logistics, LLC, DRT LLC, Eagle Express Lines, Inc., Hoovestol, Inc., Lone Mountain Truck Leasing LLC, Pat Salmon & Sons, Inc., Red Rock Trailer, LLC (through July 2024), Specialty Transportation Core Insurance Company, Inc., 10 Roads Services, LLC (effective February 2024) and Speed Charge LLC, (effective September 2024) (collectively the Company). Effective January 2025, the Plan also provides retirement benefits for eligible employees of Optigrid, LLC, Pro Pilot, LLC, and Speed Charge Services, LLC.

In June 2023, the Company approved the merger of the Beco, Inc. 401(k) Profit Sharing Plan and Trust (Beco Plan). Assets totaling \$4,813,410 were settled and received into the Plan in July 2023. Participants of the Beco Plan began participating in this plan effective March 2023.

Employees are eligible to make salary deferral contributions and receive discretionary matching and profit-sharing contributions after attaining age 18 and completing one month of service. Eligible employees become participants on the first day of the month following the date on which entry requirements were met. Employees must have 1,000 hours of service and be employed on the last day of the Plan year to receive discretionary profit-sharing contributions.

Contributions

Participants may make voluntary salary pre-tax and Roth after-tax contributions up to 90% of eligible compensation, not to exceed the maximum dollar limits allowable by law. Participants who are age 50 or older may make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company may make discretionary matching contributions and discretionary profit-sharing contributions. For the years ended December 31, 2024 and 2023, the Company's discretionary matching contributions were \$540,474 and \$956,787, respectively. The Company did not make any discretionary profit-sharing contributions during the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of a) the Company's discretionary matching and profit-sharing contributions, b) Plan earnings or losses and c) an allocation of administrative expenses paid by the Plan. The Company's discretionary matching contributions are allocated among participants based upon the classification of the participant and the participant's elected salary deferral. The Company's discretionary profit-sharing contributions are allocated based upon the classification of the participant and the participant's eligible compensation. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Fidelity Management Trust Company (Fidelity).

Vesting

Participants are vested immediately in their contributions plus earnings thereon. Vesting in Company contributions credited to participants' accounts are based on years of continuous service. Participants are 100% vested in the Company's contributions after three years of credited service. Certain participants hired under predecessor employers may be subject to different vesting schedules.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Note receivable terms range from one to five years or longer for the purchase of a primary residence. Principal and interest payments must be made through payroll deductions.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive an amount equal to the value of the vested funds allocated to the participant's account in either a lump sum amount or in installments. The Plan automatically distributes those benefits that are under \$1,000 in the event the participant does not elect a payout option. The Plan requires that distributions between \$1,000 and \$5,000 (\$7,000, effective April 11, 2025) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect a payout option. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of their Company contributions not then vested shall be forfeited. The forfeited portion of any participant's account will be used to reduce expenses or Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$30,999 and \$244,328, respectively. During 2024 and 2023, \$351,786 and \$56,864, respectively, of forfeited amounts were used to reduce administrative expenses and Company contributions.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Other fees specifically incurred by or attributable to individual participants are paid from the applicable participant's account and included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 9, 2025. See the "General" and "Payment of Benefits" sections in Note 1 for descriptions of subsequent events.

3. Information Certified by Fidelity

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market Fund: Valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Valued at the NAV based on the fair value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these trusts meets those requirements. The participants have the ability to redeem the accounts at NAV as of the measurement dates on a daily basis. There are no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distribution to participants of the account balances would be made as soon as practicable after the termination date.

6. Tax Status

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from Federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Related Party Transactions

Certain Plan investments are assets managed by Fidelity. Fidelity is the trustee, custodian and recordkeeper as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions.
