INDEPENDENT AUDITOR'S REPORT

Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Envision, LLC Employees' 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Envision, LLC Employees' 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing audits in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Envision, LLC Employees' 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Envision, LLC Employees' 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of assets (held at end of year) as of December 31, 2024 and delinquent participant contributions for the year then ended (collectively, "supplemental schedules") are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF THE PLAN

The following description of the Envision, LLC Employees' 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution plan, covers all employees of Envision, LLC, who have elected to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Eligibility

The Plan covers all employees age 21 or older. Upon meeting the eligibility requirements, employees can begin to participate on the first day of each month then following. Employees become eligible to receive employer-matching and profit-sharing contributions after completing two years of service.

Contributions

An eligible employee may elect to defer up to 60% of their eligible compensation, as defined by the Plan, up to the maximum allowed by the Internal Revenue Code. Participants age 50 or older are allowed to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. For the years ended December 31, 2024 and 2023, employer matching contributions were 25% of the participant's elective deferral contributions up to 6% of their compensation.

A participant must be at least 21 and be employed for at least two years to be eligible to receive the Employer matching contribution or the discretionary Employer profit sharing contribution. The Employer, at its discretion, may also elect to contribute an additional matching contribution at the end of each Plan quarter. Participants, to be eligible for the additional matching contributions, must be an active participant at anytime during that Plan quarter. The Company elected not to make a profit sharing contribution for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations. Participants direct contributions into the various investment options offered by the Plan.

Participant accounts

Each participant's account is credited with the participant's contribution, the Employer's matching contribution, an allocation of the Employer's discretionary profit sharing or additional matching contribution (if applicable), and an allocation of Plan's earnings or losses. Employer matching contributions are allocated based on a percentage of the participant's salary deferral contributions, subject to certain limitations. The Employer discretionary contributions are allocated to a participant based on a formula integrated with the social security wage base. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

1. DESCRIPTION OF THE PLAN (continued)

Vesting

Participants are 100% vested in employee deferral contributions, qualified non-elective contributions, rollover contributions, and Employer discretionary contributions, plus actual earnings thereon. Vesting in Employer matching contributions is subject to a graded vesting schedule based on years of credited service. Participants are fully vested in the Employer contributions after the completion of two years of service.

Notwithstanding the above, participants become 100% vested in their account upon death, disability, or attainment of early or normal retirement age.

Benefit payments

On termination of service, death, disability or early (age 55 with 5 years vesting service) or normal retirement age (65), the participant may elect to receive the value of the vested interest in their account as a lump sum distribution. The Plan allows in-service withdrawals at 5 years of active participation within the Plan, at age 59 ½, and hardship withdrawals, subject to Plan provisions.

Forfeitures

Forfeited non-vested account balances may be used to pay administrative expenses or to reduce future Employer contributions. At December 31, 2024 and 2023, there were balances of \$15 and \$3,741 forfeited non-vested accounts, respectively. Forfeitures used to pay administrative expenses for the years ended December 31, 2024 and 2023, totaled \$3,868 and \$1,289, respectively.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested balance. The notes are secured by the vested balance in the participant's account. Note terms range from one to five years unless it is for the purchase of a primary residence. Principal and interest are paid ratably at least on a quarterly basis. Interest rates on participant notes are based on the rates available for similar loans from commercial lending institutions.

Secure 2.0 and Cares Act

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Organization has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0.

Secure 2.0 and Cares Act (continued)

Effective March 27, 2020, the Plan administratively adopted the provisions of the Coronavirus Aid, Relief, and Economic Security ("CARES") Act, related to participant loans and distributions. The Company has until December 31, 2026, to amend the Plan for changes allowed by the CARES Act.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates in financial statement preparation

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Benefit payments

Benefit payments are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Loans are secured by participant accounts. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Expenses

Expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Any expenses paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participants account and are included in administration expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 11, 2025, the date the financial statements were available for issue.

3. SUMMARY OF FINANCIAL DATA CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan, has certified to the completeness and accuracy of the investment and notes receivable from participant information and the related investment earnings, interest and dividends presented in the accompanying statements of net assets available for benefits and the statements of changes in net assets available for benefits as of and for the years ended December 31, 2024 and 2023, and the December 31, 2024, schedule of assets (held at end of year).

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

4. FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market fund: Valued at NAV of \$1 per share. The money market fund is invested in the Fidelity Government Money Market Fund. The Plan invests in the money market fund to provide daily liquidity.

5. PLAN TAX STATUS

An opinion letter dated June 30, 2020 has been received from the Internal Revenue Service on the Fidelity prototype plan. This letter indicates the Plan is qualified under Section 401 of the Internal Revenue Code and is therefore not subject to tax under current income tax law. Although the Plan has been amended since receiving this determination letter, the Plan Administrator believes that the Plan is designed and currently operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100 percent vested in their account balances.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are managed by Fidelity, the trustee of the Plan. Therefore, the investment transactions with Fidelity qualify as party-in-interest transactions. Fees paid by the Plan for administrative services were \$6,262 and \$2,626 for the years ended December 31, 2024 and 2023, respectively.

9. DELINQUENT PARTICIPANT CONTRIBUTIONS

The Company had a late contribution of \$18,734 during the Plan year ended December 31, 2023. The Company determined and remitted lost earnings to self-correct these delinquent contributions during the Plan year ended December 31, 2024.
