### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Jack Demmer Ford, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### **NOTE 1 - Description of Plan**

The following summary description of the Jack Demmer Ford, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for more complete information of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering substantially all full-time and part-time employees of Jack Demmer Ford, Inc. (Company) who have attained the age of 21 and have completed 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan assets are held in a trust and by an insurance company and are managed by Empower Trust Company, LLC. Plan management is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions** - Each year, participants may contribute a percentage of pretax annual compensation as defined by the Plan, subject to certain IRS limitations. Participants may designate all or part of their elective deferrals as after-tax Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Plan includes an auto-enrollment provisions whereby all newly eligible employees are automatically enrolled in the Plan at 3% unless they affirmatively elect not to participate in the Plan. The Plan also includes an auto-escalate feature, which increases an auto-enrolled participant's deferral percentage by 1% annually up to 10%. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary matching contributions of 50% of the first 2% of participant eligible compensation, as defined in the plan document. The Company made discretionary matching contributions of \$148,625 for the year ended December 31, 2024.

**Participant accounts** - Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes receivable from participants** - Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not have more than two loans outstanding. The loans are secured by the balance in the participant's account. Repayments are made through payroll deductions, and all payments of principal and interest are credited back to the participant's account. Interest rate is set by the Plan administrator in accordance with local prevailing rates for similar types of loans.

#### **NOTE 1 - Description of Plan - (Continued)**

**Payment of benefits** - Upon termination of service due to death, disability, retirement or separation of employment, a participant, or beneficiary thereof, shall be eligible to receive a distribution of the balance of the participant's vested interest in his or her account.

**Vesting** - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

**Reclassifications** - Certain reclassifications were made to the 2023 financial statements to conform to the 2024 presentation.

**Forfeited accounts** - At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,161 and \$4,599, respectively. During 2024, employer contributions were reduced from forfeited non-vested accounts by \$10,346. During 2024, there were no forfeited amounts used to pay plan audit expenses. The balance at December 31, 2024, will be used for plan audit expenses and may be used to reduce future employer contributions.

#### **NOTE 2 - Summary of Significant Accounting Policies**

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and the custodian. See Note 4 for discussion of fair value measurements.

Common collective trust funds are valued at the net asset value per share, or its equivalent, of the fund, which is based on the fair value of the funds underlying assets. There are no redemption restrictions or unfunded commitments on any investment.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

#### **NOTE 2 - Summary of Significant Accounting Policies - (Continued)**

**Contributions** - Contributions for Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of benefits** - Benefits are recorded when paid.

**Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. The Plan pays for direct fees for custodian and record keeping services.

**Subsequent events** - The Plan has evaluated subsequent events through September 2, 2025, the date the financial statements were available to be issued. There were no subsequent events that required disclosure.

#### **NOTE 3 - Certification of Investment Information**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, a qualified institution.

#### **NOTE 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

**Mutual funds** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Pooled separate accounts** - Valued at fair value based on the net asset value (NAV) of similar shares held by the plan at year end. They are similar to mutual funds but are only available to group annuity contract holders.

**Common collective trust funds** - Fair value is determined by the underlying asset's daily value using net asset value (NAV) as a practical expedient.

**Guaranteed general account** – A guaranteed general account is valued at the net asset value of units of the insurance company. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

#### **NOTE 5 - Related-Party Transactions and Party In Interest Transactions**

Under the terms of a trust agreement, the current custodian, Empower Trust Company, LLC manages the Plan's investments as directed by the plan participants. Certain plan investments consist of units of mutual funds, common collective trust funds, pooled separate accounts, and guaranteed general account by Empower Trust Company, LLC, and therefore, these transactions qualify as party in interest. As described in Note 2, the Plan made direct payments to the custodian for participant loan fees and investment asset charges. The Plan sponsor pays directly any other fees related to the Plan's operations.

During 2024, the Plan made payments totaling \$13,879 to Empower Annuity Insurance Company for recordkeeping services.

During 2024, the Plan made payments totaling \$4,696 to Empower Advisory Group, LLC for investment management services.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

#### **NOTE 6 - Plan Termination**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to amend, modify, terminate, or partially terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their employer contributions.

#### **NOTE 7 - Tax Status**

The Plan is a prototype plan. The prototype plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for Federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and state authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
