#### **NOTE 1 - DESCRIPTION OF THE PLAN**

---

The following description of the McArthur Next, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a defined contribution plan covering a large portion of the employees of McArthur Next, LLC (the “Company”), excluding certain non-resident aliens, leased employees, part-time employees, temporary employees, seasonal employees, and anyone who previously made an irrevocable election not to participate. The majority of the Company’s employees are eligible following the completion of a two-month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Trustees is responsible for oversight of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Effective November 14, 2024, Ascensus LLC. was appointed trustee and recordkeeper of the Plan, replacing Newport Trust Company (which was acquired by Ascensus LLC.).

##### **Contributions**

Each year, eligible participants may contribute up to the maximum limits allowable by the Internal Revenue Code (“IRC”) of pretax annual compensation or after-tax basis in accordance with the Roth provision, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. Plan provisions do not allow for any type of employer contributions. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

##### **Participant Accounts**

Each participant’s account is credited with the participant’s contribution, as well as, allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

##### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through weekly payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum, or in equal monthly installments over a period of years. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, the Plan allows for hardship distributions if certain criteria are met.

**Forfeited Accounts**

At December 31, 2024 and 2023, there were no forfeited nonvested accounts. If applicable, these accounts will be used to reduce future employer contributions. Also, in 2024, there were no amounts from forfeited nonvested accounts that were utilized.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and the trustees. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from compensation.

**Investment Concentration**

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 3, 2025 the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4 - RELATED-PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS**

---

Notes receivable from participants qualify as party-in-interest transactions. Such transactions are permitted under the Plan and are exempt from the prohibition of party-in-interest transactions. All other transactions, which may be considered related-party or parties-in-interest transactions, relate to normal plan management and administrative services, and the related payment of fees.

**NOTE 5 - PLAN TERMINATION**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**NOTE 6 - TAX STATUS**

---

The Employer has adopted a non-standardized pre-approved profit sharing money purchase plan with CODA sponsored by Newport Group Inc. The non-standardized pre-approved profit sharing money purchase plan has received an opinion letter from the IRS dated June 30, 2020, as to the non-standardized pre-approved profit sharing money purchase plan's qualified status. The non-standardized pre-approved profit sharing money purchase plan opinion letter has been relied upon by the Plan. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - CERTIFIED INVESTMENTS**

---

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the period November 14, 2024 through December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus LLC. (the current trustee of the Plan).

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the period January 1, 2024 through November 13, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Newport Trust Company (the prior trustee of the Plan).

**NOTE 9 - DELINQUENT PARTICIPANT DEFERRAL TRANSMITTALS**

---

During 2023, the Company erroneously failed to remit certain participant deferrals to the Plan aggregating \$52. These deferrals are included in the Plan's receivables at December 31, 2024 and 2023. The Company will compute lost earnings on these 2023 deferrals and subsequently will remit the deferrals and make a contribution for lost earnings to the Plan.

During 2022, the Company erroneously failed to remit certain participant deferrals to the Plan aggregating \$10,761. The Company computed the lost earnings on these 2022 deferrals and subsequently remitted the deferrals, in 2023, and made a contribution for lost earnings to the Plan during 2024.
