#### **Scope and Nature of ERISA Section 103(a)(3)(c) Audit**

**Note A - Description of the Plan**

The following description of the Garafalo Markets, LLC (“Company”) 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a salary deferral defined contribution plan established effective October 4, 1998. The Plan covers all eligible employees of Milford Markets, LLC, East Haven Markets, LLC, Hamden Markets, LLC, Stratford Markets, LLC, Orange Markets, LLC, Clinton Markets, LLC and Cromwell Markets, LLC which all have common ownership. All employees of the Company are eligible to participate once they have completed two (2) months of service and have attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended so that all eligible employees hired on or after July 1, 2016 will be automatically enrolled in the Plan. If the automatic enrollment provision applies to an employee, the Plan will automatically defer 5% of their compensation unless the employee elects to opt-out of the Plan.

**Administration**

The Company is the Plan’s named fiduciary and plan administrator. The Standard Retirement Services (“Standard”) is the TPA and recordkeeper for the Plan. Reliance Trust Company, (“Reliance”) and the Standard Insurance Company (“Standard Insurance”) are the custodians of the Plan. Reliance holds the Plan’s investments in registered investment companies, and Standard Insurance holds the Plans investment in an insurance company general account. Reliance and Standard Insurance hold investment assets and execute investment transactions. The Standard prepares statements for participants, which include amounts of contributions, investment income, disbursements and fair value of investments, along with calculating distributions in the event of a participant’s termination of employment.

**Contributions**

**Participant’s salary reduction election:**

The total deferral in 2024 and 2023 may not exceed \$23,000 and \$22,500 for each year, respectively. This amount will be adjusted annually in accordance with IRS rules and regulations. Participants have the option of making either 401(k) elective deferral contributions or designating some or all as Roth elective deferral contributions. Participants who will reach age 50 by the end of the 2024 and 2023 tax year may contribute an additional \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

**Contributions (continued)**

**Employer matching contribution:**

The Company may make a qualified matching contribution of 100% of the employees elective deferral contributions up to 3% of pay, plus 50% of the employees elective deferral contributions which are over 3% of pay but not over 5% of pay. Any participant actively employed during the Plan year shall be eligible to share in the matching contribution for the plan year. The Company's matching contributions to the Plan for the years ended December 31, 2024 and 2023 was \$379,250 and \$395,830, respectively.

**Employer discretionary contribution:**

The Company may make a discretionary contribution. Participants are eligible if they are active on the date of the contribution and have 1,000 or more hours of service in the plan year. Also, any participants who were active at any time during the plan year and had retired, died or became totally disabled will be eligible. The Company did not make a discretionary contribution to the Plan for the years ended December 31, 2024 and 2023.

**Vesting**

Participants are 100% vested at all times.

**Participant accounts**

Each participant's account is credited with the participant's deferrals and the Company's matching contribution and Plan earnings. Plan contributions are participant directed and are invested in one or more investment vehicles available to participants under the Plan. Earnings and losses are determined by individual investment vehicle performance.

**Investment options**

Upon enrollment in the Plan, a participant may direct employee contributions and employer discretionary contributions in any whole percent increments in any of the various investment options available by the Plan. Participants may change their investment options on a daily basis.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the non-forfeitable accrued benefit of the participant under the Plan. Loan terms range for 1-5 years, unless the proceeds are used for the purchase of a principal residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest are paid ratably through payroll.

**Hardship withdrawals**

Participants may elect, subject to specific circumstances as defined in the Plan, to receive all or part of elective deferral contributions (not earnings) for immediate and severe financial need.

**Forfeitures**

If excess 401(k) elective deferral contributions are refunded to a participant, any matching contributions will be forfeited. If the participant is a highly paid employee, the law may limit their contributions and the Company's matching contributions. If 401(k) elective deferral contributions are refunded to a highly paid employee, any matching contributions made because of these 401(k) elective deferral contributions will be forfeited. Matching contributions which are forfeited because of these limits may reduce the Company's future contributions or may be used to pay administrative expenses. During the year ended December 31, 2024 and 2023, no forfeitures were used to reduce matching contributions. Forfeited non-vested accounts totaled \$1,592 and \$1,559 as of December 31, 2024 and 2023, respectively.

**Payment of benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments in accordance with IRS regulations. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Note B - Significant Accounting Policies**

**Basis of accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

**Use of estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions**

Employee and employer contributions are recorded in the period during which the Company makes payroll deductions from the Plan participants' earnings.

**Investment valuation and income recognition**

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants**

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. No allowance for loan losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. During the years ended December 31, 2024 and 2023 delinquent loans reclassified as distributions were \$9,842 and \$3,579, respectively.

**Payment of benefits**

Benefits are recorded when paid.

**Plan expenses**

The Company has elected to charge administrative fees to the Plan's trust and all other expenses are paid by the Company.

**Note C - Fair Value Measurements**

Accounting standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described below:

**Level 1 Inputs:** Valuation based on quoted prices in active markets for identical assets or liabilities that a reporting entity has the ability to access at the measurement date, and where transactions occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

**Level 2 Inputs:** Valuation based on inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, that is markets in which there are few transactions, prices are not current, or prices vary substantially over time.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3 Inputs:** Valuation based on inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024.

**Shares of Registered Investment Companies**

The fair value of these investments are determined by reference to the fund's underlying assets, which are principally marketable equities and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value as of December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note D - Insurance Company General Account**

The Standard Stable Asset Fund is a group annuity product that meets the criteria of a fully benefit-responsive investment contract and is therefore reported at contract value which approximates fair value. Contract value represents contributions made to the fund, less participant withdrawals and administrative expenses, plus interest credited. The crediting interest rate for the Plan was 2.09% and 1.83% for the years ended December 31, 2024 and 2023, respectively. The redemption frequency for these funds is immediate with no redemption notice required. However, to fully remove the stable asset fund from the Plan, it could take up to 30 days to pay out the fund's assets. There were no unfunded commitments as of December 31, 2024.

Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditor not to extend audit procedures to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Reliance and Standard Insurance as of and for the years ended December 31, 2024 and 2023 stating that the certified investment information listed below is complete and accurate:

**Note F - Related Party Transactions**

Certain Plan investments are managed by affiliates of Reliance and Standard Insurance, the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Participant loans are also considered party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

**Note G - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full termination, partial termination, or the complete discontinuance of contributions by the Company, all amounts credited to the affected participants' combined accounts are already 100% vested.

**Note H - Tax Status**

The Internal Revenue Service has determined and informed the Standard by a letter dated March 31, 2014 that the Standard Retirement Services, Inc. Volume Submitter 401(k) Profit Sharing Plan, which has been adopted by the Company, is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan has been amended since receiving the advisory letter. However, the plan administrator and the plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.


