#### **Note 1 – Plan Description**

The following description of the Saint Jean Industries, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Saint Jean Industries, Inc. (the “Company” or “Employer”). The Plan, which commenced effective November 1, 2006, was amended and restated effective August 26, 2021, to comply with the latest rules and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

#### ***Plan Custodian and Trustee***

Fidelity Management Trust Company (“Fidelity,” the “Custodian,” or “Trustee”) is the Custodian maintaining custody of all investments held by the Plan, maintaining the Plan’s participant account balances, and providing recordkeeping services to the Plan. Among other duties, the Custodian receives contributions, holds, and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. Fidelity also serves as the Plan’s Trustee.

#### ***Eligibility and Plan Entrance Date***

All employees of the Company who have at least three months of service and are age 18 or older are eligible to participate in the Plan. Eligible employees are permitted to enter the Plan on the first day of each month after which the employee has satisfied the eligibility requirements.

#### ***Participant Contributions***

Participants may elect to contribute, either through pre-tax or Roth deferrals, up to 50% of their eligible compensation, as defined in the Plan, up to the maximum amount allowed annually by the IRC, which was \$23,000 for 2024. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024.

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

#### ***Employer Contributions***

The Plan provides for Safe Harbor Employer matching contributions for eligible participants. For the Plan year ended December 31, 2024, the Company made matching contributions equal to 100% of the first 4% of the participant's eligible compensation contributed to the Plan. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

#### ***Participant Accounts***

Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Note 1 – Plan Description (continued)

##### *Participant-Directed Investments*

All Plan assets are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, and participants may designate the allocation of their account balances to one or more of these options. The investment options vary in types of investments, rates of return, and investment risk.

##### *Vesting*

Participants are immediately vested in their voluntary contributions and Safe Harbor Employer matching contributions plus earnings thereon. Participants are not vested in discretionary Employer contributions until they complete 2 years of service, at which time, they become 20% vested. Twenty percent of the remainder of their account vests after each year of continuous service, so that a participant is fully vested after 6 complete years of service.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. A participant may only have 2 outstanding loans at a time. Loans are secured by the balance in the participant's account. The loan interest rate is set at commercially reasonable rates of interest, as defined. Principal and interest are paid ratably through payroll deductions and are due in equal installments not less frequently than quarterly.

##### *Payment of Benefits*

Upon separation of service due to death, disability, normal retirement, termination of employment, or financial hardship, a participant may elect to receive a lump sum payment from the vested portion of their account balance. Distributions to a terminated employee with a vested account balance equal to or less than \$1,000 are made as a lump sum distribution as soon as administratively possible following the participant's termination of employment. The participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. If the vested account balance is less than or equal to \$1,000, the Plan permits involuntary lump sum cash distributions. If a terminated employee has an account balance exceeding \$1,000, the participant may elect to take a distribution of less than the entire vested account balance.

##### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,859 and \$23,188, respectively. These accounts will be used to reduce future Employer contributions. During the year ended December 31, 2024, \$3,877 of forfeitures were used to reduce Employer contributions and \$375 was used to pay for Plan expenses.

#### Note 2 – Summary of Significant Accounting Policies

##### *Basis of Accounting*

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

##### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

##### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

##### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

##### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

#### **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement), and the lowest priority to unobservable inputs (level 3 measurement). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.
- **Common Collective Trust Funds** – Valued using the NAV of units held by the Plan at year-end as provided by the fund administrator. Units of each fund are valued each day on which the New York Stock Exchange (“NYSE”) is open for trading in accordance with the valuation procedures established by Wilmington Trust. The NAV per unit is calculated as of the close of trading on the NYSE and computed by dividing the total fair value of the assets of a fund, less its liabilities, by the total number of units outstanding at the time of such computation. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or any unfunded commitments.

The Plan’s independent auditor did not perform auditing procedures with respect to this information except for comparing such information with the related information included in the financial statements and supplemental schedules.

#### Note 5 – Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by the Trustee; as such, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. There have been no known prohibited transactions with parties-in-interest. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

The Plan has notes receivables from participants at December 31, 2024 and 2023. These receivable and related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

#### Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

#### Note 7 – Tax Status

The Plan adopted a non-standardized, preapproved profit-sharing plan sponsored by FMR, LLC. The IRS has determined and informed FMR, LLC, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has not filed individually with the IRS for a letter regarding the Plan’s qualified tax status; however, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term, and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
