### Notes to Financial Statements

- 
1. **Description of the Plan** The following description of the Perpetual Capital 401(k) Plan (formerly CNC Perpetual 401(k) Plan) (the "Plan") provides only general information. Several related companies participate in the Plan. The participating companies include Capitol News Company, LLC; Lazy Lane Farms, LLC; Perpetual Capital, LLC; In-Shape Solutions, LLC; and California Family Health, LLC dba California Family Fitness (hereafter collectively referred to as the "Company"). The Plan was amended effective October 14, 2024 to add Nova Technology Solutions, LLC as a participating employer in the Plan. Service with Nova Technology Solutions, LLC will be credited for participants who were employed by Nova Technology Solutions, LLC on October 14, 2024. Additionally, those active participants were permitted to roll their accounts, including loans, into the Plan. During 2024, a total of \$16,210,942 accounts were rolled into the Plan by Nova Technology Solutions, LLC participants. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan was amended effective January 1, 2024 to change the primary company sponsoring the Plan from Capitol News Company, LLC to Perpetual Capital Management Services LLC. In connection with this change, the Plan name was changed to Perpetual Capital 401(k) Plan. Also effective with this amendment, Perpetual Capital, LLC was removed as a participating employer.

**General:** The Plan is a defined contribution plan covering substantially all employees of the Company who are at least 18 years old, except for employees classified as domestic employees, interns, household staff employees, employees working outside of the United States of America, leased employees unless otherwise determined by the administrative committee, and employees who are covered by a collective bargaining agreement, unless the agreement provides for participation in the Plan. Employees may enter the Plan the date they satisfy the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

## Perpetual Capital 401(k) Plan (formerly CNC Perpetual 401(k) Plan)

### Notes to Financial Statements

**Contributions:** The investment committee determines the minimum and maximum rates a participant may contribute to the Plan each year. Participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan provides for automatic enrollment. Any eligible employee who does not affirmatively elect to contribute to the Plan or does not affirmatively decline to participate in the Plan is automatically enrolled in the Plan with a six percent withholding of pretax annual compensation. This withholding will increase by one percent each subsequent year until the automatic election reaches a maximum withholding contribution of twelve percent of compensation. The Plan allows for discretionary matching contributions, whereby each employer may have a different matching contribution. During 2024, the Company contributed 50 percent of the first six percent of compensation that a non-highly compensated participant contributed to the Plan. Certain participating employers were not granted a matching contribution during 2024. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, if any, Plan earnings, and reduced for Plan losses. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions, if any, is based on years of continuous service. A participant is 20 percent vested after one year of service is completed, and vests an additional 20 percent per year until full vesting after five years. The Plan has experienced partial plan terminations in 2014 and 2020. As a result, any participants that terminated during those years became 100 percent vested.

**Payment of benefits:** Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Effective September 18, 2024, the Company elected certain optional withdrawals available through the SECURE Act and SECURE 2.0 Acts. Benefits are payable in lump sum, rollover, substantially equal installments and partial withdrawal payments.

**Forfeited accounts and unallocated amounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$391,319 and \$307,830, respectively. These accounts will be used to reduce future Company contributions, to pay Plan expenses or to restore participant accounts. During 2024, \$47,846 of forfeited nonvested accounts was used to reduce Company contributions and \$98,425 of forfeited nonvested accounts was used to pay Plan expenses.

At December 31, 2024 and 2023, unallocated balances (other than forfeited nonvested accounts) totaled \$163,931 and \$114,914, respectively. These amounts represent unclaimed benefits previously distributed to participants. These amounts will be restored to participant accounts or used in the same manner as forfeited nonvested accounts. During 2024, no unallocated amounts were used to reduce Company contributions or to pay Plan expenses. A total of \$40,743 of unallocated amounts were used to restore participant accounts and reissue benefit payments.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prime rate plus one percent at the time of issuance. Principal and interest are paid through payroll deductions.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan and distribution administration fees, are charged directly to the participant's account and are included in administrative expenses. Recordkeeping fees based on the number of Plan participants are deducted from participant accounts and included in administrative expenses.

#### 2. Significant accounting policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

**Contributions:** Participant contributions and discretionary Company matching contributions, if any, are recognized in the period the participant contribution is withheld from compensation.

**Payment of benefits:** Benefits are recorded when paid.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent events:** The Plan has evaluated subsequent events for disclosure in these financial statements through September 11, 2025, which is the date the financial statements were available to be issued.

**3. Certified information** Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, the trustee of the Plan.

**4. Fair value measurements** The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of the collective trust funds is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the trust funds. The NAV of the collective trust is used as a practical expedient to estimate fair value and is determined by the fund trustee based on the fair value of underlying assets in the trust, less its liabilities.

(a) In accordance with ASC 820, certain investments that were measured at net asset value per share (or its equivalent) as of December 31, 2024 and 2023 have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the Statements of Net Assets Available for Benefits.

Investments in the collective trust funds can generally be redeemed immediately at the current net asset value based on the fair value of the underlying assets by participants. Withdrawals from the Morley Stable Value Fund initiated by the Company require twelve months written notice. Withdrawals exceeding \$1 million from the AB US Small Cap Growth Collective Investment Trust initiated by the Company required written notice of five business days. There are no other withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2024 and 2023.

- 5. Risks and uncertainties**

The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 6. Party-in-interest transactions**

Certain Plan investments are managed by affiliates of Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the trustee and recordkeeper as defined by the Plan. The Plan paid fees to affiliates of Vanguard Fiduciary Trust Company and other service providers, totaling approximately \$386,000, for the year ended December 31, 2024. These transactions qualify as exempt party-in-interest transactions.
- 7. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
- 8. Tax status**

The Plan is a pre-approved plan of The Vanguard Group which received an opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
