## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Cardone Industries, Inc. 401(k) Safe Harbor Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Management has obtained certifications from a qualified institution as of November 21, 2024 and December 31, 2023, and for the period from January 1, 2024 to November 21, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## **Basis for Opinion**



NOTE 1 – DESCRIPTION OF PLAN

The following description of the Cardone Industries, Inc. 401(k) Safe Harbor Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Cardone Industries, Inc. (the “Company” or “Plan Administrator”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Effective November 1, 2024, the Plan merged into First Brands Group 401(k) Plan, another qualified plan, with Empower Trust Company as its trustee. The final asset transfer occurred on November 21, 2024.

Contributions

Upon meeting eligibility requirements participants may contribute up to 50% of their plan compensation on a pre-tax or after-tax Roth basis except for Dallas Chemical & Production Workers Union Local 30 who are limited to 20% of their plan compensation, subject to Internal Revenue Code (“IRC”) limitations. Participants who are at least 50 may make an additional “catch up” contribution subject to IRC limitations. Participants may also contribute funds from another qualified plan (“rollover contributions”), subject to certain requirements. Prior to February 1, 2022, all non-union participants who were deferring at a rate lower than 4% who were not part of the Rotomaster subplan and who were not deferring at a flat dollar amount, were automatically enrolled at a contribution rate of 4% of plan compensation, unless they opted out. Effective February 1, 2022, all union participants including participants that are part of the Rotomaster subplan who are deferring at a rate lower than 4% and who are not deferring a flat dollar amount are automatically enrolled at a contribution rate of 4% of plan compensation, unless they opt out.

The Company makes a safe harbor matching contribution for non-union participants equal to 100% of each non-union participant’s deferral contribution up to 4% of the participant’s compensation, for a maximum match of 4% of compensation. Effective January 1, 2024, the Plan was amended to eliminate safe harbor contributions. The Company may make a discretionary non-elective contribution to non-union participants up to 4% of compensation. Employees must be employed on the last day of the plan year and have worked at least 1,000 hours during the plan year to be eligible for a non-elective contribution.

Union participants’ contributions may be matched by the Company at a percentage of a union participant’s compensation, as determined by the Company, for employees who completed at least 250 hours of service within the first three months of employment. Union participants must be employed on the last day of the plan year and have worked at least 1,000 hours during the plan year to be eligible for matching contributions. For the period ended November 21, 2024, the Company matched the lesser of 100% of the first 10% of a union participant’s deferral contributions or 1% of the participant’s compensation deferred.

The Company also contributes non-elective contributions for employees who have completed a year of service. Union participants must be employed on the last day of the plan year and have worked at least 1,000 hours during the plan year to be eligible for non-elective contributions. All SEIU Local 252 employees covered by a collective bargaining agreement receive a 2% fixed ESOP Replacement contribution and a 3% pension replacement contribution for a maximum non-elective contribution of 5%.

The Company did not make any non-elective contributions to non-union and union participants for the 2024 plan year prior to the plan merger effective November 21, 2024.

All Harlingen Plastic Workers Union Local 18 employees who complete at least 250 hours of service within the first three months of employment and that are covered by a collective bargaining agreement receive a fixed \$25 per month contribution. Such employees must work at least 40 hours each month to be eligible to receive a contribution for that month. All Dallas Chemical & Production Workers Union Local 30 employees who complete at least 250 hours of service within the first three months of employment and that are covered by a collective bargaining agreement shall receive a fixed \$35 per month contribution. Such employees must work at least 40 hours each month to be eligible to receive a contribution for that month.

Participant Accounts

Each participant's account is increased or decreased, as appropriate, with (a) the participant's contribution, (b) the Company's contribution, and (c) investment earnings and losses. In addition, each participant's account is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in that portion of their account which represents their contributions, the Company safe harbor and ESOP replacement contributions, and the income earned thereon. A participant is 100% vested upon reaching normal retirement age, early retirement age, death, or disability while employed by the Company. Otherwise, a non-union participant's interest in the Company's non-union non-elective contributions and earnings thereon vests according to the following schedule:

A union participant's interest in the Company's pension replacement contributions, a non-union participants non-elective contributions funded prior to January 1, 2021, and a union participant's interest in the Company's discretionary matching contributions prior to February 1, 2022, and earnings thereon vests according to the following schedule:

Effective February 1, 2022, a union participant's interest in the Company's discretionary matching contributions and earnings thereon becomes 25% vested after a year of service, 75% vested after two years of service, and 100% vested after three years of service.

Forfeitures

There were no forfeited non-vested accounts at November 21, 2024. Forfeited non-vested accounts totaled \$63,898 at December 31, 2023. These accounts were used to reduce Company contributions or pay Plan expenses. During the period ended November 21, 2024, forfeitures used to pay plan expenses or fund employer contributions totaled \$106,801.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or in installment payments depending on the size of the account balance. Participants can defer their distribution payment; however, a participant's distribution cannot be postponed if their vested account balance is \$5,000 or less as Empower Annuity Insurance Company of America ("Empower" or "Trustee") has been directed to distribute vested amounts ranging from \$5,000 to \$1,000 to an Individual Retirement Account or Annuity and vested amounts less than \$1,000 be distributed as lump-sum distributions. Participants may also withdraw amounts from their accounts under certain hardship conditions as defined in the Plan document.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$750 up to a maximum amount equal to the lesser of \$50,000 or fifty percent of their vested account balance under the Plan. The maximum number of notes available to any participant is one. Loan repayment periods are not to exceed five years, unless the loan is for the purchase of a participant's primary residence. Loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The participant repays the loan and all related interest through payroll deductions.

Notes are in arrears and delinquent when any payment is missed. If the note is not paid up to date by the end of the calendar quarter, after the calendar quarter in which a payment is first delinquent, the note will be in default. In that event, the entire outstanding note balance, consisting of the missed payments, remaining principal, and all accrued but unpaid interest, will be reported to the Internal Revenue Service (“IRS”) as taxable income. If a note has not been fully repaid by the end of its term, the outstanding balance will be treated as a deemed distribution and will be reported to the IRS as taxable income.

## NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

The Plan’s investments are participant-directed accounts that are held by the Trustee. The Plan’s investments are stated at fair value at November 21, 2024 and December 31, 2023.

Investment income consists of dividends and interest income. The net appreciation of investments consists of realized gains or losses and unrealized appreciation on those investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported based on historical cost.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 21, 2024 and December 31, 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions payable as of November 21, 2024 and December 31, 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Income Taxes

The Income Taxes Topic of the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 21, 2024 and December 31, 2023 and for the period ended November 21, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent Events

The Plan has evaluated events through September 12, 2025, the date the financial statements were available to be issued.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Plan uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Observable inputs such as quoted prices in active markets;
- Level 2 – Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- *Mutual funds*: Valued at the closing price reported on the active markets in which the individual securities are traded.
- *Pooled separate accounts*: Valued at the net asset value (NAV) of units of a pooled separate account as reported by the contract issuer. The fair value of the underlying assets is used to determine the NAV of the funds. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Transactions (purchases and sales) may occur daily. There are no redemption restrictions or unfunded commitments on this investment.
- *Common / Collective Trust fund*: Valued at the NAV of units of a collective trust as reported by the fund manager. The fair value of the underlying assets is used to determine the NAV of the funds. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Transactions (purchases and sales) may occur daily. There are no redemption restrictions or unfunded commitments on this investment.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 5 – INVESTMENT CONTRACT

The Plan held a traditional fully benefit-responsive guaranteed investment contract with Empower. The Trustee maintains the contributions in a general account and is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. A rate of interest contractually guaranteed by Empower is credited to participant account balances. This credit rate is based on a formula established by the contract issuer but may not be less than 1.50%. The credit rate is reviewed on a semi-annual basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participants withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. No such events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers or participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity rate.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options. These investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to the changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 7 – PLAN TERMINATION

The Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

NOTE 8 – TAX STATUS

The Plan adopted a non-standardized pre-approved profit-sharing plan with cash of deferred arrangement provided by Empower. Empower received an opinion letter from the IRS, dated September 16, 2022, which states that the Plan document satisfies the provisions of Section 401 of the IRC. Although the Plan has been amended since the opinion letter, plan management believes that the Plan is designed and is currently being operated in compliance, in all material respects, with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 9 – PARTY-IN-INTEREST AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Trustee and the Plan incurs expenses for administrative services performed by the Trustee, and therefore, these transactions qualify as party-in-interest transactions.
