As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is responsible for maintaining a current plan instrument, including all plan amendments. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Columbia Corrugated Box Company, Inc. 401(k) and Profit-Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established March 1, 1995, maintained for the benefit of all eligible employees of Columbia Corrugated Box Company, Inc. (the Company). Employees are eligible to participate in the Plan after completing six months of service and attaining 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination - In January 2024, the Company closed an agreement providing for a stock sale acquisition of the Company to a third-party. As a result of this transaction, all of the participants in the Plan terminated their employment with the Company effective May 31, 2024. The Plan was excluded from the stock sale acquisition and during May 2024, the Company's Board of Directors elected to terminate the Plan subject to the provisions of ERISA effective June 6, 2024 (termination date). The Plan's termination ceased employee and employer contributions into the Plan and ceased new participant notes receivable from the Plan. All participants in the Plan at that time became fully vested in their accounts as of the termination date. The Plan's assets were fully distributed prior to February 28, 2025.

Plan Amendments - Effective January 1, 2024, the Plan was amended to allow for Roth contributions.

Contributions - Contributions consist of employee elective deferral contributions, participant rollover contributions and discretionary matching and profit-sharing contributions provided by the Company. Employee elective deferrals and the employer discretionary matching and profit-sharing contributions are recorded in the year in which the employee contributions are withheld from compensation. The Plan includes an auto-enrollment and annual increase program provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Under the annual increase program, the elective deferral rate for participants subject to automatic enrollment will increase by 1% each year until that deferral amount reaches 8%, or the participant elects not to have the increases applied. Company matching and profit-sharing contributions are discretionary and are determined annually by the Board of Directors. The Company made discretionary matching contributions to the Plan for the years ended December 31, 2024, and 2023 in the amount of 25% of the first 8% of employee contributions (i.e., maximum of 2%). The Company made a discretionary profit-sharing contribution of \$0 and \$674,987 for the years ended December 31, 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Employees may voluntarily contribute up to 90% of total compensation, limited to \$23,000 and \$22,500 in 2024 and 2023, respectively, as prescribed by the Internal Revenue Code (IRC). Participants aged 50 and older may elect to make an additional catch-up contribution. Contributions are subject to other limits under the IRC.

Participant Accounts - A separate account is maintained for each participant, which is credited with the participant's contributions, the Company's matching contributions and an allocation of Plan earnings and forfeited balances of terminated participants. Allocation of Plan earnings is based upon participant account balances. Allocation of forfeitures is in the same manner as employer matching contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings on those contributions. After one year of service, participants begin to vest in the Company portion of their accounts at the rate of 20% for each year of service. A participant is fully vested after six years of credited service. For vesting purposes, years of service is computed on the basis of the Plan year. All affected participants became fully vested in their accounts as of the termination date.

Expenses - Certain expenses of plan administration, including computer services, professional fees, contract administration fees, office supplies and payroll expenses of administrative and clerical personnel are provided by the Company without charge to the Plan. Administrative expenses not paid by the Company are satisfied in part through revenue sharing with various investments, with the remainder charged to participant accounts based upon their relative account balances. Revenue sharing income generally consists of 12(b)1 fees and sub-transfer agency fees and is used by the Plan to pay plan expenses. Total revenue sharing received by the Plan for the years ended December 31, 2024 and 2023 was \$1,369 and \$2,017, respectively. Fees related to the administration of distributions taken by participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of the investments.

Payment of Benefits - Upon termination of service, death, disability or retirement, a participant may elect to receive a lump sum amount or installment payments equal to the participant's vested account balance. The Plan further provides for hardship distributions and participant loans. Hardship distributions are available only for the purpose of meeting immediate and heavy financial needs.

Forfeitures - Forfeited accounts amounted to \$0 and \$29,219 at December 31, 2024 and 2023, respectively. The forfeited accounts of nonvested terminated participants are used to reduce Plan expenses or allocated to remaining participants on an annual basis to reduce the employer matching contributions. Total forfeitures used for employer matching contributions were \$29,333 and \$18,198 in 2024 and 2023, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - Financial Accounting Standards Board (FASB) issued Accounting Standards Codification (ASC) 205-30, Presentation of Financial Statements: Liquidation Basis of Accounting, which requires an entity to prepare its financial statements using the liquidation basis of accounting when liquidation is imminent. The Plan implemented ASC 205-30 for the 2024 plan year as this is when liquidation was determined to be imminent. Therefore, the accompanying financial statements have been prepared on a liquidation basis of accounting as of and for the year ended December 31, 2024 and in the ongoing (accrual) basis of accounting as of December 31, 2023. The adoption did not have a material impact on the financial statements.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investments.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events- The Plan's management has performed an evaluation of subsequent events through August 28, 2025, which is the date these financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Basis of Fair Value Measurement

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust funds: Valued at the NAV of units held by the Plan at year-end as reported by the investment managers. The fixed income common/collective trust fund is comprised primarily of fully benefit-responsive investment contracts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal to ensure that securities liquidation will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – NOTES RECEIVABLE FROM PARTICIPANTS

The Plan made loans to participants up to the lesser of 50% of their vested account balance or \$50,000. Loans were payable within five years through semi-monthly payroll deductions, unless the loan was used to acquire a primary residence. Interest is charged at the prime rate plus 1%. Participants are responsible for the payment of loan fees to the trustee, which are generally deducted from loan proceeds at the time of loan issuance. Loan fees paid by participants to the trustee amounted to \$1,800 and \$3,525 for the years ended December 31, 2024 and 2023, respectively. Loans were secured by the vested account balance of the participant.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of a common/collective trust fund and prior to the plan termination mutual funds managed by Principal Trust Company, or an affiliate of Principal Trust Company. Principal Trust Company is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for investment management services and administrative fees for the common/collective trust fund charged by the trustee are netted against Plan earnings on a monthly basis equal to an annual rate that ranges from 0.02% to 0.40% of the funds' average daily net assets.

The trustees receive a portion of the investment management fees, which the trustees accept as compensation for recordkeeping and trustee services. Such fees received by the trustees during 2024 and 2023 amounted to \$58,351 and \$81,887, respectively.

NOTE 6 – INFORMATION CERTIFIED BY TRUSTEE OF THE PLAN

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year), that was certified by the trustee of the Plan, Principal Trust Company, as of, and for the years ended December 31, 2024 and 2023, and furnished to the plan administrator. The plan administrator has obtained a certification from the trustee that such information is complete and accurate.

NOTE 7 – TAX STATUS

The Plan is an adoption of a non-standardized pre-approved profit-sharing plan sponsored by Principal Life Insurance Company. The non-standardized pre-approved profit-sharing plan document obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter, however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024, and 2023.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – CONCENTRATIONS, RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participants' account balances. There is one and three investments that individually represented more than 10% of the investments held at December 31, 2024 and 2023, respectively. See the supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year), for the complete listing of investments held as of that date.

NOTE 9 – THEFT LOSS AND RECOVERY

In September 2024, the Company was made aware of certain unauthorized activity in a participant's account that occurred during 2023. After an investigation, it was determined that this participant had one unauthorized hardship distribution and two unauthorized note receivables from participants processed and distributed from the Plan in 2023. The unauthorized notes receivable from participants totaled \$39,951 and the unauthorized hardship distribution totaled \$9,673 for a total loss to the Plan of \$49,624. The financial statements were not adjusted to reverse the loss or to accrue the recovery of the amounts due from the Trustee or the Company as of December 31, 2023 as these amounts were not material to the accompanying financial statements. The Trustee has reimbursed the Plan and the participant for the lost funds identified during the 2024 plan year. The Company has not identified any other unauthorized activity.
