Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mina Group LLC Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 30, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period beginning January 1, 2024 and ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the for the period beginning January 1, 2024 and ended September 30, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS September 30, 2024 And December 31, 2023

1. Description Of The Plan

The following description of the Mina Group LLC Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the following companies (the Company) who have obtained the age of twenty one and one year of service:

- Mina Group LLC
- MG-252 CAL, LLC
- MG-301 Mission, LLC
- MG-2120 LLC
- MG-Bos, LLC
- MG Hila LLC
- MG 350 Mission LLC
- MG International Smoke LLC
- MG-19501 Biscayne LLC
- MG Seattle LLC

The Plan is considered a single plan as each member of the controlled group is an Adopting Employer and participates with the Sponsor Employer (Mina Group LLC) (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The effective date of the Plan was January 1, 2004. It was restated effective January 1, 2015. Plan amendment No. 1 was executed January 1, 2016 to allow participation of employees from MG- Bos, LLC, MG Hila LLC and MG 350 Mission LLC into the Plan. Plan amendment No. 2 was executed April 30, 2020 to discontinue the Company safe harbor matching contribution. Plan amendment No. 3 was executed January 1, 2022 to allow participation of employees from MG International Smoke LLC, MG-19501 Biscayne LLC, and MG Seattle LLC into the Plan.

Plan Merger

On December 31, 2023 the Board of Directors of the Company executed a resolution to merge the Plan in to the Buildwise Pooled Employer Plan. All assets of the Plan were merged into the Buildwise Pooled Employer Plan as of September 30, 2024.

Notes To Financial Statements *(Continued)*

Contributions

The Plan allows for employee elective deferral contributions, Company matching contributions, and rollover contributions from another qualified plan.

Each year participants may defer a percentage or flat dollar amount of their eligible compensation, not to exceed certain Internal Revenue Service (IRS) limitations. Only pre-tax deferrals are allowed in the Plan.

The Company may also elect to make a discretionary contribution on behalf of active participants who meet certain eligibility requirements. If a discretionary contribution is made, the amount will be determined as a percentage of salary deferrals made during the Plan year or as a uniform dollar amount. A discretionary contribution will never exceed 4% of eligible compensation. The Company did not make a discretionary matching contribution during the period beginning January 1, 2024 and ended September 30, 2024.

Vesting

Participants are immediately vested in their contributions and safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions plus actual earnings thereon is based on years of vesting service, except in certain circumstances where the vesting will be considered 100%, for example, reaching normal retirement age as defined in the Plan. Otherwise, vesting percentages are as follows:

<u>Years Of Service</u>	<u>Vesting Percentage</u>
Less than one year	0%
1	25%
2	50%
3	75%
4	100%

A year of service is defined as having at least 1,000 hours worked during the 12-month period immediately following the participant's date of hire. If the participant does not work at least 1,000 during the 12-month period immediately following the date of hire, the participant will earn a year of service once the participant works at least 1,000 hours during any Plan year beginning after their date of hire.

Participant Accounts

Each participant's account includes the participant's contribution, the Company's safe harbor matching contribution, any rollover deposited from qualified participant accounts, an allocation of Plan earnings or losses and an allocation of the Company's discretionary matching contribution, if any. Allocations are based on participant elective deferrals or compensation, as defined. Participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment Of Benefits

On termination of service, death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in installments. The Plan allows for in-service distributions if a participant reaches age 59-1/2 and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan Administrator will authorize the benefit payment without the participant's consent. Participant account balances of \$5,000 or less will be distributed from the Plan to an individual retirement account if not otherwise directed by the participant.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance in their account during the prior twelve-month period. Only one loan is allowed outstanding to a participant at any one time. Loan terms may range from one to five years or longer if for the purchase of a primary residence. The loans are secured by the balance in the Participant's account and bears interest at a rate determined by the Plan Administrator based on prevailing interest rates. Principal and interest are paid ratably through bi-weekly payroll deductions.

Investments

Participants direct the investment of their own contributions and the Company's contributions into various investment options offered by the Plan through Matrix Trust Company (the Custodian).

Forfeitures

Participants who terminate their employment and are less than 100% vested will forfeit the nonvested portion of their account. Participant forfeitures may be used to pay the Plan's administrative expenses or reduce Company contributions. No forfeitures were used to reduce Company matching contributions for the period beginning January 1, 2024 and ended September 30, 2024. No forfeitures were available for future use at September 30, 2024 and December 31, 2023.

Administrative Expenses

The Company pays significant administrative expenses incurred by the Plan.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation And Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 or December 31, 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value of investments. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There have been no changes in the valuation methodologies used at September 30, 2024 or December 31, 2023.

5. Income Tax Status

The Plan uses a Volume Submitter Profit Sharing Plan. The determination letter, dated June 30, 2020 from the IRS, states the Volume Submitter format was acceptable under the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS.

The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party In Interest Transactions

The Plan pays certain administrative fees to FuturePlan Administrative Services, LLC, the Plan's third party administrator and Matrix Trust Company, the Plan's Custodian. These are party in interest transactions that are allowable under ERISA.

7. Risk And Uncertainties

The Plan invests in various investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
