Notes to the Financial Statements December 31, 2024 and 2023

Note 1 – Plan Description

The following description of the Killam Oil Company Retirement Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Killam Oil Co., Ltd. (“Company” or “Employer”). The Plan commenced effective March 1, 1957, and was amended and restated effective July 31, 2022, to comply with the latest rules and regulations. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodian and Trustee

Charles Schwab Trust Bank (“Trustee” or “Custodian”) is the Plan Trustee and Custodian. Among other duties, the Trustee receives contributions, holds and invests fund assets in accordance with the directions of participants, and makes disbursements to participants. BOK Financial Asset Management, Inc. maintains the Plan’s participant account balances and provides recordkeeping services to the Plan.

Eligibility and Plan Entrance Date

Leased employees, seasonal employees, and interns are not eligible to participate in the Plan. All other employees become eligible to participate in the Plan upon reaching 20 ½ years of age. Eligible employees are permitted to enter the Plan on the first day of each month coincident with or next following the month in which the employee satisfies the eligibility requirements.

Participant Contributions

Participants may elect to contribute, on a pre-tax or Roth basis, from 3% to 75% of eligible compensation as defined by the Plan, subject to the maximum amount permitted annually by the IRC, which was \$23,000 for 2024. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions up to the maximum amount permitted annually by the IRC, which was \$7,500 for 2024. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

Employer Contributions

For the Plan year ended December 31, 2024, the Employer made discretionary matching contributions to the Plan on behalf of participants in an amount equal to 100% of the first 3% of each participant’s contributions. The Company may also make discretionary profit-sharing contributions. No discretionary profit-sharing contributions were made during the year ended December 31, 2024.

Participant Accounts

Each participant account is credited with the participant’s contributions, Employer contributions, allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Note 1 – Plan Description (continued)

Participant-Directed Investments

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, and participants may direct the allocation of their account balances to one or more of these investment options, which vary in types of investments, rates of return, and investment risk.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. Principal and interest are paid ratably through payroll deductions at least quarterly.

Payment of Benefits

Upon separation of service due to death, disability, retirement, or termination of employment, a participant receives a lump sum distribution equal to the value of the vested portion of their account balance. The participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. If the participant makes no election and the vested account balance is at least \$5,000, the distribution will be automatically rolled over to an individual retirement account. If the vested account balance is less than \$5,000, the Plan permits involuntary lump sum cash distributions. All distributions are made as soon as administratively feasible following the participant's termination of service.

A participant may withdraw all or a portion of their account in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age of 59 ½.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Employer contributions and earnings thereon is based on years of continuous service according to the following schedule:

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$120 and \$288, respectively. These accounts will be used to reduce future Employer contributions and pay Plan expenses. During the year ended December 31, 2024, forfeitures of \$409 were used to reduce Employer contributions and \$21,208 were used to pay Plan expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses incurred in maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in the net appreciation in fair value of investments on the statement of changes in net assets available for benefits. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account. Plan expenses could include, but are not limited to, costs to process Plan distributions.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Money Market Fund** – Valued at cost, which approximates fair value and is classified within level 1 of the valuation hierarchy.

The Plan’s independent auditor did not perform auditing procedures with respect to this information except for comparing such information with the related information included in the financial statements and supplemental schedule.

Note 5 – Related Party and Party-in-Interest Transactions

Plan investments are shares of mutual funds managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. All investment fund earnings or losses posted to each Plan participant’s account are net of investment management fees charged by each investment fund under the Plan.

The Plan has notes receivable from participants as of December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 7 – Tax Status

The Plan operates under an adoption agreement in connection with a volume submitter plan and custodial document sponsored by BOKF, NA (“BOKF”). This volume submitter plan document has been filed with the appropriate agency, and BOKF has obtained a determination letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, stating that the volume submitter plan and related trust, as then designed, constituted a qualified plan under Section 401 of the IRC, and therefore were not subject to tax.

Although the Plan has not filed individually with the IRS for a letter regarding the Plan’s qualified tax status, the Plan Administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. As such, no provision for income taxes has been made in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
