Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Platinum Security, Inc. NOTE 1 - THE PLAN AND ITS SIGNIFICANT ACCOUNTING POLICIES

General – The following description of the Platinum Security, Inc. Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The Plan is a single-employer defined contribution Employee Benefit Plan covering eligible employees age 18 or older. There is no minimum service requirement. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code, as amended, and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration - The Company has appointed an Administrative Committee (the Committee) to manage the operation and administration of the Plan. The Company has contracted with Equitable Life Insurance Company to act as the trustee and a third-party administrator to process and maintain the records of participant data. Substantially all expenses incurred for administering the Plan are paid by the Company.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Basis of accounting - The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Administrative Expenses – At the Employers’ option, Plan administrative expenses may be paid by the Employers or charged to the Plan and deducted from participants’ individual accounts. During the year ended December 31, 2024, the Plan paid \$36,992 in administrative expenses.

Income taxes - The Plan has adopted a prototype plan that has received an opinion letter from the Internal Revenue Service. The Company believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Internal Revenue Code and related state statutes, and that the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. No uncertain positions have been identified that would require recognition of a liability (or asset) or disclosure in the financial statements as of December 31, 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits or any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Payment of benefits - Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid at December 31, 2024.

Risks and uncertainties - The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Subsequent events - The Plan has evaluated subsequent events through July 21, 2025 which is the date the financial statements were available to be issued.

NOTE 2 - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board Accounting Standards Codification 820, Fair Value Measurements and Disclosures provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted market prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled separate accounts: Invests in single mutual funds. The fair value of the mutual funds are not publicly traded but are available to current investors via the Employer website or when the plan participants access their account values. Valued at the daily closing price as reported by the account. Investment may be redeemed as of the measurement date, as determined by the Plan's trustee based on the fair value or market value of the underlying investments in its portfolio minus operating expenses.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

ASC 820 allows net asset value (NAV) per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. Insurance contracts held meet those

requirements. The assets can be redeemed at NAV on a daily basis. Unfunded commitments typically are found in private equity funds and therefore are not applicable.

NOTE 3 - RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by Equitable Life Insurance Company, the trustee of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 4 - PARTICIPATION AND BENEFITS

Employer contributions - At the discretion of the employer, contributions will be contributed to the Employee Contribution account under the Plan at such time it deems appropriate. Generally, employer contributions may be contributed during the plan year or after the plan year ends. Any employer contributions made during the year will be made in accordance with the following formulas (to the extent the employee satisfies the eligibility requirements):

Discretionary pro-rata employer contribution formula

The employer will decide each year and how much, if any, it will contribute to the Plan. Since this employer contribution is discretionary, the employer may decide not to make an employer contribution for a given year. If the employer decides to make an employer contribution to the plan, such contribution will be determined as a uniform percentage of compensation for all eligible participants. The employer will inform the employee of the amount of the employer contribution once the employer determines how much it will contribute to the plan.

Prevailing Wage employer contribution formula

The employer will make a contribution to the Plan for eligible participants based on the classification as a Prevailing Wage employee. A Prevailing Wage employee will receive a contribution based on the contribution requirements associated with the type of work the employee is performing. If an employee has any questions regarding the entitlement to or the amount of any Prevailing Wage contributions under the plan, the employee will contact the plan administrator.

Prevailing Wage contributions are subject to special rules that apply without regard to any other provisions under the Plan. Thus, notwithstanding any other provision in the Summary Plan Description, the following rules apply with respect to the Prevailing Wage contributions.

- Prevailing Wage contributions are only available to non-highly compensated employees, as defined in the Plan.
- Prevailing Wage contributions are not subject to any minimum age or service requirements. Thus, regardless of any minimum age or service requirements set forth in article 5 below, the employee does not have to satisfy any such requirements to receive a prevailing wage contribution.
- Prevailing Wage contributions are immediately 100% vested.

- Prevailing Wage contributions are not subject to any allocation conditions. Thus, if the employee performs with Prevailing Wage service, the employee will receive any Prevailing Wage contributions made to the plan without regard to the number of hours worked or whether employment is traded during the year.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Vesting - Participants are immediately vested in their contributions, plus earnings thereon, and rollover contributions into the plan. Participants are also immediately 100% vested in prevailing wage contributions by the employer, and after 6 years of credited service for employer matching contributions.

Participant accounts - Each participant's account is credited with the contributions made to the plan and Plan earnings (losses) thereon and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants - The plan does not permit participant loans.

Payment of benefits - A participant can withdraw from their individual account if they terminate employment before normal retirement age, become disabled, or reaches normal retirement age. Participants or beneficiaries may elect to leave their account balance in the Plan, or receive their total benefits in a partial lump sum. No in-service distributions are permitted. The Plan does not provide for involuntary cash out distributions. A terminated participant must consent to any distribution from the Plan.

NOTE 5 - CERTIFIED INFORMATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under that election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by
